CHIMNEYS LINK PHASE 2, FISHGUARD: HISTORIC ENVIRONMENT APPRAISAL

SUMMARY

A Historic Environment Appraisal of the proposed Chimney's Link, Phase 2 development in Fishguard, Pembrokeshire (centred on SM 95565 37046) was undertaken by DAT Archaeological Services following commission from Atkins on behalf of Pembrokeshire County Council, ahead of a planning application for the proposed new link road.

This document contains a summary of the archaeological resource and an appraisal of the potential impacts upon the resource by the proposed development. It comprises archaeological information from the Dyfed Historic Environment Record and also a search of aerial photographs held by the Royal Commission on the Ancient and Historical Monuments of Wales. This document will be used by planners to make an informed decision on the development proposals with regards to archaeology and the historic environment. The information will be used to supplement the existing Heritage Statement provided by Atkins for the Chimneys Link Phase 2 development proposals.

The potential development site covers an area of around 1.84ha and includes a link road, drainage, landscaping, public spaces and a bat house. Existing buildings and extensions to existing buildings will be demolished during the works, including the complete demolition of the former Fishguard County Primary School and two World War II air raid shelters. The development will provide a link road from High Street to West Street as part of a one-way clockwise gyratory system through the centre of Fishguard. This will improve traffic flows through the town. The scheme also comprises construction of a new underground drainage pipeline along The Slade.

There is one Scheduled Monument within a 1km buffer around the planning application boundary, Castle Point Fort (PE096) which has very limited intervisibility with the planning application area. There is a single registered historic park and garden within 1km of the application boundary, the grade II listed park of Plas Gwyn-y-Mel. There is no intervisibility between the gardens and the application site. The site area does not lie within a registered Historic landscape, nor does one lie within 1km of the site boundary.

There are 107 listed buildings within a 250m buffer of the application boundary, all of which are grade II listed except one grade II chapel. Although visual impacts to the settings of these buildings is likely, such impacts would be considered low to negligible. Improvements to the settings would also be likely from the new one way gyratory system which would reduce traffic flow (and potential collisions) past many of the structures.*

There are three known archaeological sites within the planning application boundary, the Fishguard County Primary School, a former World War II air raid shelter and No 13 West Street (although this structure does not actually lie within the boundary and has been slightly misplaced on the HER). A second air raid shelter formerly projected into the Phase 2 area from the Phase 1 area. These structures (excluding No 13 West Street) are of historical significance. The surviving school structure will need to be subject to building recording prior to demolition. The air raid shelters have been previously demolished

Other sites recorded on the HER indicate that there is the potential for a Bronze Age cremation cemetery to extend into the application area on its western edge. Fishguard may have an underlying Iron Age or Roman settlement as evidenced by finds and a possible cemetery site excavated in the early 19th century and so there is a potential for such remains within the development area. Medieval and

post-medieval remains associated with the development of Fishguard are also likely to be present within the application area, especially on the street frontage areas.

From an archaeological and historic environment perspective there could potentially be impacts on buried, as yet undiscovered archaeology, due to construction activities that have the potential to expose, damage or destroy archaeological remains if present at the site.

It is recommended that the former school is subjected to building record prior to demolition. Trial trench evaluation of the site area is unlikely to be possible, excluding an area to the northwest of the existing cooperative car park (closest to the possible Bronze Age cemetery area). The minimum of a watching brief is likely to be required for the remainder of the proposed development area, concentrating on the High Street and West Street frontages. The exact nature of any archaeological mitigation required at the site will need to be discussed with the archaeological advisors to the planning authority, Development Management - Dyfed Archaeological Trust.

1 INTRODUCTION

1.1 Project Proposals and Commission

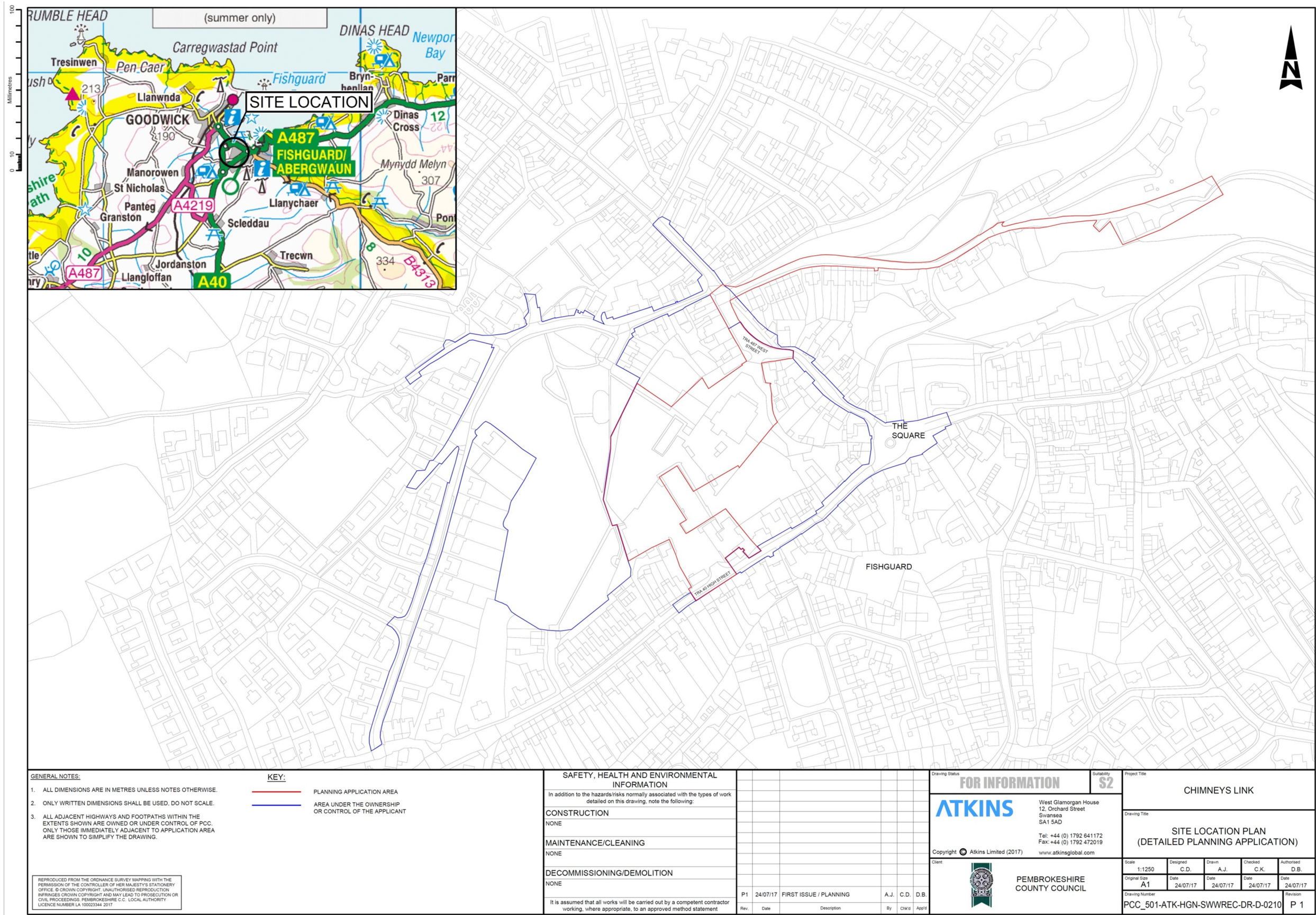


Figure 1: Map showing the location of Chimneys Link Phase 2, Fishguard, Pembrokeshire (supplied by client).

- 1.1.1 DAT Archaeological Services were commissioned by Atkins, on behalf of Pembrokeshire County Council to prepare a Historic Environment Appraisal in advance of the proposed new mixed-use development of the Chimeys Link (Phase 2) development, Fishguard, Pembrokeshire (roughly centred on SM 9569 3704; Figures 1).
- 1.1.2 A Heritage Statement was prepared in advance of Phase 1 of the development (Atkins 2016), which contained an appraisal of the archaeological resource. The report concluded that there was moderate potential for impacts on unknown buried archaeology within the areas of land take and construction associated with the scheme. An archaeological evaluation was undertaken by DAT Archaeological Services (DAT 2017) at the playing field area of the Fishguard Junior School in order to fulfil an archaeological condition placed upon the planning consent for the proposed development (Planning Application No. 16/0857/PA). This small-scale intrusive excavation did not reveal any significant archaeological features. The lack of any finds pre-dating the modern period suggested that the remainder of the area not subject to evaluation had limited archaeological potential.
- 1.1.3 A Heritage Statement was prepared by Atkins (2017) for the proposed Chimneys Link Phase 2 application. A brief summary of the archaeological resource within the report was carried out. This Historic Environment Appraisal has been commissioned to enhance the Heritage Statement with further archaeological and historic environment background information.
- 1.1.4 This Historic Environment Appraisal has collated information on the known and potential archaeology of the site area, and also determined the potential effects of the development proposals on the historic environment. The information contained within this report will enable a decision to be made regarding archaeology and the historic environment during Phase 2 of the development.

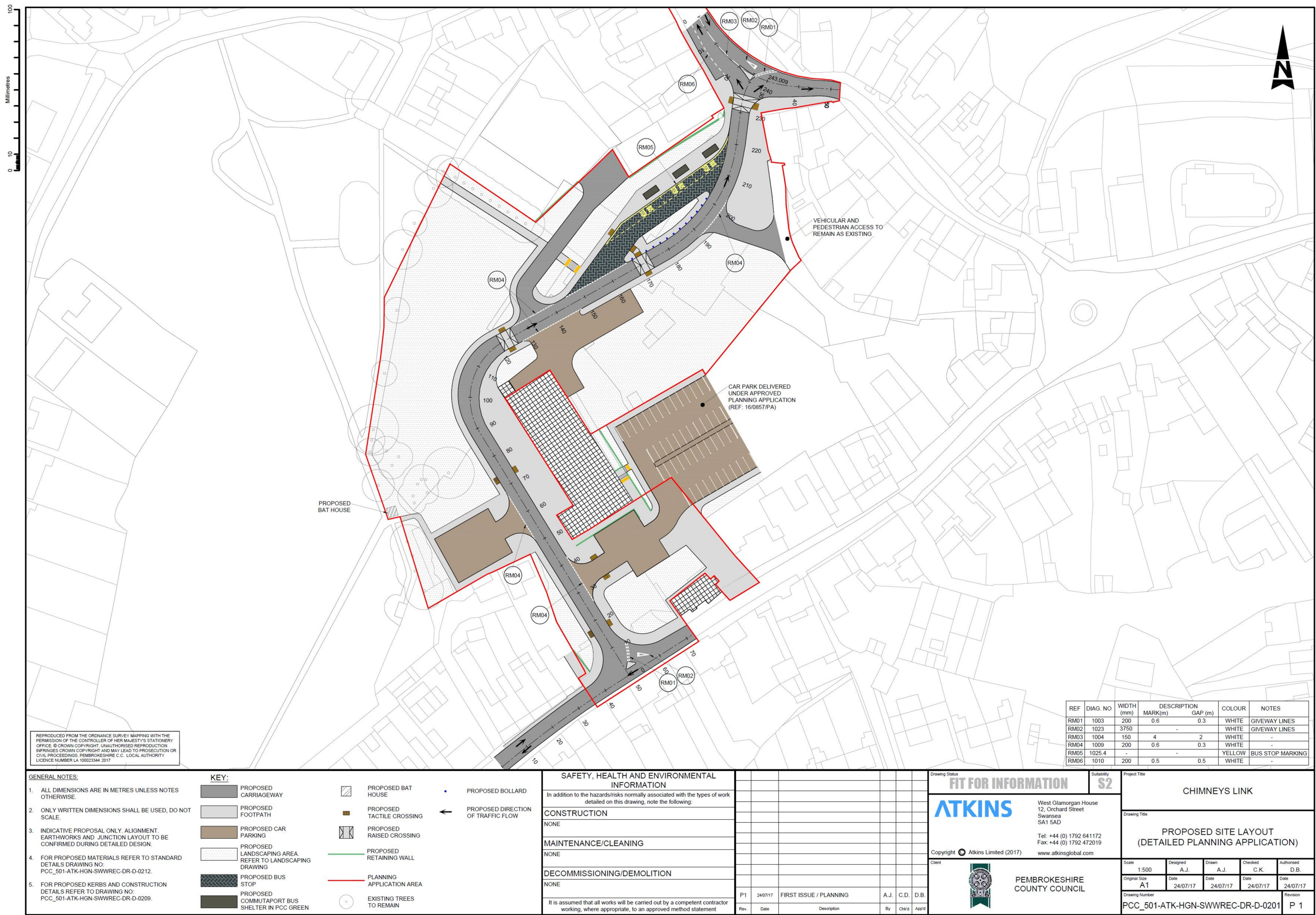


Figure 2: Proposed site layout of western part of Chimneys Link Phase 2, supplied by client

- 1.1.5 The potential development site covers an area of around 1.84ha and would include the following new components: A link road, drainage, landscaping, public spaces, a bat house. The former Fishguard Junior School, its outbuildings, and the pitched roof section of the former library and the Transition Bro Gwaun building would all be demolished. Alterations would be made to the delivery area of the Co-operative supermarket. Figure 2 shows the current development plans in the main area of works at its west end. The scheme also comprises construction of a new underground drainage pipeline along The Slade (the narrow strip at the east end of the development; Figure 1).
- 1.1.6 The Heritage Statement by Atkins (2017) states that 'The proposed link road will connect the A487 Trunk Road at West Street and the A40 Trunk Road at High Street and once constructed will form part of a one-way clockwise gyratory system through the centre of Fishguard'.
- 1.1.7 Little archaeological work has been undertaken in the centre of Fishguard but the Chimneys Link site is considered as having some potential for earlier settlement in the town (medieval or Post-Medieval).

1.2 Scope of the Project

- 1.2.1 The appraisal is written to a generic brief provided by the archaeological advisors to the planning authority (Development Management - Dyfed Archaeological Trust). This appraisal is not a full desk-based assessment of the potential historic environment resource. Rather, it is a more rapid piece of work involving readily available information to assess the historic environment potential.
- 1.2.2 The results are intended to identify the extent and character of the known and potential archaeological resource, to assess the likely and potential impacts of the scheme on that resource and to outline a possible programme of further works to mitigate those impacts. The appraisal should be seen only as the first stage of the archaeological process and does not preclude the possibility that further archaeological input may be required prior to, or during, the proposed development.
- 1.2.3 The proposed development lies within the planning jurisdiction of Pembrokeshire County Council.
- 1.2.4 The archaeological appraisal was limited to the resources held in the regional HER, RCAHMW office in Aberystwyth, a site visit and on-line resources.
- 1.2.5 This report complies with the relevant parts of the Chartered Institute for Archaeologists (CIfA) Standard and Guidance for Historic Environment Desk-Based Assessment (2014). Dyfed Archaeological Trust is a CIfA Registered Organisation and this investigation has been carried out in accordance with the CIfA Code of Conduct (2014).

1.3 Abbreviations

- 1.3.1 All sites recorded on the regional Historic Environment Record (HER) are identified by their Primary Record Number (PRN) and located by their National Grid Reference (NGR). Sites recorded on the National Monument Record (NMR) held by the Royal Commission on the Ancient and Historical Monuments of Wales (RCAHMW) are identified by their National Primary Record Number (NPRN). Scheduled Monument (SM). Altitude is expressed to Ordnance Datum (OD). References to cartographic and documentary evidence and published sources will be given in brackets throughout the text, with full details listed in the sources section at the rear of the report.

1.4 Illustrations

- 1.4.1 Printed map extracts are not necessarily reproduced to their original scale. North is always towards the top of the page unless otherwise indicated.

1.5 Timeline

1.5.1 The following timeline (Table 1) is used within this report to give date ranges for the various archaeological periods that may be mentioned within the text.

2 LOCATION, TOPOGRAPHY AND GEOLOGY

- 2.1 The site is located in the centre of Fishguard, Pembrokeshire (roughly centred on SM 9556 3704; Figures 1 and 2).
- 2.2 The main development area at the west end of the site is currently occupied by a number of buildings, namely the Co-operative store, the Ship and Anchor public house, and a former library building, and Transition Bro Gwaun's building. The entrance to the existing car park for the Co-operative is from the High Street just to the south. The pub, a small parking area and the former library are also located along the High Street. To the northeast of the pub/library lies a grassed area which was previously used as a playing field for the former Fishguard Junior School which lies further to the northeast. The entrance to the school is on West Street
- 2.3 The proposed drainage works will extend from the school, northwards along West Street and then eastwards along the length of The Slade.
- 2.4 The highest point of the site lies towards the southwestern end at around 70m aOD. The land remains relatively level as far as the former Fishguard Junior School, at which point it drops towards West Street (at around 57m aOD and then continues to fall steeply along The Slade to around 6m at its western end adjacent to the sewage works.
- 2.5 The underlying solid geology of the site is mainly mudstone of the Aber Mawr Shale Formation – sedimentary bedrock formed approximately 461 to 478 million years ago in the Ordovician Period. The part of West Street that is within the site boundary and the west end of The Slade sit on different bedrock: Ordovician Igneous Rhyolite of the Porth Maen Melyn Volcanic Formation. There are no overlying superficial geological deposits recorded in this area.

3 METHODOLOGY

- 3.1 This Historic Environment Appraisal is written to a generic brief provided by the archaeological advisors to the planning authority (the Development Management - Dyfed Archaeological Trust) as a fulfilment of a Specification of Archaeological Works.

Desk Top Study

- 3.2 Computer-based and other resources within the Regional Historic Environment Record (HER) were consulted in the preparation of this document. Sufficient information was consulted to inform comment on the goals of the appraisal. GIS layers were used to assess and illustrate what the likely effects of the proposals upon the historic environment might be. Relevant information was obtained from a number of sources, and comprised a number of elements, including:

- Dyfed Archaeological Trust HER data and other relevant information (including a review of online information held on the RCAHMW Coflein site);
- Identification of any Scheduled Monuments, Listed Buildings, Conservation Areas or Historic Landscape Areas within or in the vicinity of the site area from information held by Dyfed Archaeological Trust, Cadw and NRW;
- Readily available bibliographic, cartographic and photographic information held at the Trust;
- Photographic information held at the RCAHMW;
- Map regression exercise;
- Site visit and walkover survey;
- Assessment of the archaeological potential of the area and estimation of depths and significance of the archaeological remains (where possible); and
- Assessment of likely impacts on any identified remains (or potential remains) or setting issues and likely requirements, if any, for further stages of archaeological work.

- 3.3 Scheduled Monuments, Historic Landscape Characterisation Areas and Historic Parks and Gardens were identified within a 1km buffer zone around the planning application boundary for the proposed development. A 250m buffer zone was used for Listed Buildings. The potential visual effect of the proposed development on the settings of the designated sites within this area was then evaluated.

- 3.4 Non-designated archaeological and historic sites were identified within a 250m buffer zone around the planning application site. This area was considered sufficient to enable an assessment of the archaeological potential of the site area to be made.

Site Walkover Survey

- 3.5 A site visit was undertaken on the 18/09/2017. The visit comprised a walkover of the proposed development site and the surrounding area and also incorporated looking at the wider area for views looking back to the proposed development location from designated and other sites. Photographs were taken and field observations recorded in note form.

4 HISTORICAL, LANDSCAPE AND ARCHAEOLOGICAL BACKGROUND

4.1 Archaeological and Historic Background

4.1.1 Palaeolithic archaeology is not found *in situ* in this part of Pembrokeshire because the last ice-sheets eroded away all man-made remains in their path. Mesolithic sites are scattered along the north coast of Pembrokeshire, the nearest to Fishguard being about 5km away on Strumble head. All the Mesolithic sites known in the region are the findspots of flint tools or flint-working sites, as is typical over most of Britain. There is a much higher density of Neolithic sites around Fishguard, mainly in the form of chambered tombs and stone axe findspots, which is the pattern seen throughout Wales and especially in its coastal areas.

4.1.2 Evidence for occupation in the Bronze Age is prolific, in line with the distribution shown in the county as a whole. Sites are mainly funerary mounds and standing stones, but there are no sites within Fishguard itself. Remains of known Iron Age date are fewer, again in line with the rest of Wales, and mainly consist of defended enclosures such as hillforts. Castle Point overlooking Fishguard Harbour is one such potential site.

4.1.3 The early history of the settlement of Fishguard is unclear and has not been extensively researched. The following is an extract from a desk-top assessment carried out in Fishguard by DAT in 1999 (Crane 1999):

Sambrook (1997) has noted the relatively large number of finds of Roman date, in particular coin hoards, from the Fishguard and Goodwick area which he suggests indicates a densely occupied area in the Roman period..... It was considered that a carved stone found in Fishguard was an example of an Early Christian Monument (PRN 5010) and therefore demonstrated pre-Norman ecclesiastical use of the area and possible concomitant settlement. However, recent research has demonstrated that the stone is of probable 13th century date.

The main archaeological and historical interest of Fishguard is therefore the medieval and Post-Medieval town. Soulsby (1983) considers that the town was founded in the late 11th century when Martin of Tours granted 'Abergwaun' to Jordan of Cantington along with other lands in the lordship of Cemais. This foundation of a town at this date is unlikely as the Welsh soon re-conquered South Wales. However, by 1115 Cemais was in the hands of the Anglo-Norman lord Robert Fitzmartin (Murphy 1994). He initially founded his castle at Nevern, and later, in the late 12th century, he transferred it to Newport, where he also founded a town. It is unlikely that Fitzmartin would allow a second town within the lordship of Cemais to compete with his new foundation at Newport, and therefore the existence of a sizeable settlement at Fishguard prior to the 13th century must be questioned.

A church was recorded at Fishguard in 1291 (Ludlow 1998), but this need not imply the presence of an adjoining settlement. It is assumed that the 13th century church was situated on the present site. The extant church dates to 1855-57. Fishguard has no charter, and therefore assumed the status and functions of a town by tradition. It is not known when a settlement developed at Fishguard or when it achieved a size sufficiently large to be considered a town. However, its status was such that by at least 1586 a portreeve was elected, and later documents record burgesses (Jones 1977). The decline of Newport in the 16th century – hastened by plague according to tradition (Soulsby 1993) – probably added to Fishguard's size and status. The better harbour facilities offered by Fishguard over Newport also did not harm the former town's growth over its near neighbour.

- 4.1.4 The town has prospered since medieval times as a sea port, first for the trade of goods and now as a major ferry port, with an economic decline in between. The more detailed history of the town during this period is given in A Character Appraisal and Management Plan for part of Fishguard by Pembrokeshire County Council (2016).

4.2 The Historic Landscape

- 4.2.1 The proposed development site does not lie within any Historic Landscape Character Areas (HLCAs) recorded in the Register of Landscapes of Outstanding Historic Interest in Wales (Cadw 1998). The nearest is 1.3km away to the northwest: Goodwick (No. 354), a small urban historic landscape area and consists of port infrastructure and railway station together with residential development built on a constrained site. Goodwick did not develop until the 19th century, and most of the buildings date to the mid-to-late 19th century and 20th century.
- 4.2.2 The proposed development site lies partially within the Fishguard Conservation Area. A Conservation Area is defined as: *"an area of special architectural and historic interest, the character or appearance of which it is desirable to preserve or enhance"* (Planning (Listed Buildings and Conservation Areas) Act 1990). The Character Appraisal and Management Plan by Pembrokeshire County Council (2016) lists the key characteristics giving special interest to the Conservation area:
- *Long maritime history*
 - *Strategic position in relation to its links to Ireland*
 - *Natural characteristic of the dramatic coastal setting*
 - *The medieval market place centre point and subsequent radial street development*
 - *The sheltered harbour and valley in the lee of the headland setting*
 - *Architecturally distinctive landmark buildings*
 - *Significant views into, out of, and within the Conservation Area*
 - *Mix of building styles with the majority comprising 17th, 18th and 19th century buildings*
 - *Listed Buildings and other buildings which add to the interest and character of the street scene*
 - *Historic shop fronts*
 - *Extreme topography separation the upper town area from the lower town.*
 - *Historic narrow streets in the centre of town with alleyways and footpath links*
 - *Architectural details prevalent within the town*

4.3 Known Archaeological Remains

Scheduled Monuments

- 4.3.1 There is a single Scheduled Monument within 1km of the planning application boundary, that of Castle Point Old Fort (PE096), a post-medieval and modern fort (Figure 3). This lies some 600m north of the western end of the planning application boundary on The Slade. The main development area is not visible from the fort, although the western end of the proposed drainage along The Slade may just be visible. It is considered that overall there will be no negative impact upon the setting of the Scheduled Monument.

Historic Parks and Gardens

- 4.3.2 There is a single registered Historic Park and Garden within 1km of the planning application boundary, that of Plas Gwyn-y-Mel (PGW (Dy) 22(PEM) (Figure 3). It is Grade II registered. The gardens lie on the eastern side of Lower Town at Fishguard and have no intervisibility with the planning application area and thus the proposed development will have no impact upon the registered gardens.

Listed Buildings

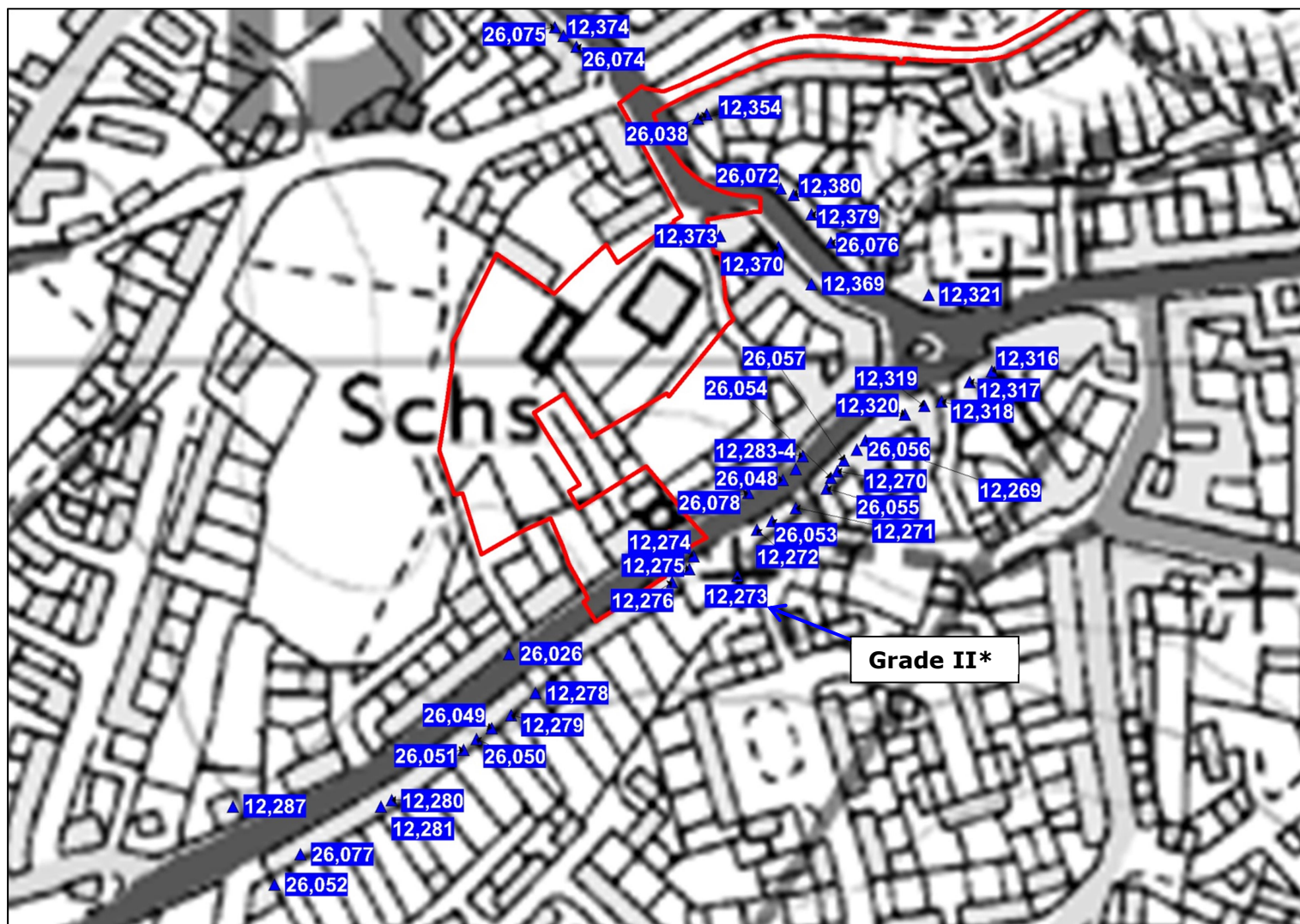


Figure 5: Grade II* and II Listed Buildings (blue) within 250m of the proposed development site (outlined in red), at its west end. The only Grade II* building is annotated.

- 4.3.3 Table 2 and Figures 4 and 5 show the one Grade II* and the one hundred and six Grade II Listed Buildings within 250m of the planning application boundary. There are no Grade I Listed Buildings within 250m. The Grade II* building is the Post-Medieval Hermon Baptist Church including Forecourt Walls and Steps, Baptist Chapel, which lies 20m southeast of the southernmost part of the site, on the opposite side of the High Street. All of the Grade II buildings are also of Post-Medieval date.
- 4.3.4 Although many of these listed buildings will have intervisibility with the proposed development area, the nature and scale of the proposals within the urban landscape of Fishguard will create minimal or negligible negative impact to their settings. This is considered in more detail within the Heritage Statement (Atkins 2017).
- 4.3.5 No Listed Buildings lie within the proposed planning application boundary.

Non-designated sites

- 4.3.6 This section considers historic assets that are recorded on the Regional HER within a 250m buffer zone around the planning application boundary, and that are not the Listed Buildings already presented. The Regional HER records a total of seven sites of medieval or earlier date within the area (Table 3; Figure 4) and thirty nine sites of post-medieval or modern date (Table 4; Figure 5).
- 4.3.7 There are three sites recorded on the Dyfed HER which lie within the planning application boundary: PRN 20116 – Fishguard County Primary School; PRN 20151 – No 13 West Street (incorrectly recorded as a Listed Building); and PRN 28756 – an air raid shelter to the south of West Street.
- 4.3.8 The Heritage Statement (Atkins 2017) provides a description and photographs of the Fishguard County Primary School (PRN 20116) and states that 'The school is an Edwardian building and was approved by the Board on 7th November 1907 with full permission granted on 2nd June 1908, the year in which it was built. The architect and surveyor was D. Edward Thomas of 17 Victoria Place, Haverfordwest. It opened in October 1909.
- 'The Fishguard Conservation Area Character Appraisal and Management Plan describes it as a large site bounded by a solid stone wall. Its front elevations appear largely unaltered since its construction with the boys and girls entrances still apparent. The playing field to the south of the school has remained undeveloped and open.
- 'The school closed in 2011, with pupils moving to the new Ysgol Glannau Gwaun.'
- 4.3.9 The school has been identified as a structure of historical significance representing a good example of an early 20th century educational establishment. Such buildings are falling into disuse with the reorganisation and modernisation of the education system and once redundant, the buildings are often demolished. It has been noted that the building should be subject to a scheme of historic building recording prior to demolition.
- 4.3.10 No 13 West Street (PRN 20151) is a post-medieval dwelling which the HER records as lying just within the development site and also states that is a grade II listed building. It is evident from detailed maps that the PRN grid reference is slightly misplaced, and that the structure lies directly to the south of the planning application boundary (the application boundary covering only the existing road and pavements in this area). As noted above, the HER also records it as a listed building, although this does not appear to be correct based on information held on the CofCymru and HistoricWales websites (which only has nos 9, 11 and 15 as listed).
- 4.3.11 The West Street air raid shelter (PRN 28756) is described on the HER as 'a 1940-45, Civil Defence, Air Raid Shelter, which was previously used as a school store. It is a single storey, brick built structure with a rectangular plan. It has a flat concrete roof, doorway in southern wall, escape panel converted into a window in northern wall, and ventilation bricks in eastern and western walls at roof verge. It has a concrete raft foundation.' It is one of a pair, the other HER entry lies within the Chimney's Link Phase 1 area (PRN 28755), although the structure actually straddled the boundary between the two. These buildings have been previously demolished.
- 4.3.12 There is a single site of Bronze Age date recorded on the HER some 240m west of the planning application boundary around Rope Walk (PRN 2564);

the site of a Bronze Age cremation cemetery. The site was identified by Richard Fenton in the early 19th century, although its exact location is not known. Potentially the cemetery could extend into or have laid within the western side of the planning application boundary. There is thus a low/moderate potential for prehistoric cremation burials to be present within the application site.

- 4.3.12 Fenton also describes finding rock cut graves at Tower Hill, with bent bones, unglazed pottery and painted iron (PRN 2559) found around 200m to the southeast of the eastern side of the planning application boundary. Fenton's original description (1811, 318) states that "*The graves..., when discovered, had a remarkable appearance; they were cut out of the solid rab, mostly of the parallelogram figure, though some of the smallest were very shallow oval excavations; the bones in all were burnt, and in most of the larger ones were small urns of various shapes, though unornamented, and of much better unglazed pottery than any of those found in the tumuli or Carneddau which are invariably coarse, half-baked and always ornamented. These vessels generally lay in one corner of the grave, in which likewise found several pieces of iron of a pointed form, varying in size from that of a common spike nail to one of about three or four inches long... Among the ashes were several small wrought stones of different shapes and sizes, particularly one of a softer texture, circular with a hole in the middle...*" The burials are most likely to be of Iron Age or Roman date, but were later attributed to the early medieval period and possibly associated with Capel Y Drindod (although with no evidence for this assumption). It is most unlikely that this area of burials would have extended into the application boundary.
- 4.3.13 There are two sites of Roman date recorded on the HER in the search area: a findspot recovered in the area of Heol Preseli (PRN 10000), located to the south although the exact location of which is not recorded (and it could potentially be of Iron Age date); and a Roman coin hoard found somewhere within the eastern side of town south of the eastern side of the planning application boundary (PRN 2554). Alongside the possible Roman or Iron Age burials noted above, there is a fair suggestion of either an Iron Age / Romano-British settlement at Fishguard. This would indicate that there is a low/moderate potential for further remains of Iron Age or Roman date to be present within the application boundary associated with activity or settlement from this period.
- 4.3.13 Fishguard Parish Church (PRN 2535) located to the east of the main western part of the planning application boundary in the centre of Fishguard, was originally a medieval church. It was rebuilt in the 1850s. medieval common land is also recorded on Slade Bank on the slopes to the north of The Slade (PRN 13892). The town is known to have medieval origins and the potential for archaeological remains associated with medieval settlement close to the core of the medieval town must be considered moderate.
- 4.3.14 The place name of Castle Hill is also recorded on the HER (PRN 2536) which would suggest the presence of a fortified site. Such a place name would typically indicate the site of an Iron Age fort or a medieval castle, although there is no evidence to further substantiate this. Potentially the place name reference reinforces the Iron Age / Romano-British archaeological potential within the application boundary.
- 4.3.15 The majority of post-medieval sites recorded on the HER refer to buildings constructed during the post-medieval expansion of the town including numerous buildings on Main Street, West Street and High Street. It is

known that expansion of the town occurred during the post medieval times as it had a good harbour (PRN 32154). Its importance as a harbour town grew in the 18th century, and many of the most notable buildings in the town date from this century or into the early 19th century.

- 4.3.16 Other post-medieval structures recorded on the HER include chapels, schools, bridge (presumably with medieval origins), a toll gate and a milestone. Industrial features recorded on earlier maps include a saw mill on the Slade and a number of quarries and limekilns (at the lower eastern end of the Slade).
- 4.3.17 There are also military sites of later post-medieval and modern date within the search area indicating the strategic importance of the harbour town, including the two air raid shelters noted above as well as an early 19th century howitzer gun emplacement on the Slade (PRN 17323) and the location of a First World War Red Cross working party on West Street.
- 4.3.18 The majority of buildings and structures associated with post-medieval development in the town lie outside of the planning application boundary (excluding the air raid shelters and Fishguard County Primary School noted above).

4.4 Other archaeological finds

- 4.4.1 The Portable Antiquities Scheme records two 3rd / 4th century Roman coins found c.80m to the south of the main western area of the planning application boundary. No other PAS finds are recorded within 250m.

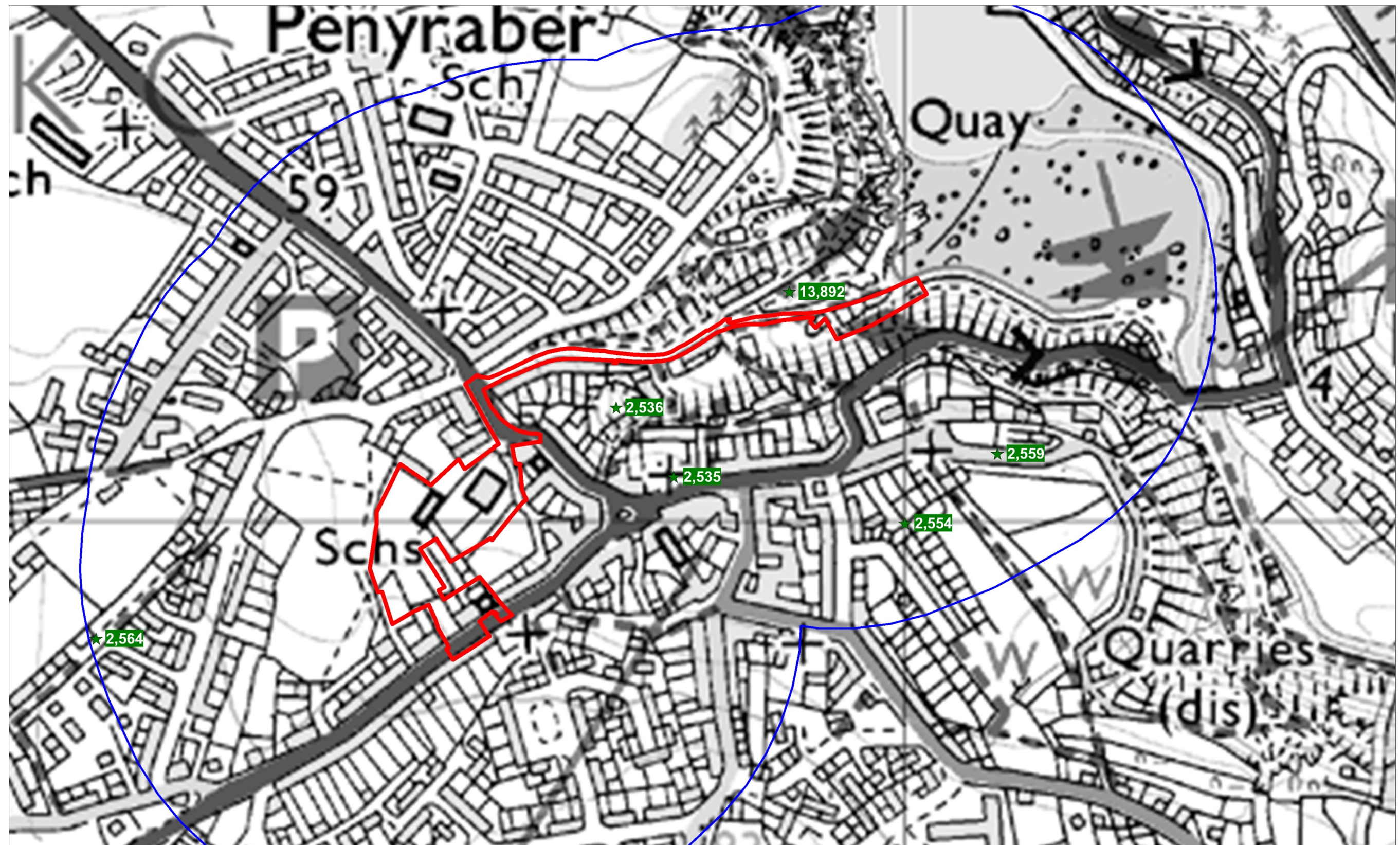


Figure 6: Known heritage assets of medieval and earlier date, recorded on the HER within 250m of the proposed development

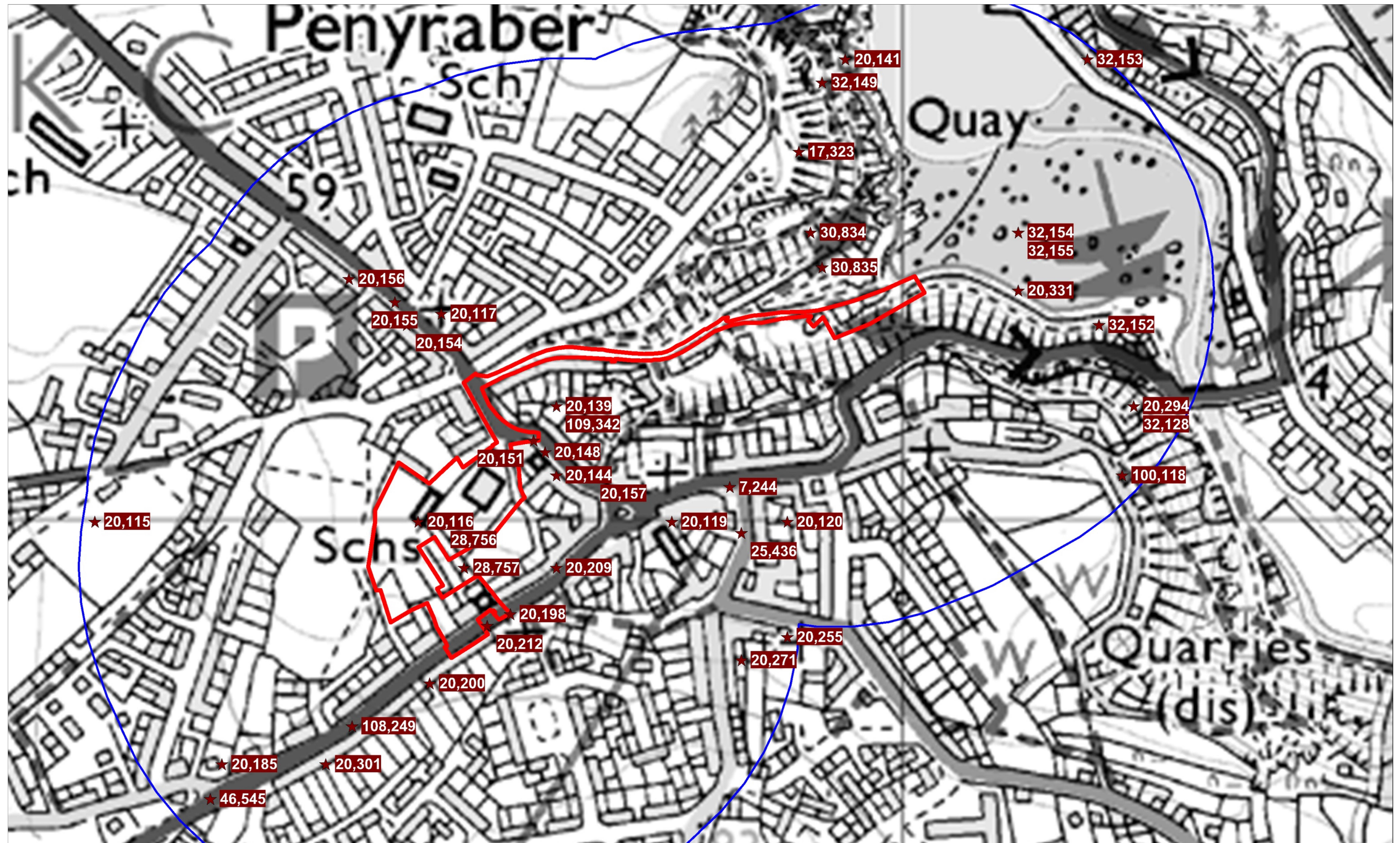


Figure 7: Known heritage assets of post medieval date, excluding Listed Buildings, recorded on the HER within 250m of the proposed development

4.5 Historic Mapping

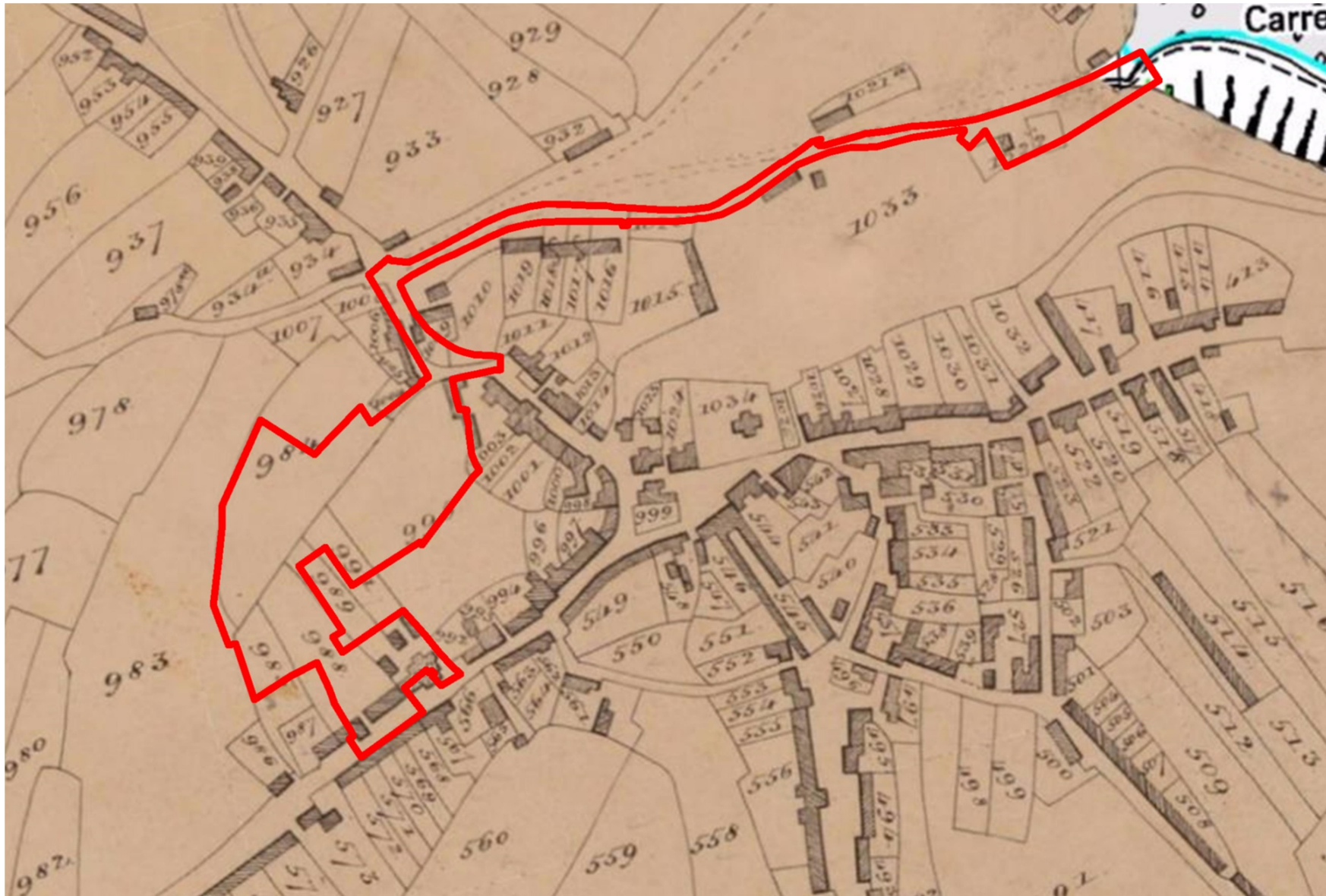


Figure 8: Extract of the Fishguard Parish Tithe Map of 1841, with the approximate outline of the proposed development in red

- 4.5.1 The following description of the 1841 Tithe map is from Crane (1999). The tithe map is shown in Figure 8.

The first large-scale map of Fishguard, the tithe map of 1839, shows a well-developed small town. The market place to the southwest of the church which provides a focus for the town is shown surrounded by almost unbroken building development. Building plots are mostly long narrow strips with the buildings hard against the street frontage. These plots seem to be burgage plots – a type of land allocation common in medieval towns. The arrangement of plots shown on the tithe maps suggests gradual development over several decades if not several centuries, consistent with the known history of the town, rather than a planned and laid-out settlement. To the south of the town there undoubtedly existed a strip- or open-field system. By the tithe survey this had been enclosed, but the pattern of stripd was preserved, as can be seen on the tithe map.

- 4.5.2 On the Tithe map, the planning application boundary can be seen to cover an area of undeveloped fields and gardens on its western side, with buildings only present along the High Street frontage. The eastern side partially follows the road line of West Street, and runs along the entire length of 'The Slade' just beyond the sewage works at the edge of the Aber Gwaun inlet. The area of West Street within the application boundary (north of the school area) can be seen to have originally comprised a smaller road in 1841, with one former building lying within the area which is now a small grassed and seating area on the northeastern side of West Street.

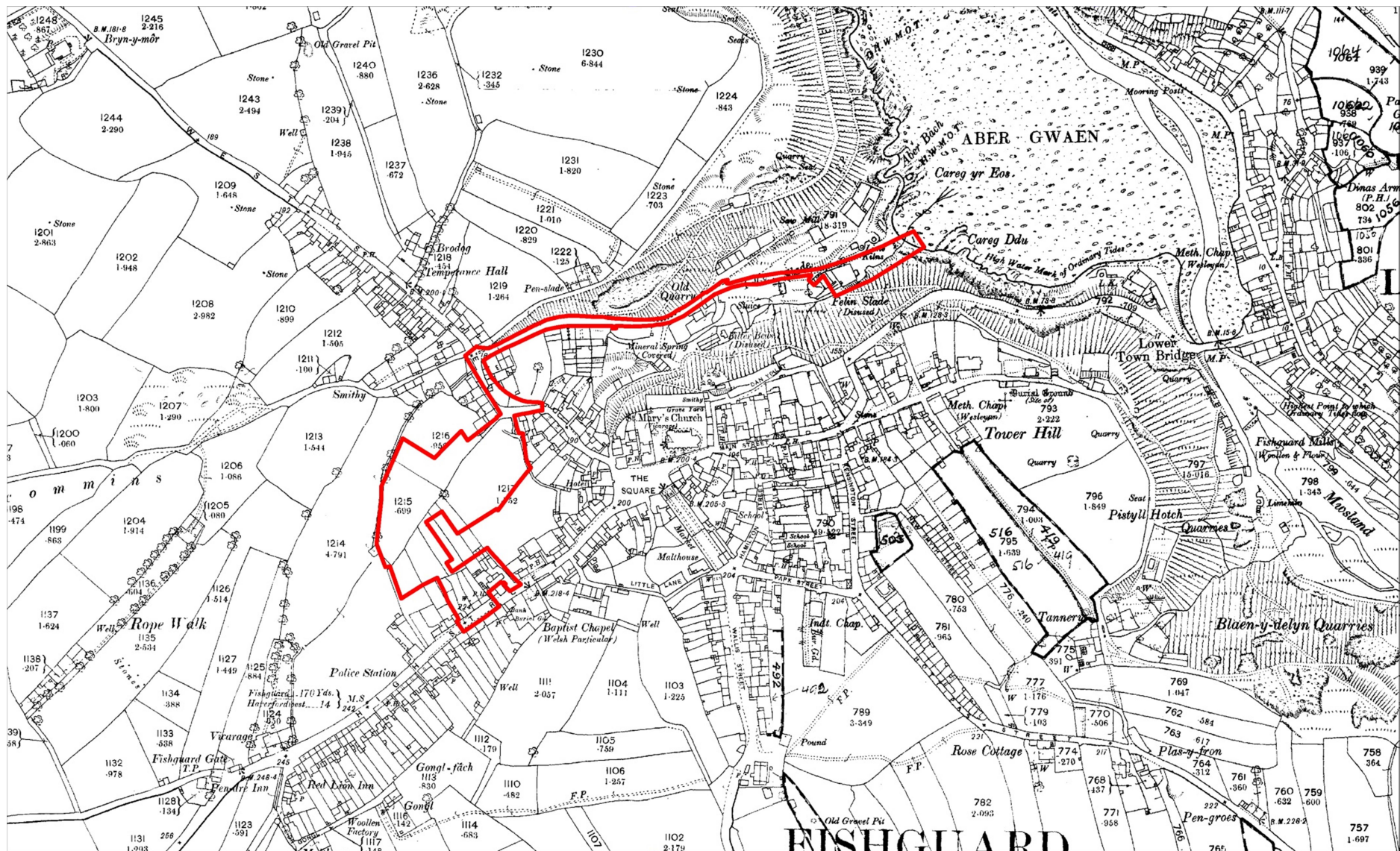


Figure 9: Extract of the first edition Ordnance Survey 1:2500 map, dated 1889, with the planning application boundary in red

- 4.5.3 By the first edition OS map of 1889 (Figure 9) the majority of the area has changed little from the Tithe map, with much of the western area still covering former gardens and fields. Buildings are still present on the small part of the High Street frontage within the application boundary. The area on the northwestern side of West Street can again be seen to contain garden boundaries and at least one structure.
- 4.5.4 The layout of The Slade has changed little since 1841, except at its western end where the former Felin Slade quarry was located and a series of associated buildings were present.

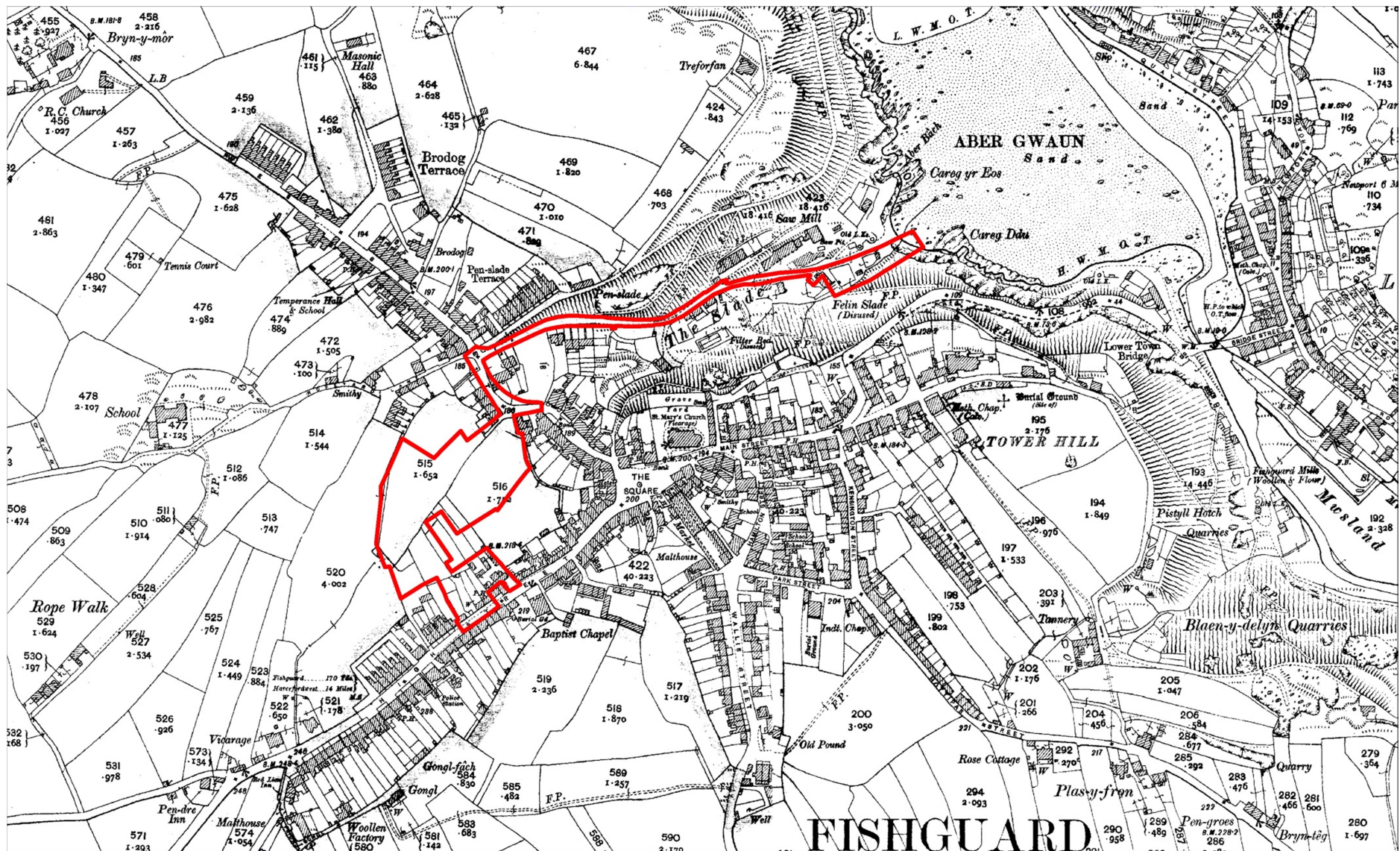


Figure 10: Extract of the second edition Ordnance Survey 1:2500 map, dated 1907, with the planning application boundary in red

- 4.5.5 There is no discernible change between the 1889 and 1907 OS maps of the area except that a few additional buildings are shown on The Slade (Figure 10).
- 4.5.6 The 1937 OS map (not illustrated, but shown as Figure 5.3 in the heritage Statement, Atkins 2017) is the first to show the Fishguard County Primary School, but otherwise little change.

4.6 Previous Archaeological Works

- 4.6.1 There have been few previous archaeological investigations in Fishguard. A number of desk-based assessments have previously been undertaken in and around the town, but little intrusive works have ever been completed.
- 4.6.2 A small archaeological evaluation was undertaken at the site of the proposed 'Fishguard Last Invasion Centre' in 1999 by Cambria Archaeology (now DAT Archaeological Services) (Page 1999). This site was located to the south of the Farmer's Arms on The Square and revealed significant archaeological remains, mostly of medieval or post-medieval date associated with intensive development in the town. It also recorded the concrete raft foundation of a former air raid shelter (presumably similar to those within the Chimneys Link Phase 2 site) which had been demolished in the 1970s.
- 4.6.3 An archaeological watching brief was undertaken at Berry Cottage, Tower Hill close to the main area of the development site, although no significant archaeological remains were identified due to previous terracing (Crane 2008).
- 4.6.4 An archaeological evaluation was carried out within the former playing field for the Fishguard County Primary School earlier in 2017 by DAT Archaeological Services (Enright 2017). The playing field was the only part of the Phase 1 area which was suitable for evaluation, with much of the area previously containing a large extension to the rear of the Ship and Anchor pub on the High Street frontage. Due to the suspected presence of services identified by a Cable Avoidance Tool, three trenches were opened up within the former playing field area (Figure 11). A linear gully was exposed in Trench 1 (103/104), which ran parallel with the school boundary wall (roughly northeast to southwest). At its northeastern end the gully had a rounded profile and 0.05m depth. The feature became shallower to the southwest where it had been virtually truncated away. Modern finds were recovered from the fill of the gully. Evidence for a possible geotechnical test-pit or modern soakaway were found in Trench 3, visible as an area of backfilled, clean fragmented local bedrock (303/304). No archaeological features were visible within Trench 2.
- 4.6.5 The archaeological evaluation within the Phase 1 area did not reveal any significant archaeological features. The lack of any finds pre-dating the modern period suggests that the remainder of the area not subject to evaluation has very limited archaeological potential. It is possible that the area was formerly levelled prior to it being used as a playing field. This is indicated by the gully recorded in Trench 1 which became shallower to the south, perhaps indicating that the ground level was previously higher and had thus been subject to deeper levelling. The area may also have been significantly disturbed through the installation of services across the site area, which was indicated by the Cable Avoidance Tool.

4.7 Site Walkover Survey

- 4.7.1 The site walkover survey was undertaken on the 18th September 2017. The Transition Bro Gwaun building on the High Street frontage will be demolished (Photo 1) to make way for the link road connection to the High Street. The building is a later 20th century building and of negligible historical significance. The 20th century pitched roof section of the former library on the southern side of the Ship and Anchor pub will also be demolished, although this is not considered to be of any historical significance.

- 4.7.2 The existing car park of the Cooperative supermarket (Photo 2) will be removed for the new link road, and replaced by the Chimneys Link Phase 1 car park that is already under construction. The former school land to the northwest of the existing car park will be improved and made accessible (Photo 3). It is presently fenced and being used for spoil tips for the Phase 1 works.
- 4.7.3 The former Fishguard County Primary School building (Photos 4, 5 and 6) is presently unoccupied and starting to deteriorate. The building will be demolished to make way for the new link road and a bus stop area. The building retains almost all of its original structure and façade with some additional extensions and outbuildings to the rear. The sites of the air raid shelters were not accessible during the site visit, but it is understood that both of these have been previously demolished.

- 4.7.4 The Chimneys Link road will connect with West Street in the area to the northeast of the former school buildings (Photos 7 and 8). The proposed development will include significant alteration of the road in this area, to extend to the northeast over the presently grassed area (Photo 7 and 8).
- 4.7.5 The junction between West Street and The Slade is unlikely to be altered to any great extent (Photo 9), but drainage runs are proposed that will run eastwards down the Slade to the sewage works area and the Aber Gwaun inlet. The Slade itself is a small road with a number of properties along the western part of its length (Photos 10 and 11). The eastern end of The Slade has less residential buildings and contains the sewage works (Photo 12) and lime kilns (Photo 13).

- 4.7.6 The eastern end of The Slade leads to the Aber Gwaun harbour from which there are extensive views north. The promontory on which Castle Point Fort (Scheduled Monument) lies can be seen from this point (Photo 14). The proposed drainage works on The Slade are most unlikely to be visible from the fort (Photo 15). There is also unlikely to be any alteration to the skyline of Fishguard from the proposed Chimney's Link Phase 2 works which would impact the setting of Castle Point Fort (Photo 15).

5 IMPACT OF PROPOSALS ON THE HISTORIC ENVIRONMENT

5.1 Physical Impacts of the Development Proposals

- 5.1.1 The proposed Chimneys Link Phase 2 development will include the demolition of the Fishguard County Primary School. The two former air raid shelters have been previously demolished.
- 5.1.2 The Chimneys Link works will include the construction of a link road between High Street and West Street, running through the existing Cooperative supermarket car park, through the former school grounds and the former school building itself. The link road would require groundworks on the northeastern side of West Street in an area which is presently partially laid to grass and footpaths. A bus stop area is also proposed for the area of the former school. A bat house will be erected as a habitat for any bats displaced by the works. Ancillary works including drainage will also be required. The main drains from the area will be installed running from the main area of the link road, along The Slade down to the sewage works and Aber Gwaun harbor.
- 5.1.3 The following construction activities are all likely to be undertaken to some extent at the development site, all of which have the potential to expose, damage or destroy archaeological remains if present at the site:
- Enabling works, such as installation of contractor's compound, construction of access roads, parking areas, storage areas and borrow pits;
 - topsoil stripping;
 - landscaping and terracing works;
 - foundation excavation;
 - construction of roads and infrastructure; and
 - drainage and other service installation.

5.2 Buried Archaeological Potential

- 5.2.1 The school discussed above is of archaeological and historical significance. There are no other known archaeological remains within the planning application boundary. The archaeological potential for hitherto unknown archaeological sites to be present within the proposed development area is considered to be low/moderate.
- 5.2.2 Information held on the HER indicates that a Bronze Age cremation cemetery was uncovered by Fenton in the early 19th century to the west of the application area. The exact location is not known and so there is some potential that the cemetery could be located within or extend into the site boundary. Remains of this date would be of regional archaeological importance.
- 5.2.3 There have been a number of finds of Romano British or Iron Age date within the town of Fishguard which may indicate a pre-cursor to the medieval settlement was present during these periods. The potential for further remains of this date to be present cannot be discounted. Remains of this date would be of at least regional archaeological importance.
- 5.2.4 The highest archaeological potential would be for medieval and post-medieval remains associated with the development of Fishguard. Although earlier cartographic sources indicate that most of the western part of the application area was located within agricultural land (which is likely to

have been so in the medieval period as well) the boundary does include part of the street frontage on High Street, West Street and The Chimneys. The grassed and pathed area on the northwestern side of West Street opposite the former school is known to have had at least one former building on it. Remains of medieval or post-medieval date would be considered to be of local archaeological importance.

- 5.2.5 Modern sites include the school and former air raid shelters, but it is unlikely that any other significant remains of modern date survive. The remains of this period are of local / regional importance.
- 5.2.6 The archaeological potential of the site will have been compromised to some extent from previous development. The school and air raid shelters will have disturbed earlier archaeological remains. Drainage and services associated with these and the more recent supermarket will have caused disturbance of below ground deposits, as would the processes of constructing the car parks and road ways that presently exist.

5.3 Palaeo-environmental Potential

It is unlikely that deposits suitable for the survival of palaeo-environmental evidence on the site would be present, due to the probable nature of the soil and sub-strata and the dryness of the site.

5.4 Visual Impacts

- 5.4.1 It is considered that the development proposals will have very minor or negligible negative impacts upon the current setting listed buildings within the vicinity of the site. The majority will not be affected. The creation of a link road creating a one-way clockwise gyratory system through the centre of Fishguard would be seen as a positive impact upon the setting of listed buildings adjacent to the roads, reducing traffic flow past many of the buildings. The narrow roads that presently exist for two way traffic do have the threat of accidental impacts with buildings by traffic, which could be vastly reduced by the new road system.
- 5.4.2 The one scheduled monument of Castle Point Fort has minimal views of the development site and it is considered that distance, tree cover and the existing urban townscape will make any setting impacts negligible. The registered historic park and garden on the eastern side of Fishguard is not intervisible with the site and will thus there will be no setting impacts.

5.5 Recommendations for Further Archaeological Works

- 5.6.1 As noted above the former Fishguard County Primary School is of historical significance. It should be subject to a programme of building recording prior to its demolition.
- 5.6.2 The proposed development area is identified as having a low/moderate archaeological potential for buried remains of significance. It is thus possible that further archaeological mitigation will need to be implemented during groundworks for the development.
- 5.6.3 Due to the nature of the site it is unlikely that any preliminary evaluation works could be carried out, other than in the area of the former school grounds to the west of the school buildings. This area has low archaeological potential as it does not lie on the street frontages but in an area indicated as agricultural land on earlier cartographic sources.

- 5.6.4 The street frontage areas on High Street and West Street have the highest archaeological potential for remains associated with the medieval and post-medieval development of the town. As was seen during the evaluation of the Fishguard last Invasion Centre in 1999, Fishguard has the potential to contain complex and significant archaeological remains. As the areas have been subject to significant disturbance in the past from former buildings and modern redevelopment, it is possible that such remains have already been compromised. It is suggested that as a minimum a watching brief is maintained during groundworks within these areas. A less intensive watching brief would be suitable for the remainder of the site area and during any drainage works along The Slade.
- 5.6.5 The decision for the scope of any further programme of archaeological works lies with the archaeological advisor to the local planning authority (Development Management - Dyfed Archaeological Trust).

Further survey as part of the harbour is recommended. 
