TIR GOFAL FARM VISIT REPORT

This report is intended to provide a statement on the condition and recommended management of all known archaeological and historical sites and features on this farm at the time it was visited by Cambria Archaeology. This information will be used to inform the Tir Gofal Management Agreement for the farm.

Description of Felindre Farm, Maesycrugiau, PRN 40652

Maesycrugiau is a small farm of 18.87ha (46.64 acres) on the banks of the Afon Teifi in north Carmarthenshire. The farm occupies gently sloping land that falls from a high point of c.90m above Ordnance Datum (OD) in the southeast corner to its lowest point, 85m OD along the northeast edge of the farm, on the banks of the Afon Teifi. The northeastern boundary is also the south boundary of St. Llonio's Church and the adjacent medieval motte. The farm is called Felindre on the tithe map of 1839 and Felindre-isaf on the 2nd edition Ordnance Survey map (1906) suggesting that there may have been a mill on the site at some time. A pond is shown just to the southwest of the yard on the 2nd edition OS map, although there is nothing to suggest that the pond was ever a mill pond, or that there was ever a mill on the site. It is not clear when the farm took the name Maesycrugiau which was formerly applied to a mansion house and estate a short distance to the south. The farm was originally part of the Maesycrugiau estate which has its origins in the later medieval period. When the tithe map was published (1839) the farmyard area consisted of two ranges of buildings, the house and cartshed on the northeast side of the yard and a cowshed and barn along the southeast, forming an L-shaped arrangement along two sides of the yard. This arrangement survives today, although the cartshed and house have been extensively altered. The layout of fields and tracks was well established by the mid 19th century and probably dates from the 18th century, although the boundaries around the church are probably medieval or earlier. A cist cemetery discovered when the graveyard was extended in 1877 and a possible Celtic dedication suggest a pre-Norman foundation for the church. The boundaries across the farm are typically earth banks with pitched stone facing and topped by a mature hedge. There is great variety in the stones used for the facing suggesting that they were picked up locally, possibly from the bed of the Teifi.

Management Recommendations

The farm is not farmed or managed intensively with low stocking levels and some hay cutting taking place. There are no plans to remove any existing boundaries or to reroute or to modify the tracks and footpaths, and they should where possible be retained. However, the farm buildings themselves have undergone, or are earmarked for, extensive renovation and rebuilding. The northeast range, which included the house and cartshed, was almost totally demolished and rebuilt. The current owners are considering plans to renovate the cowshed and barn, which again will require extensive rebuilding because it is presently in fairly unstable condition. So far the rebuilding and modernisation of the buildings has been sympathetic to the style of the buildings and this approach should be maintained for any future rebuilding. There are plans to create a pond and waterside habitats from an area of boggy ground to the south of the house, but this is not considered to have significant archaeological implications.

Description

Section of the former Manchester and Milford Railway which opened during the mid 19th century. The line runs through a deep cutting, c.70m long x 10m deep x 10m wide, where it enters Maesycrugiau land in the southwest corner of the farm. From the point the line leaves the cutting it runs on a terrace, c.6-7m wide x 1-2m high, made up from imported material, including bottles and other refuse. Modern houses have been built over the line to the northeast of the farm. The line is very overgrown with trees and it now forms a narrow band of woodland.

Recommendations

Maintain the cutting and terrace in their present condition. Stock should be excluded to prevent erosion of the terrace sides and to stop cattle poaching of the wet areas of the track bed.
