INTRODUCTION

This report is intended to provide a statement on the condition and recommended management of all known archaeological and historical sites and features on this farm at the time it was visited by Cambria Archaeology. This information will be used to inform the Tir Gofal Management Agreement for the farm.

Method Statement

The farm visit consisted of two phases:

Phase 1 was a rapid search of all readily available documentary, cartographic and published sources to try to understand the historical development of the farm and the wider landscape and to identify new sites of archaeological interest. The searches undertaken include information held in the regional Sites and Monuments Record, the relevant County Records Office and the National Library of Wales. New sites, or areas of interest were plotted onto a Geographical Information System based map for use during the field survey and for the final report.

Phase 2 was a farm visit to assess the extent, character and current condition of the archaeological and historical sites identified during the research phase. Due to time constraints recording is rapid and consists of photographs and sites notes. Some of the sites may not have been visited. The information gained during the visit has been used to determine their management recommendations.

GENERAL DESCRIPTION OF FARM

Summary description

Carters Green is a large holding of approximately 520 hectares which incorporates much of the Angle peninsular. The farm is owned by the Mirehouse-Allen family whose ancestors acquired the estate in the early 19th century. The farm has a rich history spanning several thousand years and includes a wide diversity of archaeological remains.

The holding exists within a landscape composed of distinct character areas which have been identified and described as part of the Historic Landscape Characterisation of Registered Landscapes of Historic Interest in Wales, these include the Historic Landscape Character Areas of Rhos Crowther (341), Angle (342), and Angle Airfield (343).

Prehistory

The earliest prehistoric remains which have been recorded, broadly date from the Neolithic and Mesolithic periods which range from 10,000 to 2,000 years BC. The evidence for human activity consists of stone objects, usually found on the ground surface, which indicate that stone has been worked for the manufacture of tools, weapons or other stone objects.

A possible barrow (Prn 13058) has also been located in a field at West Pickard, identified from an aerial photograph as a cropmark (differential growth in crops/vegetation or soil marks). This probably dates from the Bronze Age (2000 to 600BC) and would contain either an inhumation or a cremation.

Other prehistoric evidence includes the far more visible remains of the West Pickard Hillfort (PRN 3099) and a further hillfort at West Angle Bay (PRN 35019). These probably date from the Iron Age period (600BC to 43AD) although they may be earlier in date. Originally these would form defensive enclosures, built to secure and defend property, although they may have had various uses over a long period of time.

Early Medieval

There is documentary evidence to suggest that two early chapel sites fall within the Carters Green holding, St. Anthony's (PRN 3092) at West Angle Bay and St. Mary's (PRN 3093). Although there are no upstanding remains of these structures, various features associated with these early medieval sites survive including burials.

Medieval

The area which surrounds the village of Angle exhibits a highly characteristic field system (Prn 5701), in which the medieval field layout is preserved within the current boundaries. Analysis of the form of the field layout suggests that the fields to the north of the village were laid out at around the time that the village itself was established as a planned element around 1100. The fields to the south may have been laid out over open-fields (An area of arable land which had common rights after harvest or while fallow. Usually without internal divisions such as hedges, walls or fences).

Post Medieval

The estate came to lie within the extensive Cawdor Estate in the 18th century where it remained until John Mirehouse of Brownslade bought it in 1805 and whose descendants are still the major landowners of the parish.

Much of the character of the current landscape is derived from this period and many archaeological features survive. Amongst these are the farmsteads including Carters Green itself and the Home Farm of Angle Hall. Other notable features within the holding which date from this period is the windmill (PRN 4386), the garden features associated with Bangeston mansion (PRNs 15914) and brick works (PRN 15878).

Military

In the last century Angle developed a pivotal role in the defence of the Milford Haven and consequently all modern sites are military in nature. These are numerous, and range in scale from isolated observation posts to the major military complex of Chapel Bay Fort. The dates of the military sites also span from the late 19th century across the first half of the 20th century.

Due to the extensive nature of the military sites those listed in the gazetteer represent those sites which have been visited for which a current condition appraisal can be included. The other sites which have been identified in Roger Thomas's survey of Military Buildings of Pembrokeshire have been included in the appendices with a map indicating the location of each site.

MAIN MANAGEMENT RECOMMENDATIONS

Due to the extensive nature of the archaeological sites on this holding the following general recommendations have been included for broad classes of sites; for specific site recommendations please refer to the gazetteer.

Buried archaeological sites

Where sites have been identified as buried archaeology with no visible, above-ground remains, all efforts should be made to preserve these sensitive archaeological deposits. In those areas where levels of preservation are likely to be high no ground disturbing activities should take place and the ground should be retained intact.

Where identified sites (such as flintworking floors and cropmarks) have been under cultivation for many years, it is possible that there may still be archaeological deposits surviving below the ploughing level or in field margins. For this reason it is recommended that although agricultural practices could continue in these areas the depth and extent of ploughing should be restricted to a minimum and certainly not exceed current levels.

Built structures (e.g. walls and buildings)

The main threat to these structures is the intrusive vegetation. It would be a significant loss if these buildings were left to decay. Within the holding of Carters Green there are many structures which are deserving of restoration. These include some of the buildings associated with the Home Farm of Angle Hall and the garden structures relating to the lost mansion of Bangeston.

If works to any of these buildings or structures are being considered then an archaeological record should be undertaken which should include the internal contents. Please consult with Cambria Archaeology prior to works being carried out.

Military sites

The Angle peninsular is covered with military remains and those that survive are just a fraction of what was once constructed to defend the mouth of Milford Haven in the past century. Many military sites have been identified by Roger Thomas's invaluable survey of Military Buildings in Pembrokeshire (1994). Many of the sites which survive are generally either incorporated into field boundaries or are currently in use (eg the hard standing of a dispersal pen is currently being used as a silage clamp). These sites should therefore be under no further threat if they are maintained in their current use.

(All recorded military sites, including those not visited, are included in the appendix.)

The main management concerns regarding the military structures is the threat posed by water ingress and intrusive vegetation, in particular those sites to the east of Chapel bay fort (See Map 2). If these sites are to be retained for future generations some kind of management regime should be maintained which will prevent the intrusive vegetation becoming established within the structures.

Public access/interpretation

This farm presents an excellent opportunity for interpretation and presentation to the public, due to the range of archaeological sites and also the extensive military structures which are present within a small geographical area, where public access is already established to large extent. Many sites are already accessible due to their proximity to the coastal path and could be brought to people's attention with very little effort, with either interpretation boards or information leaflets. Indeed Roger Thomas's report highlights Angle as being an area which is particularly suited to public interpretation, (1994, p74-78).

Description

There is now no visible trace of the medieval chapel of St. Anthony which was one of three former chapels in the parish of Angle. It was reputedly washed into the sea before 1500. A small circular enclosure has been recorded which was thought to be the burial ground associated with it (PRN 7595). Two cist graves (PRN 35095), presumably part of the burial ground, have also been identified in the cliff edge. The former existence of the chapel is acknowledged in Tithe survey of 1842 which records this area as "Old Church", this element is retained in its current name of "church field" (Mr. David Thomas, farm manager, pers. com.).

Recommendations

Since documentary sources claim that the chapel has been washed into the sea, there are no specific management recommendations for this structure. Nevertheless, undoubtedly there are sensitive archaeological remains surviving in this area and no ground disturbing activities should occur in this region.

Description

There is now no visible trace of St. Mary's Chapel which was apparently destroyed during the construction of the Chapel Bay Fort (PRN 7655) (Ordnance Survey record card). The chapel stood within a small circular enclosure (PRN 7596) which survived to a height of approximately 2 feet high at the beginning of the 20th century.

Recommendations

Although there is no visible trace of the chapel there may still be archaeological remains surviving in this area. It is therefore recommended that no further ground intrusive activities are carried out in this area without prior consultation with Cambria Archaeology. The proposed management scheme of using the fields to the south as hay meadows, taking this area out of cultivation, would be an ideal landuse for this site.

Description

The following is taken from the Cadw scheduling description;

"Fine promontory fort with rounded interior which slopes gently downward towards the sea, surrounded on the landward side by a curving bank and ditch. The bank is c. 3m high externally and 1.3m high internally. There is a little erosion at the ends of the bank where the footpath cuts it, and the sea is gradually eroding the sides of the headland. Four depressions in the bank — weapons pits apparently."

The hillfort survives as described, the eastern bank is rock cut with a simple causeway entrance. The depressions mentioned in the eastern bank are approximately 2m in diameter and 0.5m deep. A circular gun emplacement (PRN 32765) in the interior is approximately 8m in diameter with a square cement hard standing in the centre.

The hillfort is currently in a reasonably stable condition although some erosion is occurring where the coastal path passes over the earthworks to the east.

Recommendations

The situation regarding the erosion along the coastal path should be carefully monitored, and may require the temporary diversion of the path to allow areas to re-establish grass cover. Cadw should be consulted regarding any works.

Description

The following description is taken from 'The Windmill, Angle: A Historical Summary and Structural Description' by Neil Ludlow in 1997 (2, 9);

The windmill was a former corn-mill which in its present form possibly dates to the 16th century and succeeded a timber mill that had been established before 1278. It belonged to the medieval Manor of Angle. The present structure represents a 'cap-mill', in which a former timber superstructure, housing the sail-mountings, turned upon the masonry tower to face the wind. The mill was disused by the 1780's, but during World War II it was converted into a defence post, involving internal alterations and the provision of four machine-gun loops.

The windmill is a cylindrical, two-storied structure constructed from roughly coursed, mediumsized Carboniferous Limestone rubble from a local source.

The adaptation of the windmill to a defence post during World War II was in conjunction with the establishment of Battle Headquarters 40 metres to the east (PRN 44599).

The following description is taken from Roger Thomas's survey, 1994. Site no. 122/002 "Truncated, 2 storeys, circular plan, coursed rubble, windmill. Adapted as a defence post, inserted concrete floor, and 5 wide splayed concrete embrasures fitted with Turnbull mountings at 1st floor level. Steel rungs set in wall allow access to hatch in floor."

Currently the windmill is good condition and appears to have been recently restored, (Plate 1)

Recommendations

The windmill should continue to be maintained in its current good condition.

Description

Traces of the medieval system of strip fields have survived fossilized within the current field boundaries to the north and south of the village of Angle. The distinctive character of long narrow fields emanating from the back plots of the buildings lining the main street of Angle can be seen very clearly to the north of the village. To the south these early field systems can also be traced although they are not quite so complete.

Recommendations

The field boundaries to the north and south of the village of Angle are wonderfully well preserved and the field boundaries in this area should be retained intact.

Description

A small circular enclosure has been recorded within this field which was thought to be the burial ground associated with St. Anthony's Chapel (PRN 3092). An oval shaped enclosure is also marked on the 1st and 2nd edition Ordnance Survey maps (1869 & 1908), and apparently an earthwork could be made out on aerial photographs. This field has been under regular cultivation until recently and no visible trace of this earthwork could be identified during the farm visit. That there are buried archaeological remains surviving here is demonstrated by the existence of at least two cist graves which are eroding out of the cliff top (PRN 35095).

Recommendations

The exact extent of the cemetery enclosure is unknown, and there is no trace of the enclosure on the ground surface. However, that there are potentially highly sensitive archaeological deposits in this area is indicated by the cist graves which are visible in the cliff top.

In order to protect any buried archaeological remains at this site the area indicated on the attached map should not be subject to any intrusive activities. Any other sites or finds identified in this area should be notified to Cambria Archaeology.

Description

A small circular enclosure in which the chapel of St. Mary stood was defined by a bank allegedly standing to 2 feet high at the beginning of the 20th century. When recorded by the Royal Commission on the Ancient and Historical Monuments of Wales (RCAHMW) in 1922 the enclosure was barely indistinguishable, and there was no sign of any burials. Today the fields to the south of the site are used for cultivation and there is no visible trace of the enclosure.

Recommendations

The exact extent of the enclosure is unknown, and there is no trace of the enclosure on the ground surface. Although the adjoining fields have been under cultivation there may be archaeological deposits surviving either at lower levels or in isolated pockets; for example under boundaries. Ground intrusive activities should be avoided in this area or else undertaken with archaeological consultation and supervision.

The following description is taken from a site visit undertaken by Cambria Archaeology in 1997. A spring used as the water supply for Chapel Bay Fort is probably the site of this well. No structural evidence. Area disturbed by military works.

Recommendations

Although this area has been disturbed by the military construction, there may still be some archaeological deposits relating to this structure. Should any further works be undertaken archaeological advice should be sought first.

Description

The following description is taken from listed building description, Cadw:

"Chapel Bay Fort: Three gun emplacements facing N towards the Haven date from 1903, and were for 6" BL guns. A single emplacement facing W is the only survivor from the original battery of c.1890, for 10" RML guns. [One of the guns survives and is now displayed at West Angle Bay.] Concrete parapets with forward sloping aprons merging with the ground. Detonator stores beneath guns, doors missing. Shell hoist mechanisms survive. Access to N emplacements is by concrete stairs from a sunken communicating passage at rear. At rear of communicating passage is a sunken barracks unit, consisting of eight segmentally brick-vaulted rooms each approx. 5 m by 6 m, with connecting doors in line. In seven of the barracks there are hammock hooks along two sides at approx. 40 cm apart. No hooks in the last one to the E, which was evidently intended for officers. All barracks were heated by fireplaces (now blocked up) back-to-back in alternate cross walls with short brick chimneys. Door and window units were framed up to the soffit of the vaults, but all are missing. On roof of this unit are the battery commander's station and a range-finding post. One cross passage within this unit communicates front to rear. Another cross passage dips steeply down for access to lower levels. Behind the unit is another sunken passage with two ramps up to ground level at rear. At ground level at rear are single-storey buildings: a workshop with generator and a smithy (skilling shed); a telephone room, master gunner's office and oil and paint store, RA workshop, ablution room and cookhouse. The latter building is an example of early construction in unreinforced concrete, protected by cement render, now damaged [Plate 2]. The other buildings are in brickwork. Flat concrete roofs on rolled iron joists. At E of row: master gunners' quarters with porch. Latrines at rear. Nearer to bridge: latrines, machine gun shed, artillery store, lamp room, and coal store. The fort is surrounded on three sides by a deep defensive ditch between concrete retaining walls, with two caponiers reached by tunnels from the interior of the fort. Ancillary structures: In connection with Chapel Bay Fort are a number of structures essential to its understanding, on the land to the E of the fort as far as the next headland. At SM 8596 0363: a 12 pdr quick-firing battery of c.1880 and a minewatcher's post. At SM 8610 0355: well and pumphouse. At SM 8617 0351: a submarine mining establishment, consisting of engine room, generator room, store and test room, built in mass concrete. Also Maxim gun emplacements, light emplacements and a slipway."

A two storey building is currently under construction at the west side of the fort. The other buildings along the south side are in a poor condition. To the far east is a single storey building of brick construction with deteriorating cement render finish which has largely fallen off the south face. The above mentioned ablutions block, constructed in unreinforced concrete is also suffering from the loss of its weatherproof cement render skin.

Beside the entrance gate the ditch which surrounds the fort has been used for dumping waste and

fly tipping.

Recommendations

The derelict buildings which line the south side of the fort urgently require some remedial works to prevent their further deterioration. This should focus on making the buildings weatherproof. Since these buildings lie within the scheduled area, all works must be carried out with full consultation with CADW and will require scheduled monument consent.

In addition the accumulated rubbish and waste which has been dumped in the external ditch should be removed with care not to cause damage to the structure and the external ditch kept clear.

Description

This is apparently the site of seamen's graves, marked as graves on both the 1st and 2nd edition Ordnance Survey maps (1869 and 1908). Identified at the beginning of the 20th century as modern longitudinal mounds, one of which had recently been opened. The site of these inhumations could not be identified during this farm visit.

Recommendations

This area is subject to coastal erosion and consequently these graves may begin to erode out of the cliff although no indication of this could be seen at the time of the farm visit. Cambria Archaeology should be notified if any finds are identified.

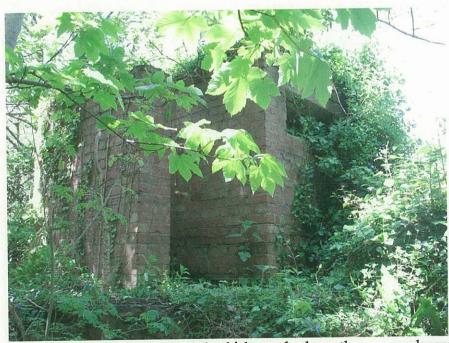


Plate 5 – Minewatchers post (PRN 35022) which stands above the gun emplacement (PRN 35023)

This complex of rooms is located within the hillside with a main open access route cut into the hillside (Plate 6). The structure is constructed out of mass concrete, with a cement finish inscribed with an ashlar pattern and a cement moulded string course. The rooms were lit with sash windows of which only the remnants of the boxes survive, with iron grills set over the exterior.

The cement skin of the concrete structure has been lost in some places and the concrete is now beginning to erode. The structure is also overgrown with vegetation which may be causing structural problems.

This site is of great interest and importance.

Recommendations

This complex should be maintained in a stable condition. Urgent action is required to prevent the eroding of the concrete structure by water ingress, this will require specialist conservation advice. The vegetation also needs to be kept under control to prevent any structural damage.

This site, along with the Chapel Bay Fort, presents a wonderful opportunity for public access and interpretation.

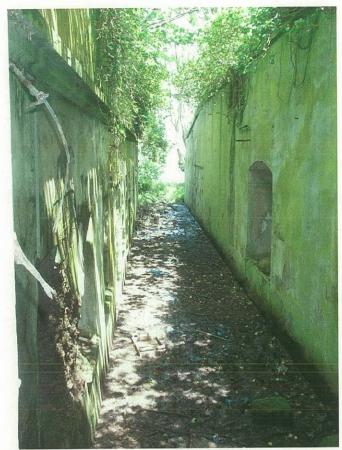


Plate 6 - Submarine mining establishment (PRN 35026)

A cist grave was discovered by Mr Bushnell's eight year old daughter Samantha (family on holiday), in the cliff face above West Angle Beach on 24th July 1997. Up to four graves were subsequently identified within the eroding cliff face (Plate 7)

Two definite stone lined graves could be seen from the cliff top, with stone side slabs and cap stones projecting from the cliff face, a possible third was also seen. A wide shallow V-shaped grave cut could be seen extending from the topsoil to the top of the graves.

The graves are gradually eroding out of the cliff, and a fragment of bone could be seen lying on the rocks below.

Recommendations

These graves are a valuable and important addition to the corpus of cist cemetery sites. Ideally an excavation should take place to record these graves and the inhumations they contain before they are lost. However, in the meantime the graves should be monitored to record further archaeological information as it comes to light.

To the east of the submarine mining establishment (PRN 35026) are a series of latrines. Set within the coastal slope and to the north of a linear earthwork which runs along the contour.

The western most structure is the officer's latrine identified by Roger Thomas Site no. 371/011; "Semi-sunken, small, single storey, square plan, mass concrete, flat earth covered concrete roofed chamber containing a single water closet."

This building appears as described by Roger Thomas however the water closet no longer survives but the scars of the fittings are visible.

To the east is a second structure described by Roger Thomas as the Men's Latrine 371/012; "Semi-sunken, small, single storey, rectangular plan, mass concrete, flat earth covered concrete roofed chamber containing a pair of water closets divided by a slate cubical partition."

This building appears as described by Roger Thomas, with two iron pots in situ. A further structure adjoins this to the west.

These structures survive reasonably intact. However, the men's latrine does have a large tree growing out of the wall beside the entrance, which inevitably will cause damage to the structure.

Recommendations

The main threat to the survival of these structures is the intrusive vegetation. The vegetation should be cut back and the roots treated to prevent regrowth, these should then be left to die in place.

Description

The following description is taken from Roger Thomas's survey, 1994. Site no. 371/013 "Hut. Single storey,3 bay rectangular plan, timber framed, painted galvanized steel sheeting clad, mono-pitch roof. Doorway set centrally in north wall flanked by windows. East, west, and south walls are blind."

The hut is as described by Roger Thomas in all except that the roof is pitched. The east window is smashed in the north wall and the whole building is very overgrown with ivy.

Recommendations

This hut is of unknown function but would appear to be associated with the other late 19th / early 20th century military structures found in this area. The building should be retained if possible, and the vegetation cut back before it causes serious structural damage.

Description

Within the field margin are the masonry remains of a building. The remains are L-shaped, 11.5 metres long in an east west direction, and 1.6 metres to the north (Plate 12). The wall stands to a height of 1.7 metres, and is constructed out of stone, uncoursed rubble, with no visible dressings. In the long section are 4 splayed slit openings evenly spaced. The openings are splayed out to the north side corresponding to the interior of the building. A rectangular structure is recorded on the 1st and 2nd edition Ordnance Survey maps (1869 &1908), shown in outline only - suggesting that it was derelict at this stage.

Although apparently fairly stable the remains of this structure has nettles and ivy growing from the wall top.

Recommendations

This structure of unknown origin should be retained, and kept clear of intrusive vegetation. The proposed management regime of grazing; taking the adjoining field out of cultivation, should preserve any surviving archaeological remains which may relate to this structure.

Description

To the north of the old house of Bangeston is the remains of a walled garden. The garden is sub-rectangular in shape, 120 metres by 60 metres. It is bounded by brick walls to the north and east and to the south by stone, the west wall appears to have largely collapsed (Plate 13).

Along the north wall are three glasshouses, constructed on dwarf stone walls with timber structures above. The eastern glasshouse is constructed as a lean-to. The other two to the west are situated perpendicular to the garden wall with chimneys in the gable.

In the north west corner of the garden is a further stone built lean-to of uncoursed rubble construction. Two windows are situated in the south wall.

The garden is currently used for cultivation although it is becoming very overgrown around the periphery and the boundary wall is extensively covered in ivy. The glass houses are derelict; much of the glazing has been lost and the timber structures are collapsing. The stone building in the north west corner of the garden is in ruins also; the roof has completely collapsed and the walls are covered with vegetation.

Recommendations

This is a very interesting area forming part of the historic landscape associated with the mansions of Bangeston, and latterly with Angle Hall, and would be deserving of further investigation.

This area presents great opportunities for the restoration of the walled garden and the associated garden structures. However, in the absence of such a project, these structures should be maintained to prevent their further deterioration. The vegetation should be cut back and allowed to die before being removed. The garden wall, which currently appears to stand to full height is particularly susceptible to damage from intrusive ivy growth and should be consolidated using appropriate materials.

Cambria Archaeology should be consulted prior to any works that are undertaken on these garden structures/features.

A building is situated against the exterior side south wall of the garden (PRN 44959). This building is very overgrown and is therefore very difficult to assess its form or function.

The building is two storeys in height, constructed in uncoursed stone rubble and the roof appears to have collapsed. The north wall, which forms the southern boundary of the walled garden, has been raised in height to accommodate the second storey and has various openings. The southern elevation has an arched doorway, and beside it a 6 pane sash window. To the east of this building is a doorway through the garden wall into a small square lean-to building (privy?) the roof of which has collapsed.

Recommendations

This building is extremely overgrown. In order to prevent the further rapid deterioration of this building the vegetation should be cut back and allowed to die before being removed. This was not identified during the farm visit as this area was substantially overgrown.

A variety of garden buildings are situated along the southern wall of the garden. These buildings are low lean-tos, constructed out of uncoursed rubble stone. The single pitched roof has been raised with brickwork to make the pitch shallower. A lean-to glass house is situated against the north east wall.

A typical 'Nissen hut' is located to the west of the farmstead at Angle Hall. The roof is of semicircular corrugated asbestos set on dwarf brick walls. At the west end are double doors and a large metal window located at the east end. A series of skylights are set into the roof on each side.

Orientated on a north west – south east axis to the south of the farmyard is a brick built two storey range. It is constructed in a brickwork style known as English garden wall bond. The four first floor windows are arranged in the same spacing as those on the ground floor. Above the doorways are circular iron framed windows. The doorways have flat brick arches with rounded arrises and stone springers to either side. The windows have low brick arches. Internally the ground floor has cast iron pillars supporting the first floor. There are no traces of the original stalls or fittings except a couple of harness hooks which survive. The building is currently in fair condition although apparently out of use. The stone steps to the 1st floor are becoming overgrown and the pointing is deteriorating.

Recommendations

This building has great possibilities for reuse and the potential restoration of this building is to be welcomed. However, prior to any works being carried out an archaeological record should be undertaken. The restoration should endeavor to retain the character of the building and should keep the historic fabric intact as far as possible.

Description

Adjoining and perpendicular to the south of the stable (PRN 44968) is a brick built machine shop. Also constructed out of English garden wall bond brickwork, it has a very low pitched roof of corrugated asbestos. Along the west elevation are three large arched windows and to the east are two windows with a central doorway.

Internally this building is of great interest, containing as it does the machinery for woodworking (plate 14). Driven by an external engine (now removed), a drive shaft runs the length of the building along the west wall from which drive belts issued to power various lathes, saws and drills. Much of the machinery and associated paraphernalia still lie about as they were left. At the southern end is a small open fire grate. In addition, to the east of this building is a small corrugated iron and timber framed workshop. Internally this contains a large cement mounting and a possible boiler.

The farm manager, Mr David Thomas, remembers the workshop in use until the 1960's with an engine positioned to the north of the building. Here the estates joinery was carried out; coffins, gates, windows etc were manufactured. Indeed some of these items are still lying about in the extension to the west of the stable block (PRN 44968).

At the southern end, and continuous with the workshop is a smithy, also with one large brick arched window to the west and a large doorway and window to the east. Internally the smithy also retains its fittings including the hearth and two sets of bellows.

This range of workshops and smithy are in a deteriorating condition, the glazing for the windows has largely been lost, and the ivy growth is now extensive over the roof and southern end. The corrugated iron roofing to the workshop to the east has largely corroded and water is penetrating the structure.

Recommendations

The potential restoration and reuse of these buildings is to be welcomed. However, prior to any works being carried out an archaeological record should be undertaken of the buildings which should include the internal contents. Of great interest are the woodworking tools and smithing implements which survive *in situ*. The restoration should endeavor to retain the character of the building and should keep the historic fabric intact as far as possible.

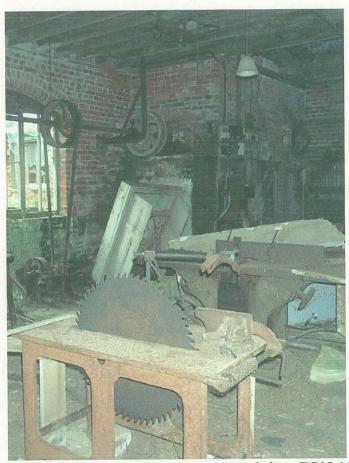


Plate 14 – the interior of the Home Farm workshop (PRN 44969)
