

#### INTRODUCTION

This report is intended to provide a statement on the condition and recommended management of all known archaeological and historical sites and features on this farm at the time it was visited by Cambria Archaeology. This information will be used to inform the Tir Gofal Management Agreement for the farm.

#### **Method Statement**

The farm visit consisted of two phases:

Phase 1 was a rapid search of all readily available documentary, cartographic and published sources to try to understand the historical development of the farm and the wider landscape and to identify new sites of archaeological interest. The searches undertaken include information held in the regional Sites and Monuments Record, the relevant County Records Office and the National Library of Wales. New sites, or areas of interest were plotted onto a Geographical Information System based map for use during the field survey and for the final report.

Phase 2 was a farm visit to assess the extent, character and current condition of the archaeological and historical sites identified during the research phase. Due to time constraints recording is rapid and consists of photographs and sites notes. Some of the sites may not have been visited. The information gained during the visit has been used to determine their management recommendations.

# GENERAL DESCRIPTION OF FARM

Pantglas farm lies around 12km to the north-east of Carmarthen and was built in the mid 19<sup>th</sup> century as the Home Farm for Pantglas house. Only fragments of the house and some of the other estate buildings remain, but much of the Victorian gardens and parkland that were created to compliment the Italianate mansion of Pantglas still survive. The gardens are included in the Cadw/CCW Register of landscapes, parks and gardens of special historic interest in Wales: Part 1 parks and gardens PGW (Dy)11(CAM) while part of the parkland is included as essential setting. The remains of the house, other estate buildings and the lake and gardens which lie at the head of a shallow valley do not form part of the holding of Pantglas farm.

Much of the holding of Pantglas comprises the informal Victorian parkland of Pantglas house (PRN 47611), there are further areas to the south-east and west but the core is very much a landscape of discrete and polite parkland. Although the original planting scheme has not survived completely, many of the small copses and horizon lines of trees have been lost, enough of the landscape still retains key parkland elements. The long drive (PRN 47175) that follows the valley side from the south west to the house at the top of the valley survives and is bordered on its western side by an almost complete run of iron railings with well built stone gate posts and gateways (PRNs 47177, 47178 and 47605).

Two farmsteads are shown on the 1839 Tithe map for Llanfynydd parish, Castle coch (PRN 47612) and Ffynnon goll (PRN 47613), however no evidence of theses sites was seen during the site visit and both were presumably cleared for the creation of the parkland. This is evidence of the dramatic effect that the creation of the Pantglas parkland must have had.

# MAIN MANAGEMENT RECOMMENDATIONS PRN 47175 – Drive

This is an important part of the parkland landscape of Pantglas. It is clearly still in use as an access track within the farm holding, and ideally it should continue to be used as such without causing excessive levels of erosion or damage. Also the iron railings are clearly beginning to suffer from deterioration and in some instances are no longer fully stockproof, these should be maintained and where necessary repaired using good quality matching material.

#### PRNs 47177, 47178 and 47605 – Gateways

Ideally these gateways should be maintained inline with the rest of the parkland railings as essential elements of the historic landscape of Pantglas. The iron work of the gates and the stonework of the gateposts are beginning to suffer from deterioration and where necessary they should be repaired using good quality matching material.

# PRNs 47606, 47607 and 47609- Kennel, Quarry and Ha ha

Maintain as existing. In order to protect any buried archaeological remains no ground breaking works should be undertaken within 15 metres of these sites.

#### PRN 47611 - Parkland

It is important for the historic environment of Pantglas that the integrity of the parkland is respected and preserved, any ground breaking activities should be restricted and as far as possible any new tree planting should follow the historic pattern as depicted on the second edition Ordnance Survey plan of 1907.

#### Description

This is the original main, grand entrance drive to Pantglas house only part of which survives within the holding of Pantglas home farm. It would have originated at the Lodge at SN53632446 and then wound its way up the valley through a section of woodland and then into the parkland to the south of the house and eventually approaching the house from the south east.

The section of drive within the parkland (and farm holding) survives as a well preserved trackway with iron railings and gateways (PRNs 47177, 47178 and 47605) along its western side.

#### Recommendations

This is an important part of the parkland landscape of Pantglas. It is clearly still in use as an access track within the farm holding, and ideally it should continue to be used as such without causing excessive levels of erosion or damage. Also the iron railings are clearly beginning to suffer from deterioration and in some instances are no longer fully stockproof, these should be maintained and where necessary repaired using good quality matching material.

#### Description

Gateway in the iron railings bordering the Pantglas house drive (PRN 47175) and near to barn PRN 47176. It consists of two large stone gateposts around 0.35m square and 1.6m high and an iron gate opening onto the field to the west.

#### Recommendations

Ideally this gateway should be maintained inline with the rest of the parkland railings as essential elements of the historic landscape of Pantglas. The iron work of the gate and the stonework of the gateposts are beginning to suffer from deterioration and where necessary they should be repaired using good quality matching material.

#### Description

A gateway across the width of the main drive (PRN 47175) (see plate 1 above). Only one of the gateposts survive, it is stone with carved rustification. The gate survives in a poor condition nearby, it has a timber frame with timber posts and iron rails and hinge work.

# Recommendations

Ideally this gateway should be maintained inline with the rest of the parkland railings as essential elements of the historic landscape of Pantglas. The iron work of the gate and the stonework of the gateposts are beginning to suffer from deterioration and where necessary they should be repaired using good quality matching material.

#### Description

A trackway diverting south east of the main house drive (PRN 47175) at the point of gateway PRN 47178, and leading towards a lodge to the south east. This trackway is not shown on the 1839 Tithe Map and must be part of the 1853 parkland landscape.

Maintain as existing.

#### Description

Gateway in the iron railings bordering the Pantglas house drive (PRN 47175). It consists of two large stone gateposts around 0.35m square and an iron gate opening onto the field to the north.

Ideally this gateway should be maintained inline with the rest of the parkland railings as essential elements of the historic landscape of Pantglas. The iron work of the gate and the stonework of the gateposts are beginning to suffer from deterioration and where necessary they should be repaired using good quality matching material.

#### Description

Kennels are shown on the 1891 first edition Ordnance Survey map. The site of these kennels is now marked by low banks forming a rectangular enclosure, measuring (4m by 8m?) north south, and located behind a modern fenceline and within an area of woodland.

#### Recommendations

Maintain as existing. In order to protect any buried archaeological remains no ground breaking works should be undertaken within 15 metres of this site.

#### Description

A quarry is shown on the 1891 first edition Ordnance Survey map. The site of this quarry is now marked by 20 metre long cut into the hillside within an area of woodland. The line of a trackway linking the quarry with the nearby kennels (PRN 47606) and shown on the first edition Ordnance Survey map is still partially visible.

#### Recommendations

Maintain as existing. In order to protect any buried archaeological remains no ground breaking works should be undertaken within 15 metres of this site.

# Description

A low bridge (or culvert) over the water course bisecting the Pantglas parkland. It, and the streamside corridor to either side of it, are very overgrown although it may possibly be part of the 1853 landscaping works.

Maintain as existing. In order to protect this as a historic landscape feature no ground breaking works should be undertaken within 15 metres of this site.

#### Description

Parkland created in 1853 to compliment the Italianate mansion of Pantglas. The parkland includes an area of essential setting of the registered garden of Pantglas PGW (Dy)11 (CAM).

#### Recommendations

It is important for the historic environment of Pantglas that the integrity of the parkland is respected and preserved, any ground breaking activities should be restricted and as far as possible any new tree planting should follow the historic pattern as depicted on the second edition Ordnance Survey plan of 1907. Continuous fencing of stream courses will have a detrimental impact on the open nature of the parkland and should as far as possible be restricted to areas previously wooded.
