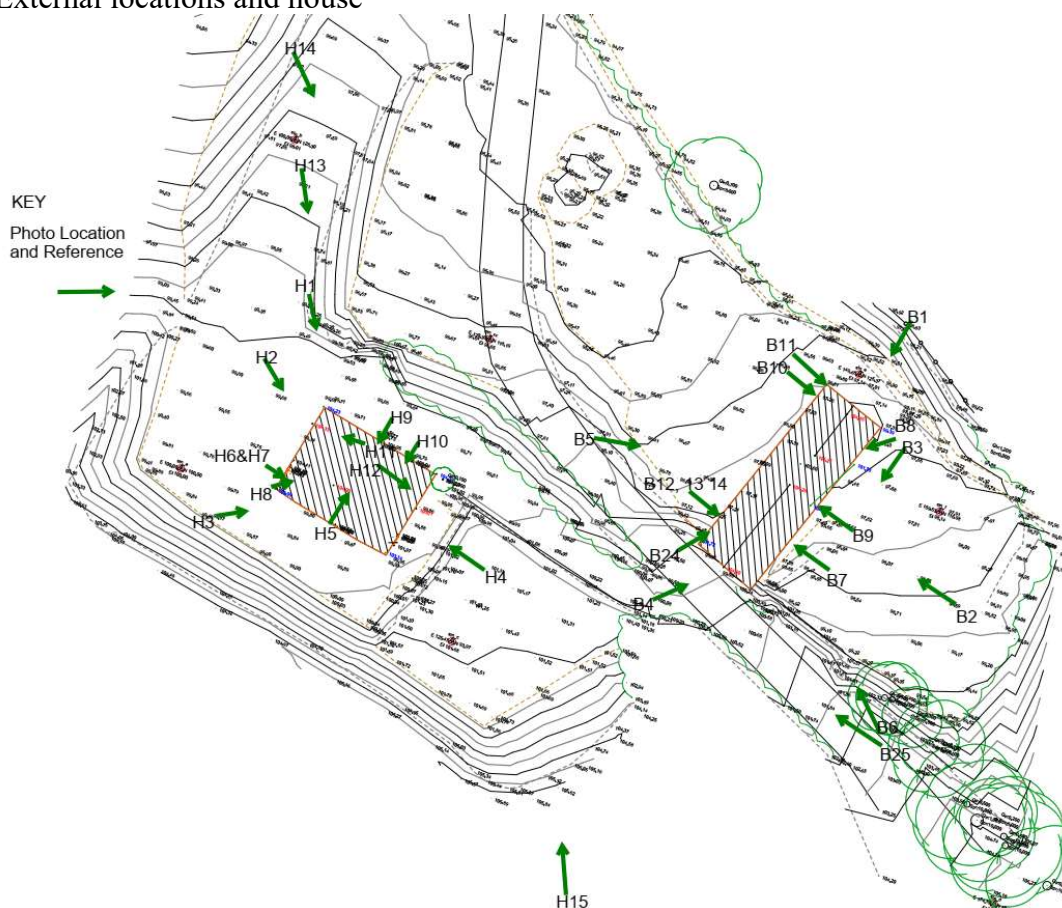

1 General Details

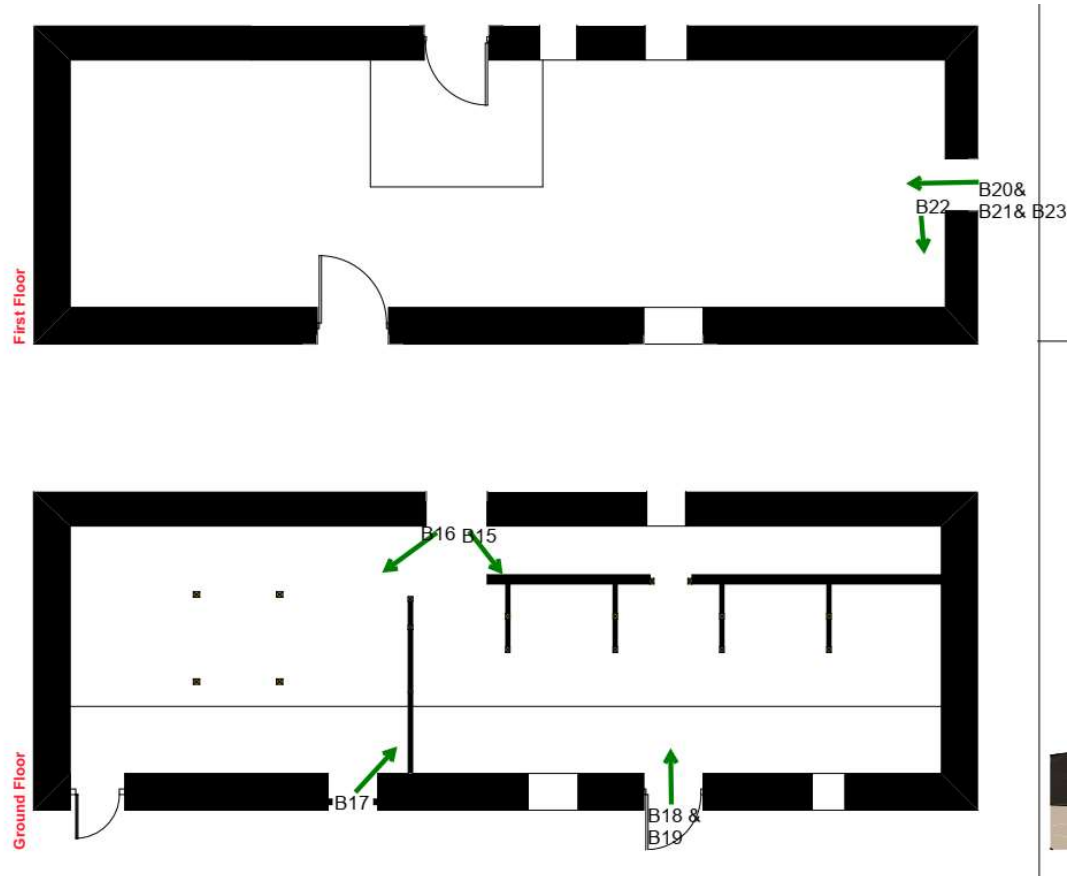
- 1.1 The accompanying photographs and plans are submitted pursuant to condition no.6 of planning permission 20/0403/PA.
- 1.2 The photographs were taken on 17/3/2021 using a Samsung S10 12Mega Pixel Camera. Integrated flash was used in all internal spaces. A 2m measuring pole was placed in the shot where possible.
- 1.3 Location of the photographs is shown on the plans below via a green arrow and Reference Letter and Number. Unfortunately structural condition of the structures prevented extensive internal photos and topography prevented some head-on photos of the buildings.
- 1.4 This information is submitted for preliminary comments before the photographs are physically deposited with Dyfed Archaeological Trust.

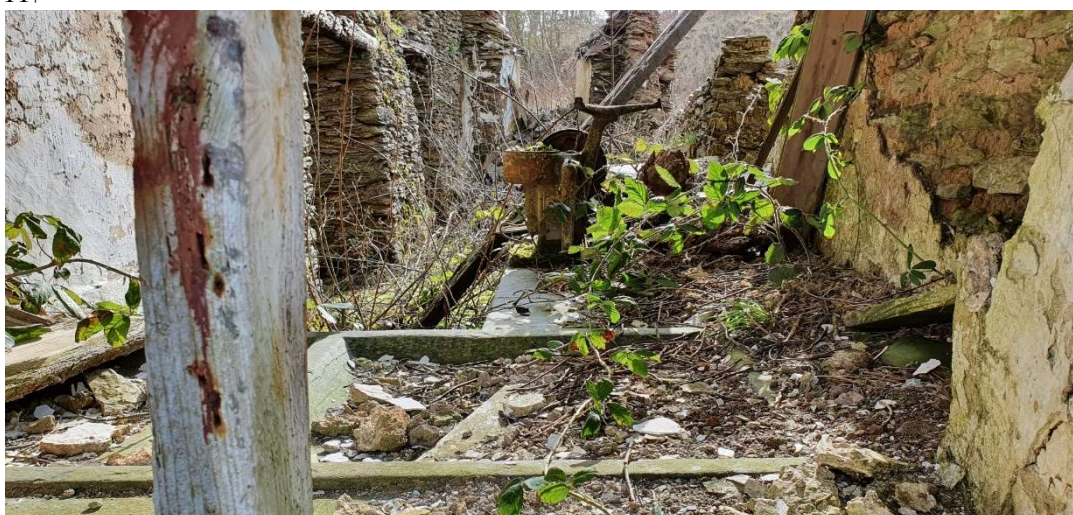
