## **1. Summary**

1.1 This historic environment appraisal has been undertaken by Trysor to examine likely impacts on the historic environment from a proposed wind turbine at Rhyd y Merydd farm, Efailwen, Carmarthenshire, planning application number W/28280.

1.2 The appraisal has looked at all known historic assets within an area measuring 2km in radius, focused on a central point at the proposed turbine site at SN1460224622, consulting the regional Historic Environment Record and the National Monuments Record, as well as examining historic maps. A field visit was also undertaken to examine the location of the turbine and record previously unknown historic assets.

1.3 The appraisal shows that there is no evidence of significant archaeological features at the proposed development site, nor is there a significant indirect, visual impact on site in the wider landscape.

1.4 There are findspots recorded (ID numbers 1 & 2), for a Bronze Age stone axe-hammer and a Roman coin hoard which suggest the potential for unknown buried archaeology. Neither of them have an accurate grid reference but the written description of them locates them close to Rhyd y Merydd.

1.5 If planning permission is forthcoming an archaeological watching brief on groundworks for the turbine in order to record any artefacts or features with which the axe hammer and hoard could have been connected might be appropriate

## **3. Introduction**

3.1 Ruth Ward of Mosscliff Environmental Ltd, Horham Airfield, Horham Road, Denham, Eye, Suffolk, IP21 5DQ commissioned Trysor heritage consultants on behalf of their client, Mr Davies of Rhyd y Merydd, Efailwen, Clynderwen Pembrokeshire, SA66 7XG to write an Historic Environment Appraisal as part of documentation for planning application W/28280 for a single wind turbine at Rhyd y Merydd, Efailwen, Pembrokeshire.

3.2 Dyfed Archaeological Trust Heritage Management section supplied a generic brief for the appraisal, (DAT HM, Undated), which was to be a rapid appraisal of the readily available historic environment information including a site visit. The purpose of the appraisal was to inform DAT HM as to whether any further assessment or evaluation would be required as part of the planning process. Trysor prepared a specification based on the brief (Trysor, 2013)

3.3 Dyfed Archaeological Trust Heritage Management section in a letter to the planning authority stated that

*The proposed development lies in an area, which contains a number of heritage assets, both scheduled and unscheduled.....There is also a potential issue of cumulative impact upon a landscape containing several prehistoric sites, with wind turbines proposed to the northwest and northeast of this application.....The site is also located close to the Registered Historic Landscape of Glandy Cross (HLC 265) DAT HM 2013*

#### 4. The proposed development




Figure 1: Location of the proposed turbine, showing the 2km radius appraisal area.

4.1 It is proposed that a single turbine with 24.6m to the upright blade tip will be located in a single field parcel at SN1460224622 at Rhyd y Merydd, Efailwen, Clunderwen, Pembrokeshire, SA66 7XG, see Figure 1.

4.2 The turbine will require a foundation hole, approximately 5 metres square, and with a cable trench up to 1 metre deep running approximately northeast for approximately 220 metres. Access will be from the farm track via existing gateways. A trackway across the field will not be necessary.

## **5. Methodology**

5.1 A study area of 2km radius circle centred on SN1460224622 was chosen for the initial appraisal of sites. This area was revised to exclude an area on the southern and eastern edges of the study area, where there was no view between the sites and the proposed location of the turbine, nor would there be any impact on setting, see figure 2.

5.2 The HER enquiry for the 2km radius area yielded 77 records.

5.3 Within the 77 records, one was a duplicate and one was a DELETED record, only kept in the HER for admin purposes, and these were removed from the dataset. A further 24 records lay with the excluded area outlined in 5.1 above and these were also removed. This left 51 HER records in the appraisal dataset. Eight of these were Scheduled Ancient Monuments and four were Listed Buildings.

5.4 A site visit was made to Rhyd y Merydd and the surrounding area on August 20th, 2013 to rapidly appraise if there were any visible archaeological features within the area directly affected by the turbine proposal and also the wider landscape context of the proposed development. The field was under pasture at the time.

5.5 The aerial photographs on Google Earth, dating to 2005, 2006 and 2009, were used to inform the appraisal.

5.6 Historic mapping was consulted. The maps used included 19<sup>th</sup> and 20<sup>th</sup> century 1:2500 scale Ordnance Survey mapping and the *Cilymaenllwyd* parish tithe map and accompanying tithe schedule (dated to 1837).

5.7 All information gathered during the desktop appraisal and fieldwork was entered into a bespoke database in Access 2003 format to create an appraisal dataset. The dataset is the source of the material output in this report, including the GIS mapping which illustrates the location of sites in the area, and the tables and appendices which provide detailed information on the sites within the study area.

5.8 At the end of a rapid appraisal of the data, the information from the site visit and historic map search, the appraisal dataset contained 52 records. As stated in 5.3, twenty six HER records were discarded as they were for a duplicate or deleted record or were within the area excluded, whilst a new record was created as a result of the desktop work and field survey undertaken by Trysor.

5.8.1 The National Monuments Record was consulted and compared with the HER. No records were added from this source to the appraisal dataset.

5.8.2 A new record was created in the project database by Trysor for the farmstead of Rhyd y Merydd (ID number 52).

5.9 Each of the records in the final appraisal dataset was assessed for Period, Rarity, Documentation, Group Value<sup>1</sup>, as well as Evidential Value, Historical Value, Aesthetic Value, Communal Value<sup>2</sup>. Once these had been considered the significance of each site





was determined and scored in accordance with the categories adopted by the Welsh Archaeological Trusts i.e. Nationally Important, Regionally Important, Locally Important, Minor and Features Needing Further Investigation (Unknown), see Figure 4. Full details of this exercise are given in Appendix C.

5.10 As this exercise is an appraisal of the study area, not a full desk-based historic environment assessment, no site descriptions have been included in the appraisal dataset or this printed report, apart from newly recorded features (See Appendix B).

## 6. Rhyd y Merydd: Historical overview

6.1 On the 1809 Tenby sheet of Ordnance Survey Original Surveyors Drawing and the 1819 1” to 1 mile Ordnance Survey map show *Rhydymerydd* is shown in its current position. Only partial field boundaries are depicted but the field in which the turbine would stand appear to be shown on the 1813 map.




Figure 3: Rhyd y Merydd on the Cilymaenllwyd parish tithe map

6.2 By the time of the tithe survey in 1837, gives the field names in Table 1 for the property, called *Rhydymherydd* which was noted as being owned John Phillips Allen Lloyd Phillips of Dale Castle, Ffosybleiddiaid, Mabws, and Ystrad Teilo and occupied by Owen James during the 1840s (see Figure 3);

6.3 The turbine would be located in field parcel 321 as shown on the tithe map *Parc Beatin*. *Beatin* is a Cymricisation and misspelling of “betting”, which is an old word for the practice of burning stubble and ploughing the ash back into the ground while still hot (“betting” comes from an old English word for “kindling a fire”).

6.4 The 1889 1:2500 Ordnance Survey map shows the farm buildings and field system clearly. The buildings are not easy to reconcile with what is present now but the fields of the same size and shape.

6.5 The field system of the holding shown on 19<sup>th</sup> century maps, including the area around the proposed turbine, has undergone little change during the past century. A few of the smaller fields have been amalgamated to create bigger fields, but the field the turbine would be in has remained the same.

## **7. Rhyd y Merydd farm: Proposed turbine site**

7.1 The proposed turbine at Rhyd y Merydd will be located in a single field parcel at SN1460224622 at Rhyd y Merydd, Efailwen, Clunderwen, Pembrokeshire, SA66 7XG, see Figure 1. The turbine will require a foundation hole, approximately 5 metres square, and with a cable trench up to 1 metre deep running approximately northeast for approximately 220 metres. Access will be from the farm track via existing gateways.

7.2 When the farm and its environs were visited in August 2013, an assessment was made of the intervisibility of key monuments in the local landscape with the proposed turbine site. This assessment was undertaken on a dry day and in reasonable light.

## **8. Impact Assessment**

8.1 Within the revised area a total of 52 sites were recorded in the appraisal database.

8.2 The Direct and Indirect impact on each site was assessed taking into account both physical and non-physical impacts. Each impact was assessed within the scale Very Low, Low, Moderate, High and Very High, taking into account the significance of the site and the nature of the impact. A full table is found in Appendix A but a summary is tabulated in Table 2 below and illustrated in Figure 4.

8.3 As Table 2 and Appendix A show, no recorded historic assets within the area of the appraisal were determined to be exposed to any significant impact from the proposed turbine development. (Details of the appraisal for direct and indirect impact for each of the sites in Table 2 can be found in Appendix A).

8.4 An examination of the proposed development site identified no evidence of surface material of archaeological interest. The land was under pasture and generally well-grassed, with very little exposure of the underlying soil surface.


8.5 The cable trench will run northeast for approximately 200 metres towards an electricity pole close by the farmhouse. It will go through existing gaps in two field boundaries.

8.6 The only possible mitigation thought necessary in relation to the groundworks for the turbine is a watching brief as there have been artefacts found in the general area of Rhyd y Merydd, including a stone axe-hammer (ID number 933) and a Roman coin hoard (ID number 925)

## **9. Historic Landscape Aspects Relating to the Rhyd y Merydd Proposed Turbine**

9.1 The following aspects of the historic environment around the Rhyd y Merydd proposed turbine site have also been considered by this appraisal, as required by the brief supplied by the Dyfed Archaeological Trust Heritage Management Section (DAT, HM, Undated);

### **a) Scheduled Ancient Monuments in their settings**

There are eight Scheduled Ancient Monument within, or partially within, the appraisal area. On three of these there would be no impact at all. There would be a Very Low impact on four of the Scheduled Ancient Monuments (ID numbers 3, 4, 6 and 22), where there would be partial intervisibility over distances greater than 1km and the setting of the monument would not be affected. One monument (ID number 7) would experience a Low impact. It would be intervisible with the turbine, 950 metres between the two. However the turbine would not affect the monuments setting.

### **b) Previously Recorded Non-scheduled Ancient Monuments in their settings**

A small number of historic assets in the appraisal area are thought likely to experience a low or very low indirect, visual impact. This is due to their being intervisible with the proposed turbine over distance, but in no case would their setting affected by the development.

Potential impacts on Non-scheduled Ancient Monuments are included in Appendix A. The significance of Non-scheduled Ancient Monuments is addressed in Appendix C.

### **c) Newly identified sites of historic importance**

One newly recorded site of historic importance was noted for this appraisal. This was a record for the farmstead of Rhyd y Merydd (ID numbers 52) which will experience a Low, direct impact as the turbine will be erected within it. However there will be no physical impact on elements of the farmstead.

Further details of this site are included in Appendices B & C.

### **d) Listed Buildings in their settings**

There are four Listed Buildings within the appraisal area. Three of them would experience a Very Low impact with partial intervisibility over 1.25km, but no affect on the setting of the sites.

### **e) Non-statutory buildings of local importance**

No non-statutory buildings of local importance included on a local list were identified as being affected by the proposed development. A number of buildings of local interest are thought likely to experience a Very Low, indirect visual impact as a result of the development. These are ID numbers 36, 38, 45, 49 and 50. The settings of these buildings will not be affected.

### **f) Registered Parks & Gardens and their essential settings.**

There are no Registered Parks and Gardens within the overall study area.

### **g) Registered Historic Landscapes**

The development site does not lie in a Registered Historic Landscape but part of the appraisal area lies with the Preseli Historic Landscape. Two character areas fall within the appraisal area, Glandy Cross HLCA 265, and Llangolman HLCA 266. Most of the

Llangolman HLCA will not be intervisible with the turbine. Glandy Cross HLCA will be intervisible.

**h) Non-registered Historic Landscapes**

There are no identified non-registered Historic Landscapes within the overall study area.

**i) LANDMAP and landscape characterisation information**

The proposed turbine would stand in the Trelech LANDMAP Historic Landscape Aspect Area (CRMRTL42474). This extensive aspect area is characterised by small settlements and dispersed farms, some of which are quite large, set in a landscape of irregular-shaped fields. Woodland often lies on the steep, deeply incised valley sides. The most significant archaeological elements are the extant buildings, Iron Age forts, and small industrial sites. The overall evaluation of the landscape is High.

The proposed development would not impact on the essential character of the area, the small scale development fitting in with the existing landscape.

**j) Conservation Area**

There are no Conservation Areas within the overall study area.

**k) Tir Gofal interests or requirements**

No Tir Gofal interests were identified.

**l) Buried archaeological potential**

There is no surface, map, or aerial photographic evidence suggestive of significant buried archaeology at the proposed development site. However there are two findspots (ID numbers 1 & 2) for a Bronze Age stone axe-hammer and a Roman coin hoard that suggest the potential for unknown buried archaeology. Neither of them have an accurate grid reference but the written description of them locates them close to Rhyd y Merydd.

**m) Palaeoenvironmental potential**

No palaeoenvironmental potential can be identified at the Rhyd y Merydd Farm turbine site. It is situated in a pasture field which is relatively well-drained.

**n) Hedgerows and field patterns**

The proposed development would be located in an arable field, which seems to have been in its current shape and size since at least the time of the tithe survey. The proposed development will not change the character of the field system nor have a significant effect on any field boundary banks.

**o) Ancient woodland**

There are eight areas, or parts of areas of Ancient and Semi-natural Woodland within the appraisal area. Six are Ancient or Semi-Natural Woodland and two are Plantations on Ancient Woodlands. They are all along valley sides and will not be intervisible with the proposed turbine.

**p) Place-names**

The farm name, Rhyd y Merydd, is an echo of the medieval sub-division of the parish into four hamlets. The northernmost of these was *Maenor y Merydd*. The use of the term *Maenor* itself appears to be a reflection of an earlier Welsh land unit defined under

medieval Welsh law, implying that an estate of that name existed outside the ecclesiastical system. It is evident that *Maenora* had their roots in the pre-Norman system of land division and administration as examples are known within Carmarthenshire from pre-11th century sources, such as *Maenor Meddynfych*, in the Llandybie district.

Whereas the meaning of *Rhyd* is well known to represent a ford, the origins of the word *Merydd* are a little less clear to even the modern Welsh speaker. The term *merydd* has been documented in 18th and 19th century dictionaries of the Welsh language. It simply means a damp or wet area. Dr William Owen Pughe records in his 'Dictionary of the Welsh Language: Explained in English' that *Merydd* means;

*"That is flat, or low; being flaccid, drooping, or sluggish; a wet place: a splash; a slug; a sluggard; a larder; also the sea matweed; otherwise called morhesg, and merydd y mor."* Pughe also records the use of the term *dwfr merydd*, meaning 'stagnant water'.

The situation of the land of *Maenor y Merydd*, and *Rhyd y Merydd* farm itself, help us make a credible interpretation of the place-name. The *maenor* was focused on the upper reaches of the Wenallt stream valley and the farm sits on the western edge of the valley, its lands historically running down to the Wenallt. It is quite likely that in medieval times the upper part of the valley, and the hills that flank it, were known as a wet area, perhaps with pools of stagnant, standing water. A trackway must have crossed this wet ground and forded the Wenallt close to the present position of the farmstead. Post-medieval land improvements have removed any traces of such wet land and the farmstead and surrounding area is now characterised by a well-managed, enclosed and well-drained field system.

#### **q) Cumulative impact**

The wind farm at Llanboidy is visible on the skyline over 7.5km to the east-northeast.

### **10. Conclusion**

10.1 There would not be a significant impact on the historic environment or on individual historic assets in relation to the proposed development of the proposed wind turbine at *Rhyd y Merydd, Efailwen*.

10.2 No sites would be exposed to a direct impact. Two sites, a standing stone pair and the farmstead itself would be exposed to a Low, indirect, visual impact (ID numbers 7 & 52) with another eleven exposed to a Very Low indirect, visual impact

10.3 There are findspots (ID numbers 1 & 2), for a Bronze Age stone axe-hammer and a Roman coin hoard which suggest the potential for unknown buried archaeology. Neither of them have an accurate grid reference but the written description of them locates them close to *Rhyd y Merydd*.

10.4 On the basis of this appraisal, the archaeological mitigation thought necessary in would be an archaeological watching brief on the groundwork's for the turbine in order to record any artefacts or features with which the axe hammer and hoard could have been connected with.

In 1841, the census for Cilmaenllwyd parish shows that an Owen James farmed Rhyd y Merydd with his wife Phebe, both aged about 35. They had a 13 year old daughter named Margaret and employed two female servants, Margaret Griffiths (20) and Martha Griffiths (14), and two farm labourers, James Williams (25) and Owen Morris (15).

Owen and Phebe James still resided here in 1851, their ages now recorded as 48 and 47 respectively. They employed two female house servants, Martha Eynon (38) and Elizabeth John (19) as well as a male farm labourer, 21 year old Edward Edward.

The farm of Rhydymeryddfawr, still farmed by Owen and Phebe James, is recorded as being of 160 acres in the 1861 census. Their grandchildren, John (11) and Margaret Thomas (8) were at the farm when the census was taken. Two house maids were employed at this time, Phebe (23) and Anne Davies (17). Phillip Evans (32) was employed as a carter on the farm, as well as 14 year old shepherd named John James. Interestingly, a cottage named Rhydymeryddfach, occupied by an agricultural labourer, Dan Gibby, his wife and three children is also recorded in 1861. This property formerly stood on the land of Rhydymeryddfawr but has long disappeared.

By 1871, Phebe James had passed away and Owen James is recorded as a Widower, now farming 200 acres. His 21 year old grandson, John Thomas, lived here also, along with his sister Alice (17). There were three house servants, Benjamin Griffiths (25), Anne Perkins (23) and Rachel John (23). Dan Gibby, his wife and four children continued to live at Rhydymeryddfach (three of the children having been born since the previous census).

In 1881, John Thomas (31) has taken over the farm of Rhydymerydd which is now recorded as being of 128 acres. He lives with his wife Martha (37), who was born at Llanboidy, and five children under the age of 10; Phebe (9), Mary (7), Margaret (5), Thomas (3) and Hannah (1). The farm employed two female general servants at this time, Anne Davies (19) and Anne Nicholas (14). A young agricultural labourer named John James (22) now lived with his wife and baby daughter at Rhydymeryddfach.

John and Martha Thomas continued to farm Rhydymerydd in 1891 but now lived with eight children. Ben (7), Owen (4) and Martha (1) had been added to the family since 1881. An agricultural labourer named Danny Evans lived with his wife and four young children at Rhydymeryddfach cottage at this time.

In 1901, the Thomases and their six youngest children continued to live here, with 22-year old Thomas assisting his father on the farm. A five-year old grandson named William T. Bowen is also recorded. There is no mention of Rhydymeryddfach on this census return.

The last available census dates to 1911 paints an interesting picture of a family engaged in working together on their holding. John and Martha Thomas still head the household, assisted by five of their now adult children. Margaret (33) and Anna (29) did 'dairy work', Thomas (31) and Ben (24) worked on the farm, Martha assisted and William Thomas Bowen (16) is described as a 'Handy Boy'.

**Description:** The farmstead at Rhyd y Merydd is shown on early 19th century Ordnance Survey maps, and the field system has changed little since the time of the tithe survey in the 1840s.

In 1841, the census for Cilmaenllwyd parish shows that an Owen James farmed Rhyd y Merydd with his wife Phebe, both aged about 35. They had a 13 year old daughter named Margaret and employed two female servants, Margaret Griffiths (20) and Martha Griffiths (14), and two farm labourers, James Williams (25) and Owen Morris (15).

Owen and Phebe James still resided here in 1851, their ages now recorded as 48 and 47 respectively. They employed two female house servants, Martha Eynon (38) and Elizabeth John (19) as well as a male farm labourer, 21 year old Edward Edward.

The farm of Rhydymeryddfawr, still farmed by Owen and Phebe James, is recorded as being of 160 acres in the 1861 census. Their grandchildren, John (11) and Margaret Thomas (8) were at the farm when the census was taken. Two house maids were employed at this time, Phebe (23) and Anne Davies (17). Phillip Evans (32) was employed as a carter on the farm, as well as 14 year old shepherd named John James. Interestingly, a cottage named Rhydymeryddfach, occupied by an agricultural labourer, Dan Gibby, his wife and three children is also recorded in 1861. This property formerly stood on the land of Rhydymeryddfawr but has long disappeared.

By 1871, Phebe James had passed away and Owen James is recorded as a Widower, now farming 200 acres. His 21 year old grandson, John Thomas, lived here also, along with his sister Alice (17). There were three house servants, Benjamin Griffiths (25), Anne Perkins (23) and Rachel John (23). Dan Gibby, his wife and four children continued to live at Rhydymeryddfach (three of the children having been born since the previous census).

In 1881, John Thomas (31) has taken over the farm of Rhydymerydd which is now recorded as being of 128 acres. He lives with his wife Martha (37), who was born at Llanboidy, and five children under the age of 10; Phebe (9), Mary (7), Margaret (5), Thomas (3) and Hannah (1). The farm employed two female general servants at this time, Anne Davies (19) and Anne Nicholas (14). A young agricultural labourer named John James (22) now lived with his wife and baby daughter at Rhydymeryddfach.

John and Martha Thomas continued to farm Rhydymerydd in 1891 but now lived with eight children. Ben (7), Owen (4) and Martha (1) had been added to the family since 1881. An agricultural labourer named Danny Evans lived with his wife and four young children at Rhydymeryddfach cottage at this time.

In 1901, the Thomases and their six youngest children continued to live here, with 22-year old Thomas assisting his father on the farm. A five-year old grandson named William T. Bowen is also recorded. There is no mention of Rhydymeryddfach on this census return.

The last available census dates to 1911 paints an interesting picture of a family engaged in working together on their holding. John and Martha Thomas still head the household, assisted by five of their now adult children. Margaret (33) and Anna (29) did 'dairy work', Thomas (31) and Ben (24) worked on the farm, Martha assisted and William Thomas Bowen (16) is described as a 'Handy Boy'.
