4. Design of New Planting

Brief description of new planting site	Planting will be carried out in improved grassland previously used for sheep grazing situated at approximately 70 masl near Llandeilo in Carmarthenshire. The land is on a moderate slope below an area of existing broadleaved woodland. The soil is mineral and generally well drained becoming wetter at the bottom of the slope. The landscape is characterised by agriculture with patches of woodland and mature hedgerows. The nearest dwelling is around 130m from the planting areas. The planting will be visible from this property, but the new woodland is surrounded by existing woodland and so the planting will not affect the view significantly from the dwelling. There are no watercourses within the field parcel. There are no public rights of ways in or adjacent to the planting area.
Pre-planting ground preparation	Grass will be cut prior to planting. Trees will be planted directly with no prior ground preparation.
Design of new planting scheme	The species listed in section 7 will be planted in a random pattern with an average spacing of 2.37m to account for open space (see below) in single species groups of around 10-30 trees. Shrubs will be planted along the edge of the new planting to provide a woodland edge habitat. Alder and hawthorn will be planted in the wetter areas.
Type of planting stock and size of trees/shrubs	40-60cm bare-rooted stock.
Tree protection – what type of tree shelters/spiral guards will be used and why?	Spiral guards and canes to protect from rabbit and vole damage.
Fencing (livestock)	A post, wire and netting stock fence will be erected along two sides of the new planting area in compliance with Glastir fencing specification.
Deer protection (if an issue)	There are no significant deer population in the area and deer protection is not required.
Open ground	A 3m ride will be retained between the existing woodland and new trees, this will account for approximately 10% of the planting area (c.0.05ha).

Are standing trees present?	Trees in adjacent woodland and hedges have been excluded from the planting area. There will be no planting under the dripline of existing trees.

Control of vegetation around trees	Grass and agricultural weeds will be controlled by mulching and/or spot spraying with herbicide.	The owner (who is a licensed spraying operator) and/or licensed contractor.	Mulch will be applied around each tree at the time of planting and topped up annually as required to supress weed for 2-3 years after planting or until the trees are established. Grass and weeds beyond the mulch will be cut manually. OR Spraying will be done in late spring (with a follow up in summer if required) for 2-3 years after planting or until the trees are established.
Tree replacement	Dead trees will be replaced in accordance with the species mix given in section 7 to ensure there are 1,600 trees/ha.	The owner and/or a contractor.	Trees will be surveyed in summer for survival and replaced as required in the winter. This will be especially important until the trees are established (expected 3-4 years) but will be continued for the duration of the contract (12 years).
Fencing	New fencing around the planting areas.	The owner and/or a contractor.	Fence will be checked annually over the GWC contract commitment period (12 years) and repaired as necessary.
Tree protection	Damaged or missing spiral guards and canes will be replaced whilst trees are vulnerable to rabbit damage.	The owner and/or a contractor.	Tree protection will be checked as part of annual tree survival survey.
Removal of tree protection	Tree guards will be removed when the trees are no longer vulnerable to rabbit damage.	The owner and/or a contractor.	Expected to be approximately 8 years after planting.
Rides and paths through wood	The ride around the new planting will be mowed or strimmed.	The owner and/or a contractor.	As required

I will allow duly authorised officers of the Welsh Government, or their duly authorised agents, access to any land or any woodland areas included in the Woodland Creation Plan in order to inspect the land, any relevant equipment, storage facilities and records (including computer records), and any other aspect of the land within the Woodland Creation Plan in order to verify the accuracy of the information in this application, and I will give them all reasonable assistance for that purpose.

I understand that if my application is successful, I will be required to enter into a Glastir Woodland Creation Contract and payment of any grant funding will be conditional on compliance with the terms of that contract. If I am offered a contract and do not enter into the agreement, or fulfil the terms of the contract I may be excluded form re-applying for Glastir Woodland Creation for the following two calendar years.
