# 4. Design of New Planting

Planting will be carried out in improved grassland currently cut for hay adjacent to existing woodland situated 70 masl near Llechryd in Ceredigion. The planting is part of a One Planet Development and will contribute toward sustainable production and self-sufficiency as required by this scheme. The planting area is relatively flat with a mixture of well drained and wetter mineral soil. There is a pond and small un-named watercourse within the field parcel which will be maintained as open ground. The landscape is characterised by agriculture with patches of woodland and mature hedgerows. The nearest dwelling is around 200m from the planting areas and is screened by existing mature trees. The planting will not affect the view significantly from any dwellings. There are no public rights of way in or adjacent to the planting area.
Grass will be kept short by cutting until the point of planting. Trees will be planted directly with no prior ground preparation.
The species listed in section 7 will be planted in a random pattern with an average spacing of 1.9m to account for open space (see below) in single species groups of 10-30 trees. Alder and aspen will be planted in the wetter areas.
40-60cm bare-rooted stock.
Mesh guards and canes to protect from rabbit and vole damage.
Not required as the area is not grazed.
There are deer populations in the area but the property has already been deer fenced and so additional protection is not required.
The pond and small un-named watercourse within the field parcel which will be maintained as open ground, this is less than 0.1ha and accounts for approximately 10% of the planting area.

Trees in adjacent woodland and hedges have been excluded from the planting area. There will be no planting under the dripline of existing trees.

Grass and weeds beyond the mulch will be cut manually.
Tree replacement	Dead trees will be replaced in accordance with the species mix given in section 7 to ensure there are 2500 trees/ha.	The owner and/or a contractor.	Trees will be surveyed in summer for survival and replaced as required in the winter. This will be especially important until the trees are established (expected 3-4 years) but will be continued for the duration of the contract (12 years).

I will allow duly authorised officers of the Welsh Government, or their duly authorised agents, access to any land or any woodland areas included in the Woodland Creation Plan in order to inspect the land, any relevant equipment, storage facilities and records (including computer records), and any other aspect of the land within the Woodland Creation Plan in order to verify the accuracy of the information in this application, and I will give them all reasonable assistance for that purpose.

I understand that if my application is successful, I will be required to enter into a Glastir Woodland Creation Contract and payment of any grant funding will be conditional on compliance with the terms of that contract. If I am offered a contract and do not enter into the agreement, or fulfil the terms of the contract I may be excluded form re-applying for Glastir Woodland Creation for the following two calendar years.

I understand that the use of an agent or Management Planner does not affect my personal responsibility for the accuracy of the information provided in this application, nor does it absolve me of responsibility to comply with the terms of any contract should my application be successful.
