Hi Llinos,

I do think that any area which is being planted within the pink boundary on Map 1 would benefit from a walkover survey. The north-eastern orange area which is being planted lies adjacent to an area of lead mining activity SN70709059. These sites are notoriously extensive and and may have outlying sites. Am I right in thinking that the orange area is the only area on Map 1 that is being planted? If so this is the only area which needs to be surveyed. Looking again at the evidence I have identified a leat from the historic maps which crosses the planting area and a site which I omitted from the earlier response, so the planting does need to be reviewed. I'm happy to organise myself or a colleague to go and visit the site. Best wishes Alice



We're currently in the process of verifying a Glastir Woodland Creation application for AU Farms, and we've come across a few things at Site 1 Rhydyronnon (SN706904) that we'd appreciate some clarification on please before we can proceed to the next stage of the process.

Could you please clarify what is meant by the following please: "An archaeological walkover survey should be carried out over the area shown in Map 1" – Is this just the area outlined in Green on Map 1, or the whole Expression of Interest area outlined in pink?

Also, please find below a map of the agreed planting site at Rhydyronnen (*orange polygon = planting area / purple dashed line = new fencing*).



As you can see from the map above, the area of concern outlined in green on your map has been excluded from planting, along with the higher areas surrounding the scheduled monuments. Could you please confirm whether or not you're happy with the current proposal to plant 100% broadleaves in the orange areas on the above map? Would you suggest an unplanted buffer of an appropriate size, or are you happy that in terms of archaeological features that they will no longer be affected?

DAT have reviewed the new planting proposals for A0027687 Aberystwyth University Farms against the Historic Environment Records database and other readily available record sources and have assessed that the application, as submitted, has the potential to have an impact upon the following Historic Environment Features (HEFs):

DAT therefore advise that in order to comply with UKFS Forests and the historic environment guidance, the following advice should be adhered to in the Glastir Woodland Creation plan:

- No planting within the areas outlined in green on the enclosed maps,
- Access tracks/loading areas should not cross these areas,
- An archaeological walkover survey should be carried out over the area shown in Map 1 further details also required on the planting scheme,
- A generous buffer of open ground around the ROC post PRN121763, Map 2, to preserve its open aspect and retain the interpretation of the building,
- Mixed broadleaf only should be planted on the areas shown in Map 3,
- Cadw must be consulted on any planting which affects the setting of the scheduled Round Barrows CD239.
