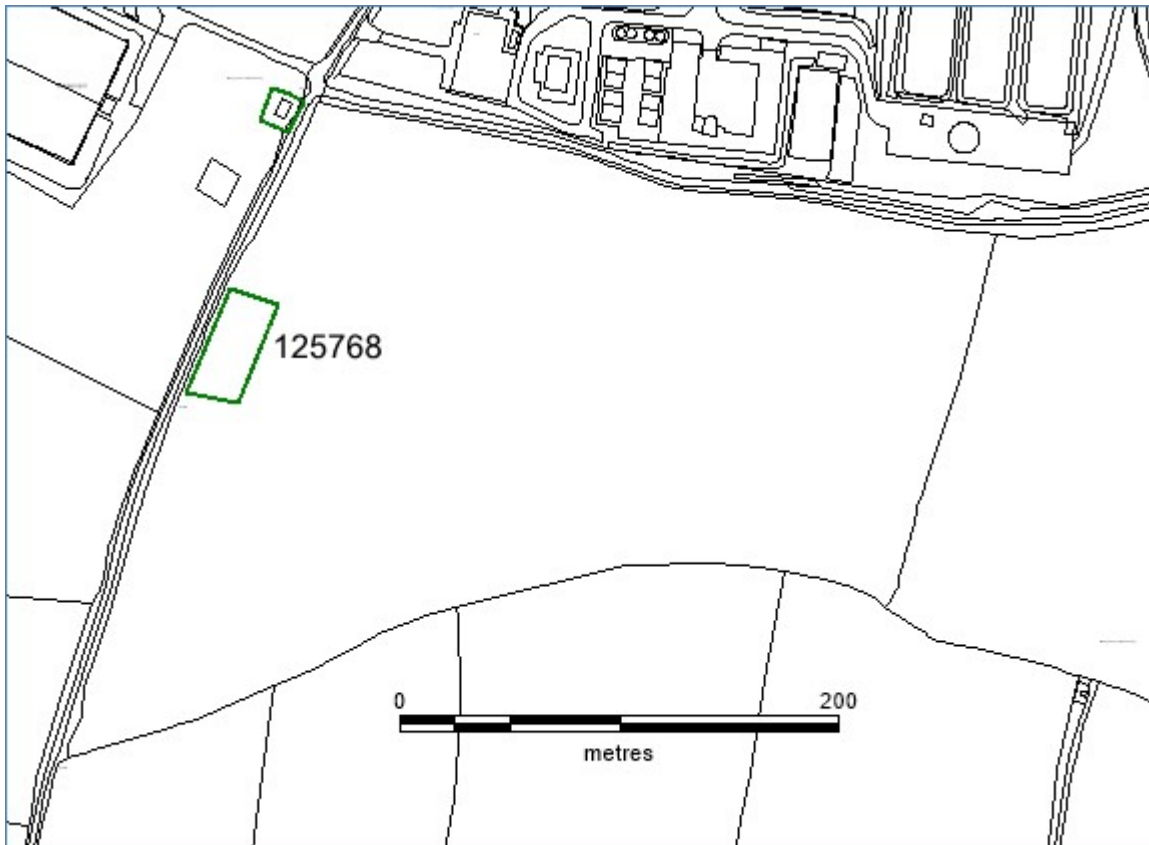
Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment feature within the consultation area;

PRN 125768

Site type: Cottage

NGR: SM91731097

Description: A cottage and garden are recorded on the 1st and 2nd edition Ordnance Survey maps. Modern maps indicate that this cottage has been demolished and no visible traces remain on the modern maps and aerial photographs. A Pyper 2021.

Having assessed the application, the proposals for land-spreading of waste should not have a detrimental impact on this feature, which does not exhibit above-ground remains. However there may still be archaeological deposits surviving below ground, so ground intrusive activities should be avoided and we would recommend that these locations are not suitable for stockpiling waste.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
