Thank you for sending this consultation for the weir on the Afon Dulais at Llanwrda. I've checked the proposals against the Historic Environment Record and note that this weir (PRN 125769) appears on the 1906 Ordnance Survey map but not on the 1887 (1<sup>st</sup> edition) and appears to have been constructed to supply water power for the Vale of Towy Wool Factory (PRN 21905) which was in operation in the 19<sup>th</sup> century.

Clearly the weir is a historic feature, therefore could you supply more information regarding the proposals for modification? We can then make recommendations as to appropriate mitigation if considered necessary.
