The weir is a historic feature (PRN125769) which appears to have been constructed to supply water power to the Vale of Towy Wool Factory sometime around the turn of the 19th/20th century. It appears to have had subsequent modifications in the 20th century.

We request that general photographs are taken of the weir before and after the works are carried out which can be submitted to the Historic Environment Record. These can be taken on a digital camera and sent to me by email, or shared by wetransfer.com.
