



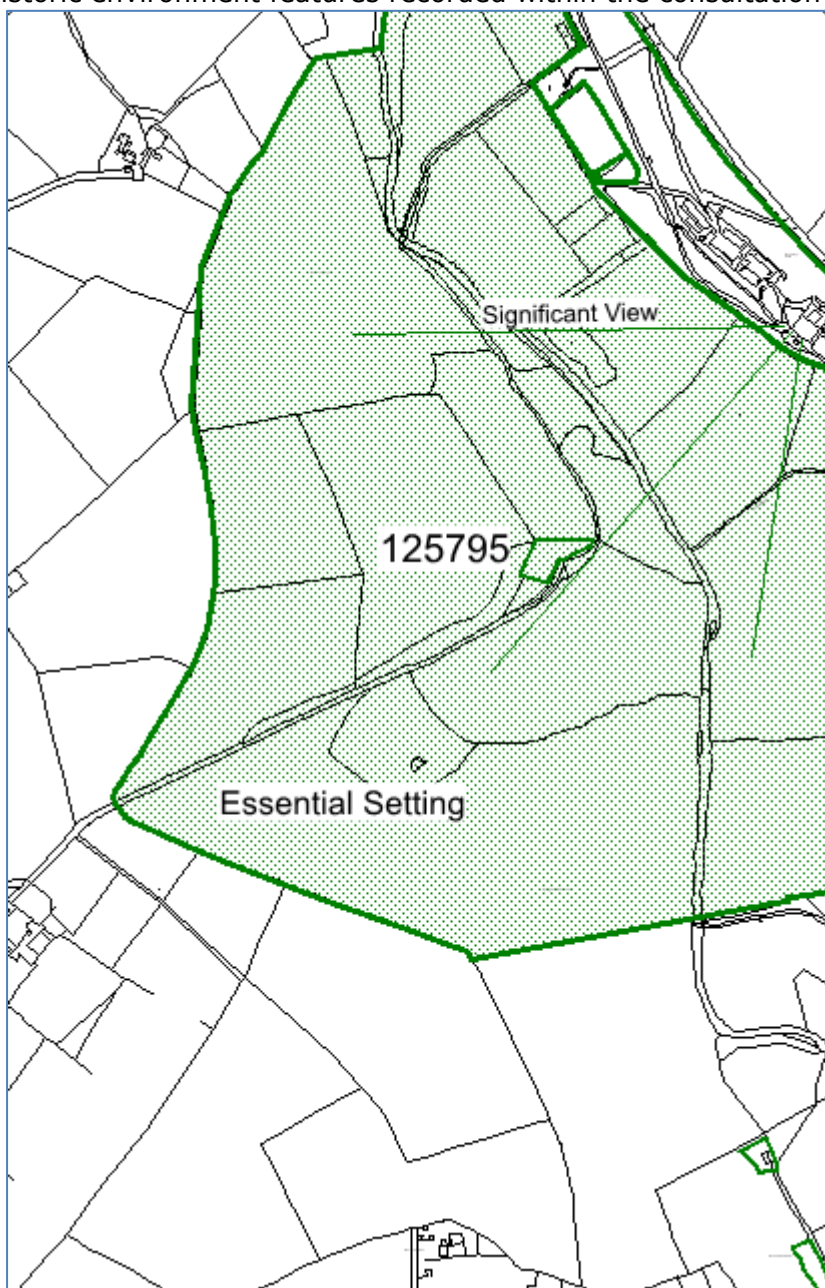

125795	A cottage within a wooded enclosure is recorded on the 2nd edition Ordnance Survey map.	Cottage	SN44694399

The current condition of this feature is unknown; however it may survive as ruins, earthworks or below ground archaeology. Felling operations should avoid causing damage in these areas.

In addition this woodland lies within the Essential Setting of the registered Grade II parkland of Alltyrolyn PGW (Dy) 46 (CER). This area was historically part of the designed landscape, framing views to and from, the mansion of Alltyrolyn. Following felling we recommend the sensitive replanting to restore the historic setting to the mansion. Please contact Dyfed Archaeological Trust Heritage Management for further advice and information.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
