Dear Arwel

Thank you for forwarding this woodland creation proposal to us. I have reviewed the new planting proposals against the Historic Environment Record and other readily available sources and note the following Historic Environment Features:

PRN 21852 Post Medieval Farmstead - Farmstead recorded on 2nd edition, 1:2500 Ordnance Survey map.
PRN 115945 Post Medieval Farmstead - Farmstead recorded on 2nd edition, 1:2500 Ordnance Survey map.
PRN 125799 Post Medieval Building - A building is recorded on the 1st edition Ordnance Survey map (1888).
PRN 125800 Post Medieval Building - A small building or structure to the southeast of Frongoch farmstead.
PRN 125801 Post Medieval Blacksmiths Workshop - A smithy is recorded on the 1st and 2nd edition Ordnance Survey maps.

In addition the consultation area incorporates parts of three different Historic Landscape Character areas:

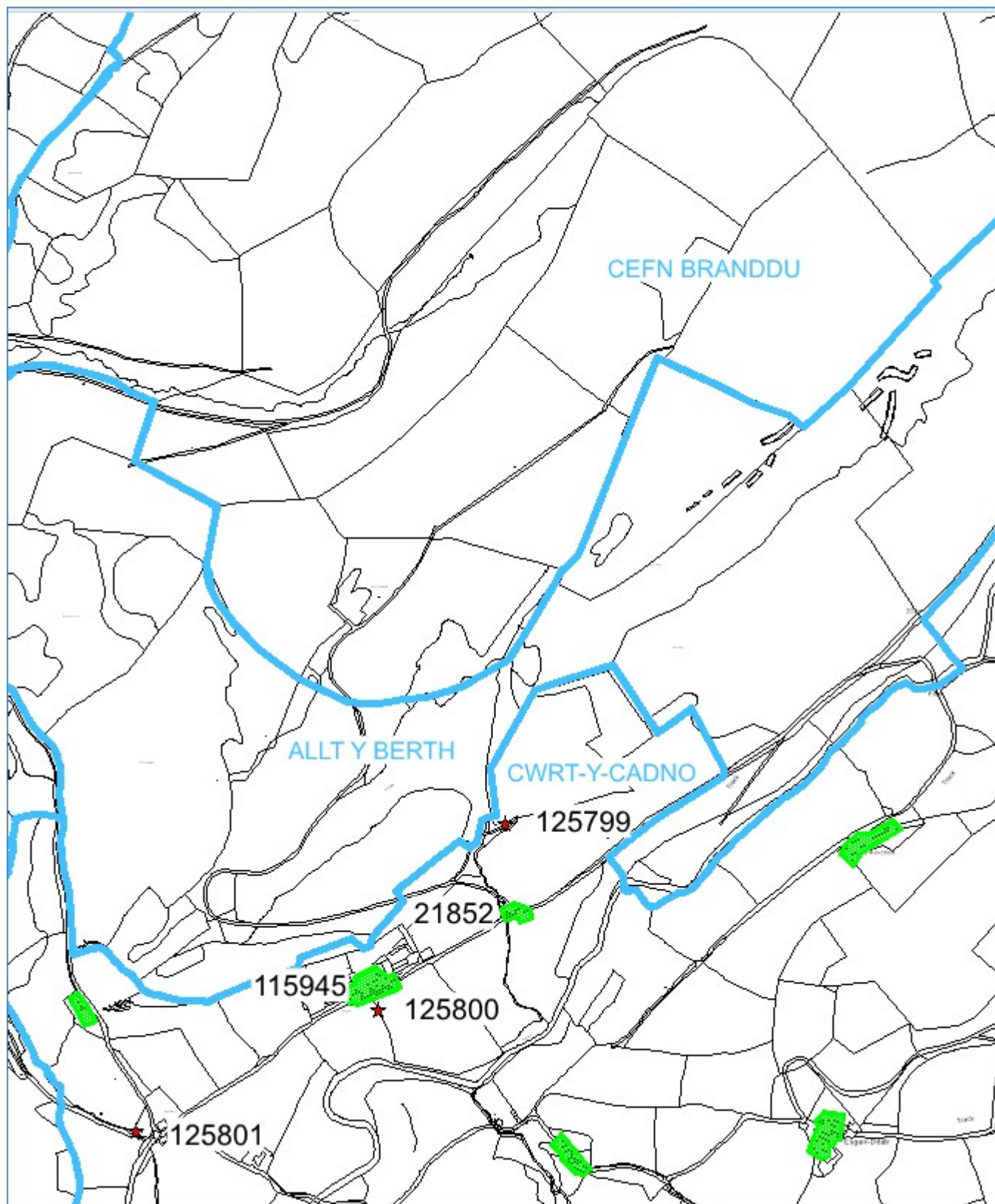

The landscape was historically unenclosed on the higher ground with deciduous woods on the steep valley sides and some scattered deciduous woodland in the valley floor.

As well as avoiding the features marked on the map below with an adequate buffer, to ensure they suffer no damage from woodland planting, we would also advise against planting on the high ground particularly with conifer species which, elsewhere, are a modern introduction to the landscape. We also have concerns about planting dense conifer plantations within the historic landscape on the valley floor which forms part of the Historic Landscape of Cwrt-y-Cadno.
