Welsh Raised Bogs LIFE Project; Cors Fochno and South Sites

Thank you for sending through the two consultations for Cors Fochno and South Sites including Cors Caron, I'm responding to these consultations together as my concerns apply to both. I have consulted colleagues widely, including the other archaeological trusts and Cadw for their input into this response to ensure a consistency of approach. However I must apologise for the delay which is my fault entirely.

I appreciate the efforts which have gone into providing these assessments, but they both fall some way short of a desk-based assessment carried out to the standards set out by the Chartered Institute for Archaeologists¹ and the best practice guidance note which Cadw have also recently issued on peatland restoration². A desk-based assessment would normally include searches of all available data including; Historic Environment Record (HER)³, National Monuments Record⁴, National Library of Wales, aerial photographs (historic and contemporary), cartographic records, LiDAR, palaeoenvironmental analyses and any other projects or data which may be relevant to each specific location. A walkover survey is also an essential part of this assessment.

Both of the larger project areas; Cors Fochno and Cors Caron, benefit from a Cadw funded archaeological assessment carried out by Dyfed Archaeological Trust which aimed to identify and understand the archaeological potential of these wetlands⁵.

The assessment for works at Cors Fochno has used the data and information within the Wetland Margins Survey: Cors Fochno, however the assessment for the south sites has not referred to the Wetland Margins Survey: Cors Caron. Even so both of these Wetland Survey reports are now over 10 years old and whilst much of the information still stands, new sources of information should be assessed (I imagine better LiDAR data should be available for instance) and most importantly the impact of the proposed work should be reviewed against all the available data.

In addition the other South Sites (Esgyrn Bottom, Cernydd Carmel, Waun Ddu) have not been subject to a full desk-based archaeological assessment as described above.

In addition to these general points I would like to make some specific comments about each report;

WRB LIFE Historic Feature Assessment - South Sites Cors Caron SAC

- The wetland survey highlights the potential for unexpected discoveries within the peat – a headless body was discovered by peat cutters in 1811 (PRN11497).
- The areas of work correspond to those identified in the Wetland Survey as areas 2, 3 and 4 which have been identified as having Medium archaeological potential for unrecorded archaeology, (Poucher 2010, p28, 29)⁶. This would strongly suggest the need for archaeological mitigation.

Esgyrn Bottom SSSI

- PRN122252 is incorrect, the mill record is PRN16944
- The statement that 'risk to historic features is thought to be very low' is not based on sufficient evidence, only when a full desk-based assessment and walkover survey is carried out can an assessment of risk be made.

Cernydd Carmel

• The statement that 'risk to historic features is thought to be very low' is not based on sufficient evidence, only when a full desk-based assessment and walkover survey is carried out can an assessment of risk be made.

Waun Ddu - Comments from Clwyd-Powys Archaeological Trust:

- the known historic assets are not at risk from the proposed works.
- We welcome the proposal to undertake some proactive management of historic features as suggested.
- The statement that 'risk to historic features is thought to be low' is not based on sufficient evidence, only when a full desk-based assessment and walkover survey is carried out can an assessment of risk be made.

WRB LIFE Cors Fochno

- Assessment using Archwilio HER of Wales Archwilio is not appropriate for use in decision making or heritage management, the full Historic Environment Record must be consulted.
- Excavator drivers are not in a position to identify archaeological features
 whilst undertaking their work, if an area is deemed to be archaeologically
 sensitive then a suitably qualified individual must be present to observe the
 machining and be able to stop excavation to investigate/record any remains
 which are uncovered.
- Dyfed not Dyfi.
- Gelli or Western mini bog bunding sits within the High archaeological potential zone (Poucher 2009, p60) near to the medieval trackway. The assessment should consider the impact (direct or indirect) works might have does the trackway lie outside the area which is bunded and therefore would it be subject to drying out? As mentioned above, this strongly suggests the need for archaeological mitigation in this area.

⁶ It would have been useful to have the GIS tables showing the location of works to be carried out, however I have reviewed as best I can against the maps provided.





To summarise best practice would include a suitably qualified and competent expert⁷ carrying out a desk-based assessment, reviewing current evidence, and a walkover survey which then assessed the impact of the proposed works. This assessment should consider the impact of works (including indirect impacts to archaeological features which may be affected by changing ground conditions, and include all access tracks / working areas or site compounds) and offer recommendations for archaeological mitigation if deemed necessary.⁸

I appreciate that this response has been delayed and therefore if works are already underway I would strongly recommend that we have a discussion to ensure any appropriate archaeological mitigation is put in place and discuss the best way forward. Whilst this is not ideal, consultation in the early planning stages of the project should be carried out in order to safeguard the historic environment.

Under the terms of the MoU between NRW and the Welsh Archaeological Trust this advice is provided as one of the Cadw funded tasks, further advice or monitoring of archaeological work will need to be funded by NRW.

I am on leave until the 18^{th} October but thereafter I'm available to discuss or clarify any concerns raised.


