**DAT 157 The Old Barn Talybont Farm Woodland Creation**

Thank you for your consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the application sits within the setting of the Scheduled Monument Llawhaden Bridge (PE023), and Cadw should be consulted. I am copying this response to Louise Mees Inspector for Ancient Monuments and Archaeology (South West Wales).

I have also noted the following historic environment features recorded within the consultation area;

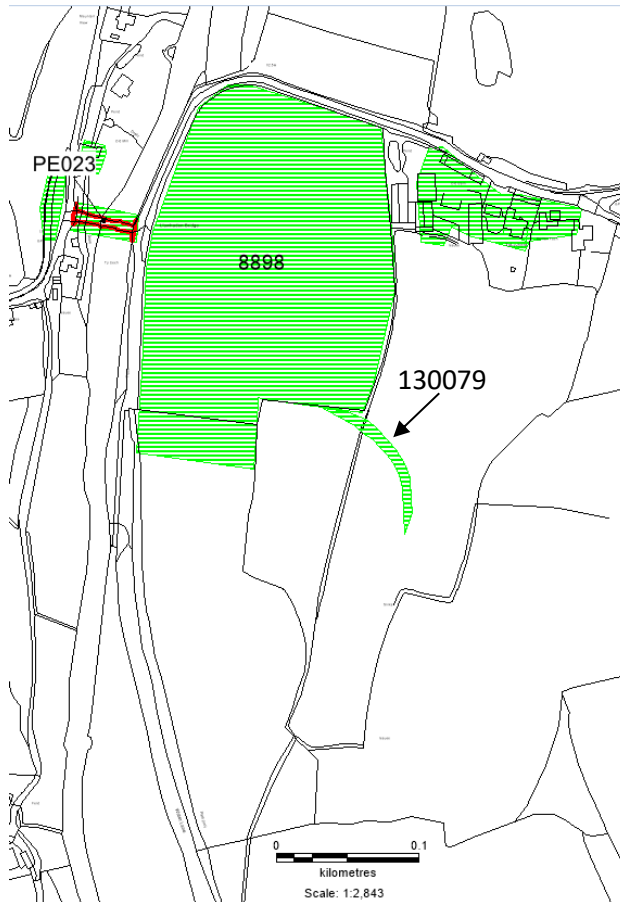

Due to the sensitivity of the archaeological earthworks, no planting should take place in the areas labelled and shaded in green on the map above and a 5-10m buffer placed around the features is recommended to prevent damage and disturbance. Although, we are comfortable recommending the area excluding these features be considered for planting.

In order to comply with UKFS Forests and the historic environment guidance planting within the areas outlined in green on the map above should be avoided, and access tracks/loading areas should not cross these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
