



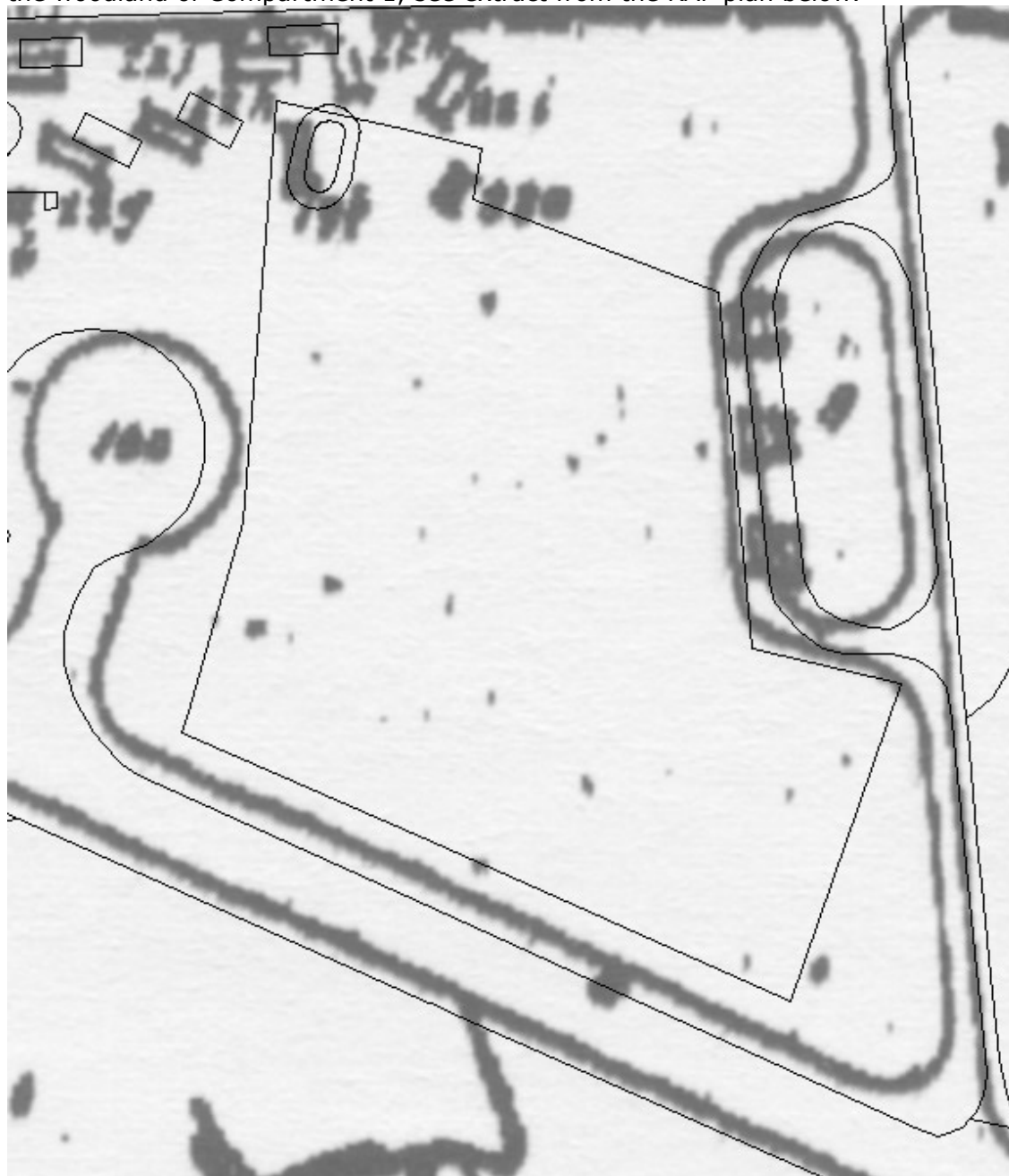

FLA 203 22-23 Templeton Training Area Woodlands

Thank you for your consultation and apologies for the delay. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note that forestry operations will be carried out within the historic airfield of RAF Templeton. Site visits have confirmed that the concrete footprint of this complex survive. In addition the footings of some buildings may survive within the woodland of Compartment 1, see extract from the RAF plan below.

Therefore in order to comply with UKFS Forests and the historic environment guidance, DAT advise that these historic environment features must be protected from damage during felling operations and subsequent restocking, and tracks and loading areas must not cross these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
