

# NRW Screening Request Bunkers Hill Farm FLA331 22-23

Thank you for your felling licence consultation. I've had a look at these proposals in reference to the Historic Environment Record and note the following historic environment features, all derived from historic map sources:

PRN 17691 LEWESTON POST MEDIEVAL MILL SM94202217 Quarry marked on the 1889 Ordnance Survey 1st edition 1:2500 map. Apparently disused by the publication of the 2nd edition map of 1906. Now covered by woodland. Site of an 'Old Mill' recorded on the 1889 1st edition Ordnance Survey map and presumed disused by this time. It is unclear how it was powered, although it is probable that water was diverted from the stream that runs to the south. Rees records (1932) a medieval mill (PRN 12518) in the vicinity and it is likely that it stood on the same site. The old mill is still recorded on the 1907 2nd edition OS - possibly still roofed - and is shown in outline on modern maps (M.Ings, 2013).

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
