





# **Ddolwen UKWAS Consultation**

Thank you for your UKWAS consultation. I've had a look at the area under evaluation in reference to the Historic Environment Record and note the following historic environment feature, which is derived from historic map sources:

PRN 129500 POST MEDIEVAL QUARRY SN3306734597 Old Quarry recorded on 1st Edition Ordnance Survey map. A.P 2023.

The current condition of this feature is unknown; however it may survive as ruin, earthwork or below ground archaeology. We advise that this historic environment feature (shown in green on the map above) is protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.


