The current condition of this feature is unknown; however it may survive as ruin, earthwork or below ground archaeology. We advise that this historic environment feature (shown in green on the map above) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

The consultation area lies within the Registered Historic Landscape
