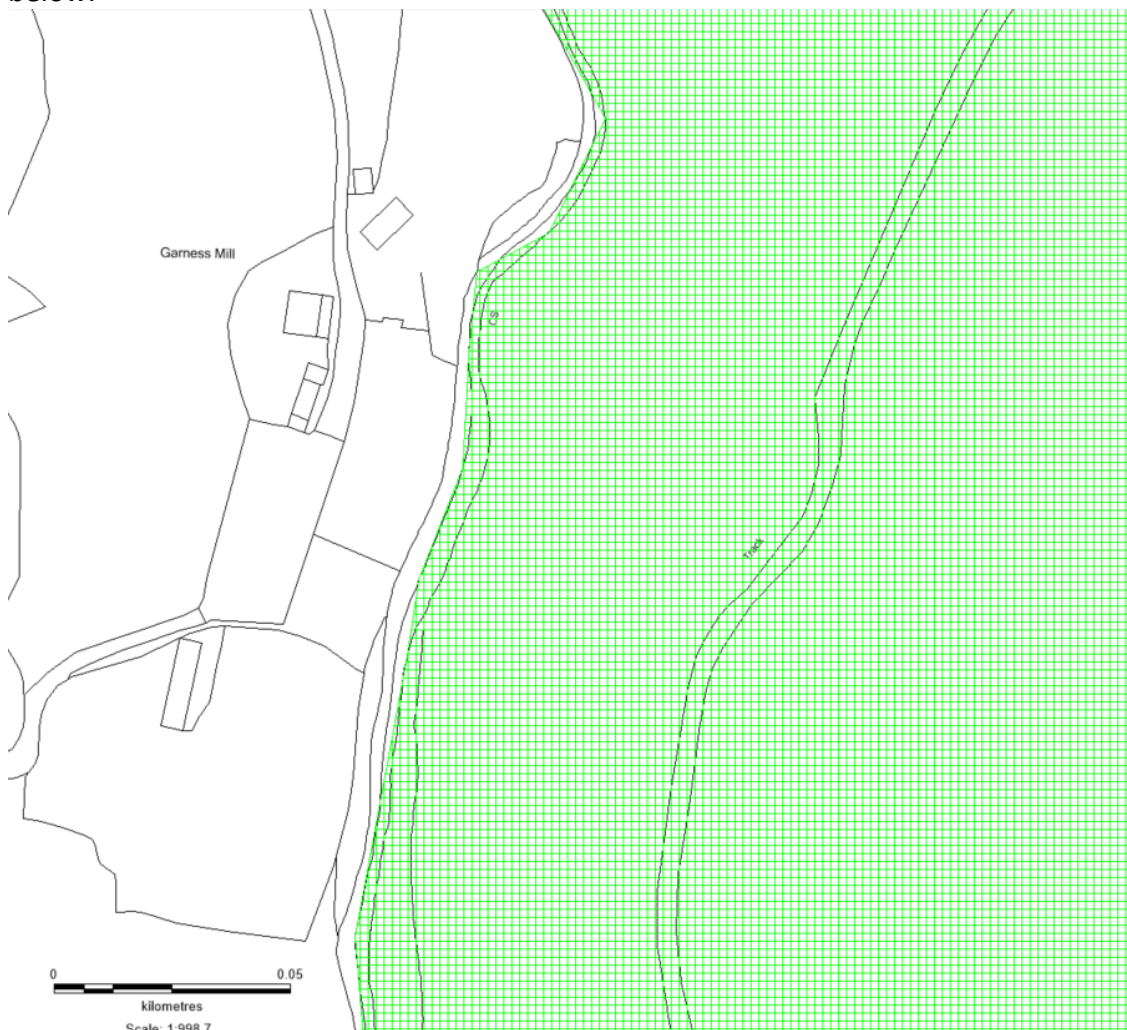

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the application falls within the Historic Landscape Character Area of Marros Mountain

The application and the surrounding land have been subject to several assessment which record medieval fields systems with ridge and furrow. The results of these assessments record the extent of these features within the green polygon on the map below.
