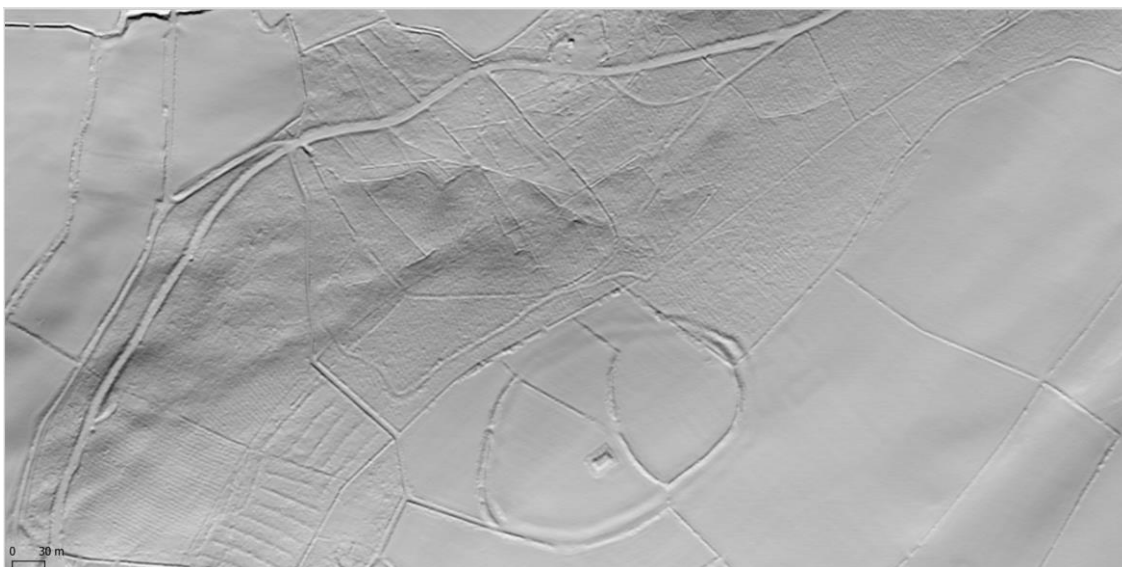
The current condition of these features is unknown; however, they may survive as a ruin, earthworks or below ground archaeology. We advise that these historic environment features (labelled on the map above and marked with a green polygon) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

The historic maps record Long Wood as mixed woodland. To reduce the visual impact of further conifer planting, we recommend any restocking be with native broadleaf species. The Lidar also shows an extensive agricultural landscape preserved beneath the woodlands and care should be taken to preserve any remnants of earlier field banks.
