Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the application lies within the Historic Landscape Character Area of Rheidol Valley in the Historic Landscape Area of Upland Ceredigion HLW (D) 2.

We have records for the Tynyfron lead mine (PRN25898) and Tramway SW of the application area. Care should be taken so that these earthwork features (labelled and marked with a green polygon on the map below) are not disturbed during forestry operations.
