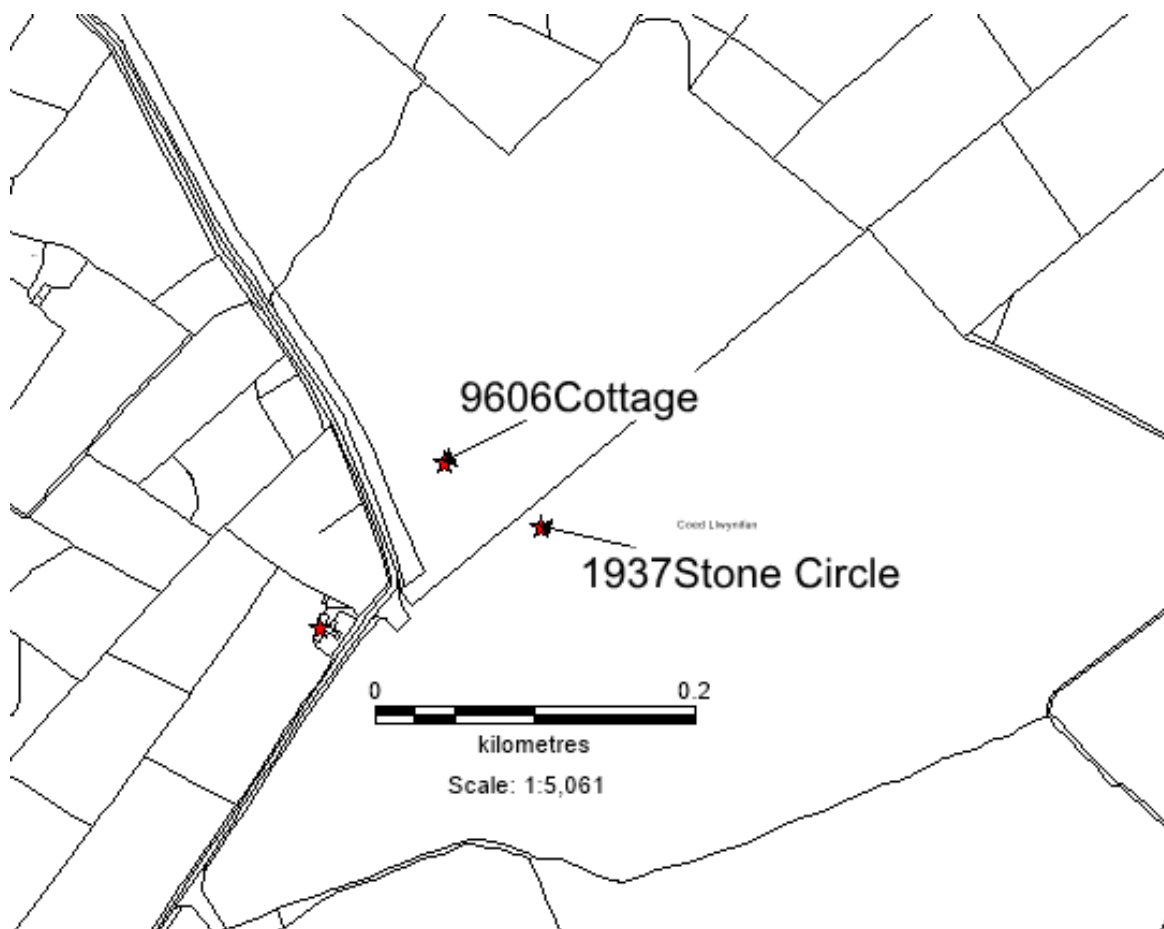

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following features:

PRN 1937 BRONZE AGE STONE CIRCLE SN63754838
Not seen by the OS in 1975, nor accessible for the PFRS project in 2004. NC 2005.
Location now covered by a coniferous plantation. The exact location of this feature is not known.

PRN 9606 POST MEDIEVAL COTTAGE SN63694842
Ruined drystone cottage recorded in 1979. RPS October 2001.
