Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the application sits within the parkland surrounding the post medieval mansion:

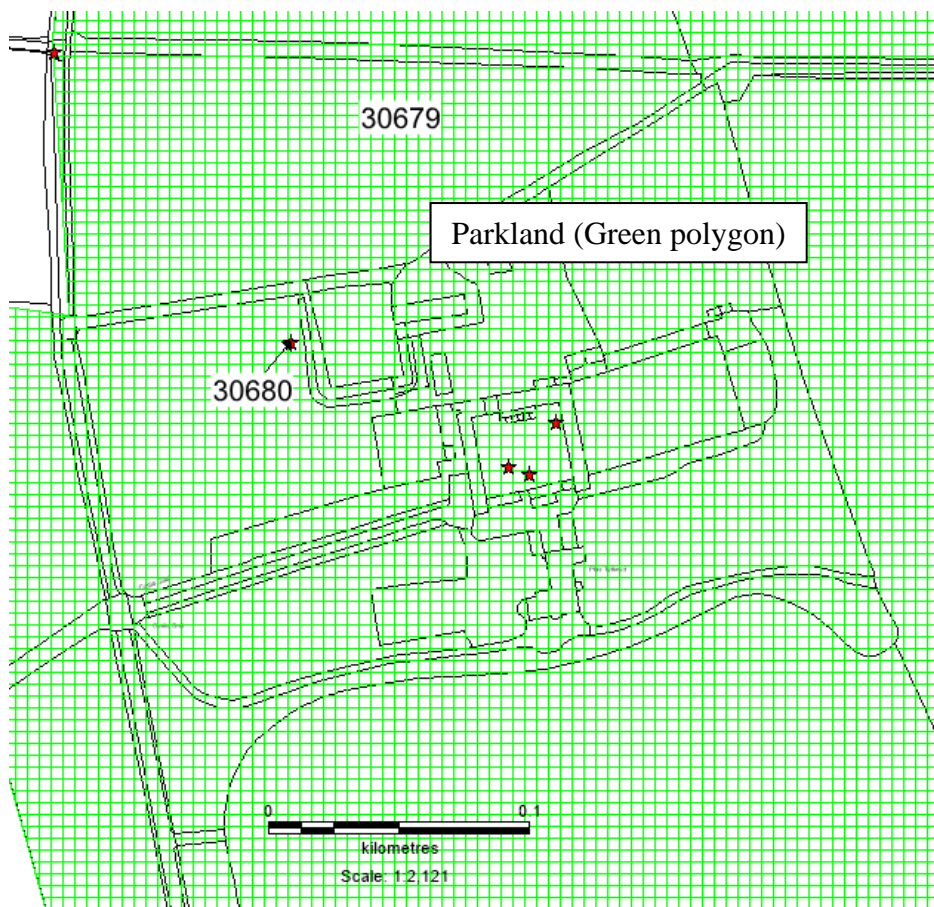
PRN 30679 TY-LLWYD POST MEDIEVAL PARK SN28414841

An area of parkland (marked as green polygon on map below) surrounding post medieval mansion, PRN 15490. The outer edges are woodland plantation mainly of beech, sycamore, lime, and horse chestnut. There is a former pond and wrought iron gates that lead onto the main drive. JH based on NL 1994.

I also note the following feature:

PRN 30680 TY-LLWYD MODERN FARMHOUSE SN28504830

A 1920's-30's house just to the north of the home farm PRN 30680. JH based on NL 1995. This PRN may have the wrong NGR. It's location is not certain.
