Thank you for sending this proposal through and apologies for the delay. I have had a look at our records and, as Tomos, identified part of this area has been subject to a Geophysical survey – you can see the report by following this link:

In summary the survey "has revealed a number of features of probable archaeological origin including former enclosures, land boundaries, pits and agricultural features." This, together with the Iron Age Defended Enclosure (PRN 3673) which represents a significant focus for prehistoric activity, means I wouldn't recommend tree planting in this area without further archaeological investigation to characterise the nature and extent of the archaeological features. I note that DAT's planning archaeologist has recommended "a programme of appropriate mitigation dealing with the archaeological deposits" for the housing development also.

Dear all,I'm looking for sites to plant trees to fulfill Pembrokeshire County Council's policy of replacing felled trees ith three newly planted ones. The property Section have highlighted land at Brny Hir near Tenby as a possibility. There is, however, an archaeological feature marked on the OS map in that field. See below. rid SN127, 018 or thereabouts. There is planning permission to develop housing on the field to the south and the access to this will be along the south west boundary following Sperriscombe Lane. My uggestion is to use the approx 2 acres highlighted on the map below to avoid the marked archaeological feature, the new housing development and provide benefits to biodiversity and recreation. The new rees would also buffer the site from visual and noise impacts of the main road.

Louise – I don't think it's scheduled, but any comments welcome.

Alice – have I missed anything and left sufficient room between the trees and the feature? Tomos, it's on PCC land, but is in PCNPA planning area. Any comments welcome.
