Level Fawr & Castell Sett SAN

Thank you for asking Dyfed Archaeological Trust to comment on the Environmental Screening Advice Note for Level Fawr Sett and Castell Sett. Firstly apologies for the delay in responding to your enquiry.

Each of these sites consist of a complex of significant historic features which include nationally important designated sites (Scheduled Monument of Castell Lead Mine (CD153), listed buildings associated with Lefel Fawr) which currently are not referenced in the request. An initial screening of the Historic Environment Record indicates 161 Historic Environment Features are recorded, see list below.

Therefore in order to fully understand the impact of the proposed works on the historic environment we recommend that an archaeological desk-based assessment (DBA) and accompanying walkover survey should be undertaken. This will help inform the proposed works to minimise impact to the historic features and develop an appropriate mitigation strategy.

The DBA should adhere to the standards and guidance provided by the Chartered Institute for Archaeologists (CIfA) (2014, updated 2020 <https://www.archaeologists.net/codes/cifa>). A Written Scheme of Investigation for the DBA should be agreed with DAT-HM in advance. In addition Cadw will need to be consulted on any works which impact the scheduled monument or its setting.
