Thank you for your consultation, and apologies for the delay in responding. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment features recorded within the consultation area;

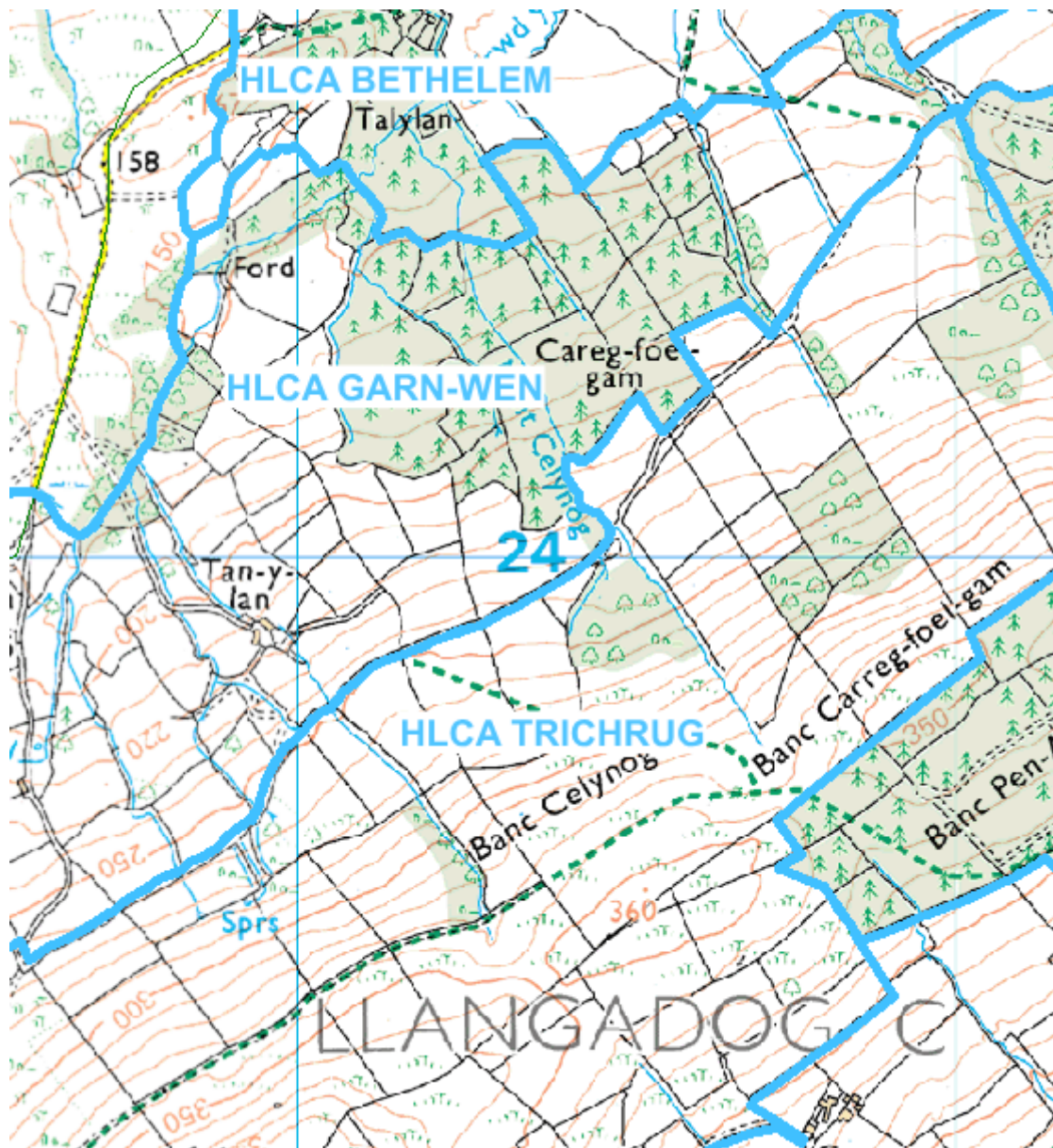

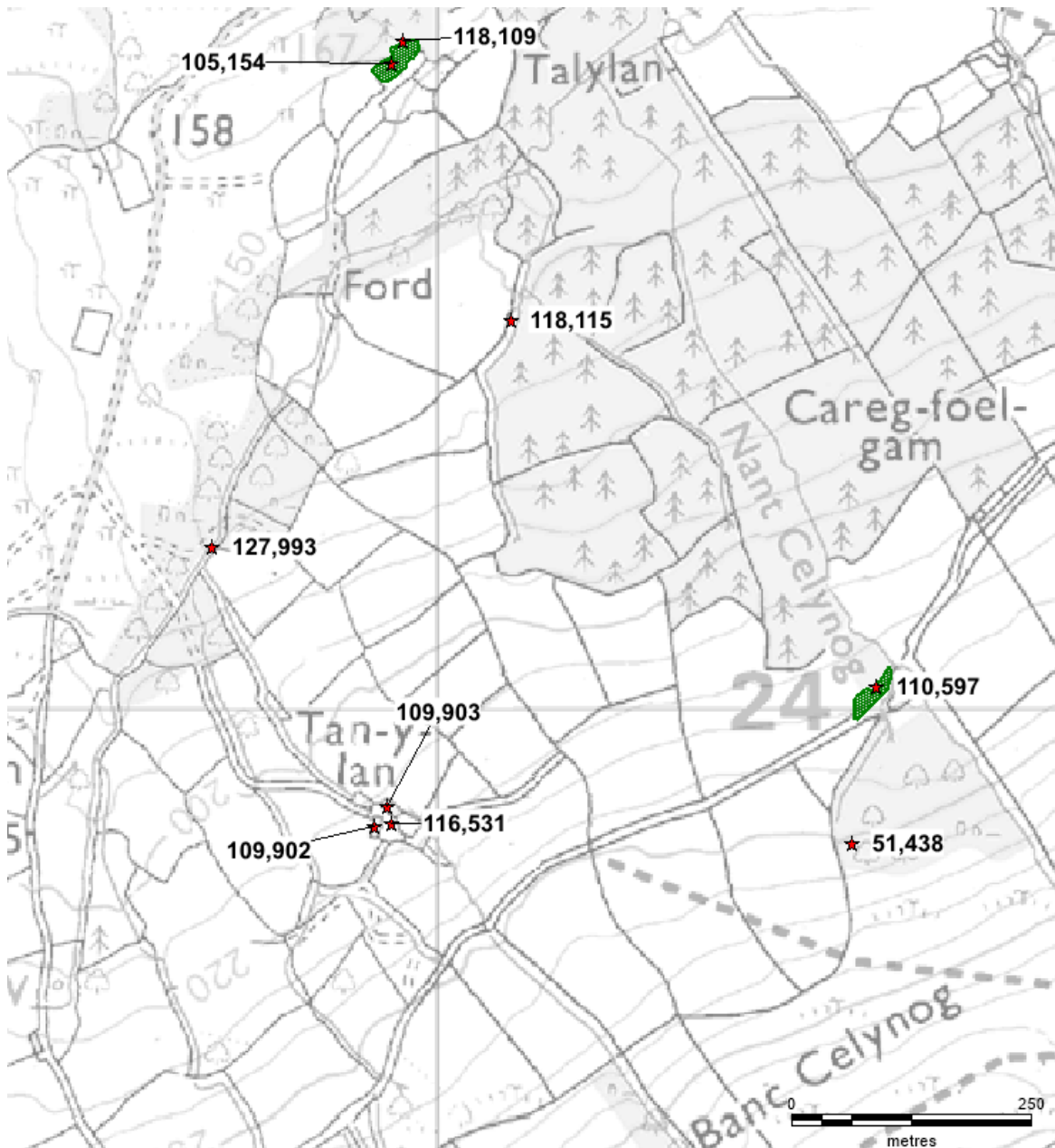
