**NRW Screening Request
FLA201 23-24 WWT Llanelli Wetland Centre.**

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following features:

PRN8813 TIR MORFA MAWR POST MEDIEVAL COAL MINE SS53509818
A small colliery shown as a disused working on the 1921 Ordnance Survey map. It is not shown on the 1891 Ordnance Survey map, however. This is evidently a late 19th - early 20th century mine.

PRN31672 MORFA BACAS MEDIEVAL SEA DEFENCES SS5370697911
Sea bank depicted on 1st and 2nd Edition OS, eastern section almost completely encloses sub rectangular area. Almost entire length replaced by corrugated steel shuttering driven into bank. BDA 1997.

PRN31677 TYRMORFA POST MEDIEVAL FARMSTEAD SS5323498545
Tir Morfa Farm identified from 1st Edition OS. BDA 1997. Farmstead recorded on 2nd edition, 1:2500 Ordnance Survey map.

PRN31678 PARC EINON FARM POST MEDIEVAL FARM SS53069835
Parc Einon Farm identified from 1st Edition OS. BDA 1997.

PRN31680 TIR MORFA POST MEDIEVAL TRACKWAY SS53029836
Trackway leading from Tir Morfa Fawr well to Parc Einon well, identified from 1st Edition OS. BDA 1997.

PRN31683 MORFA MAWR SEA DEFENCES SS52899848
Relict sea defence depicting limit of saltmarsh, identified from 1st Edition OS. BDA 1997.

PRN37417 ROPEWALK FARM POST MEDIEVAL FARM SS52889870
Unable to find farm on either historic or modern mapping. Unsure if location is correct. J. Smith 2022.

PRN130028 PARC-EINON POST MEDIEVAL WELL SS5296198369
Well recorded on 1st Edition Ordnance Survey Map. A Powell 2023.

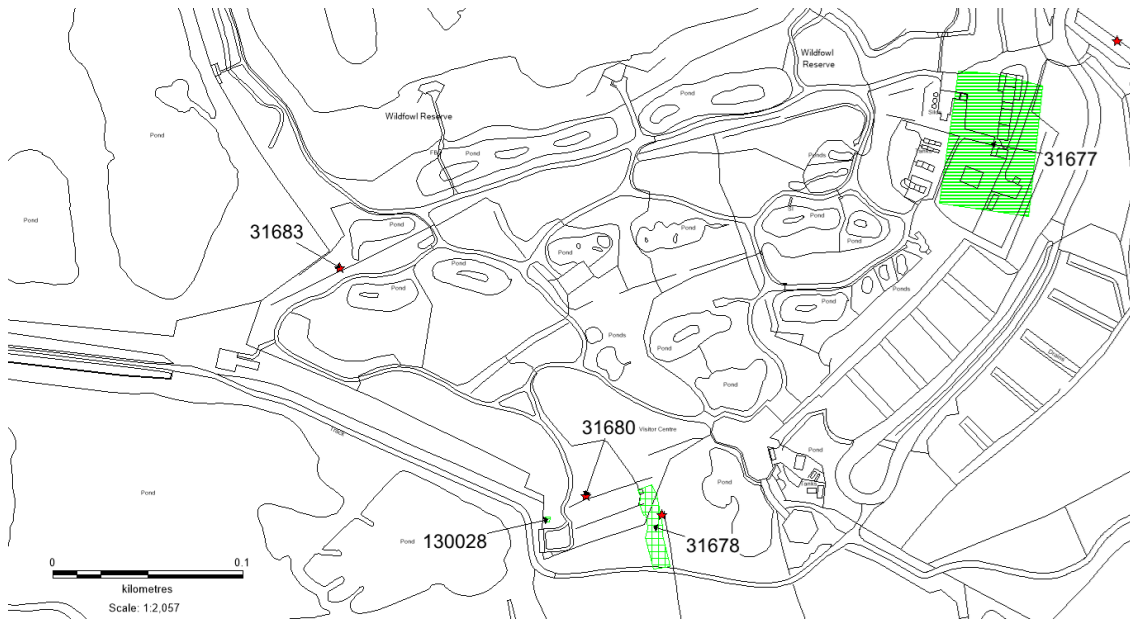

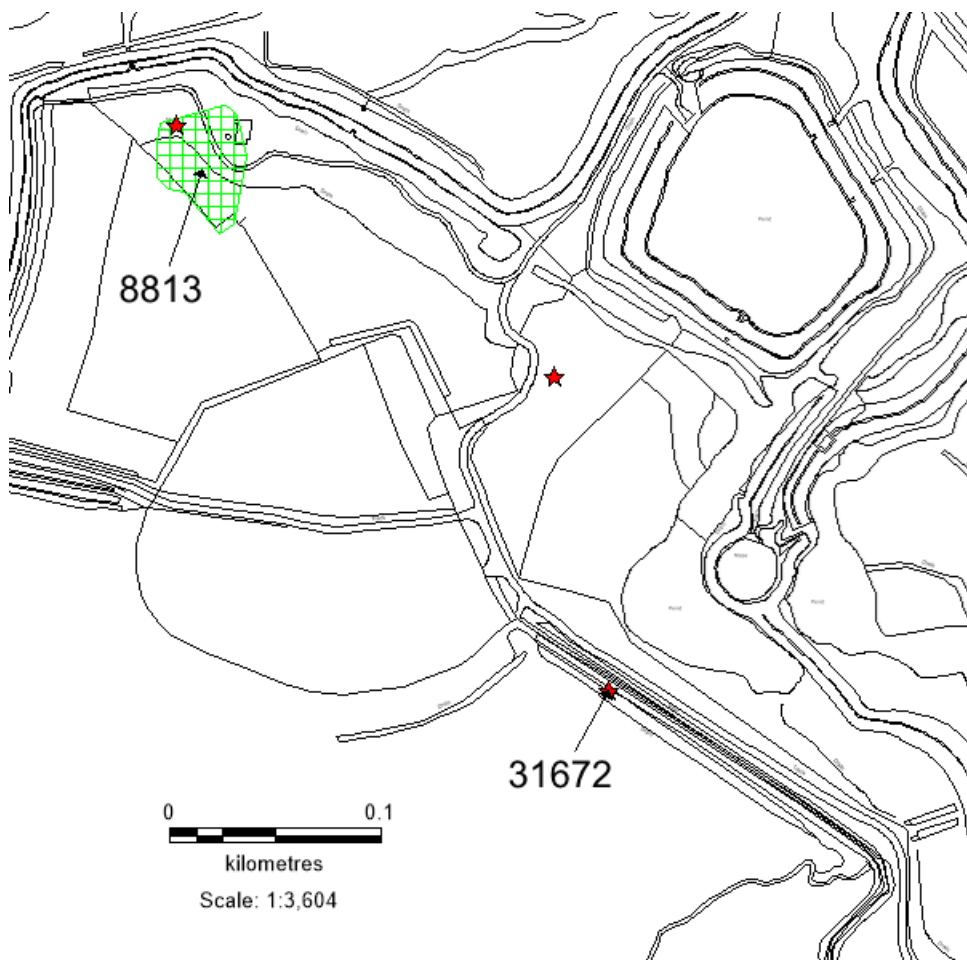

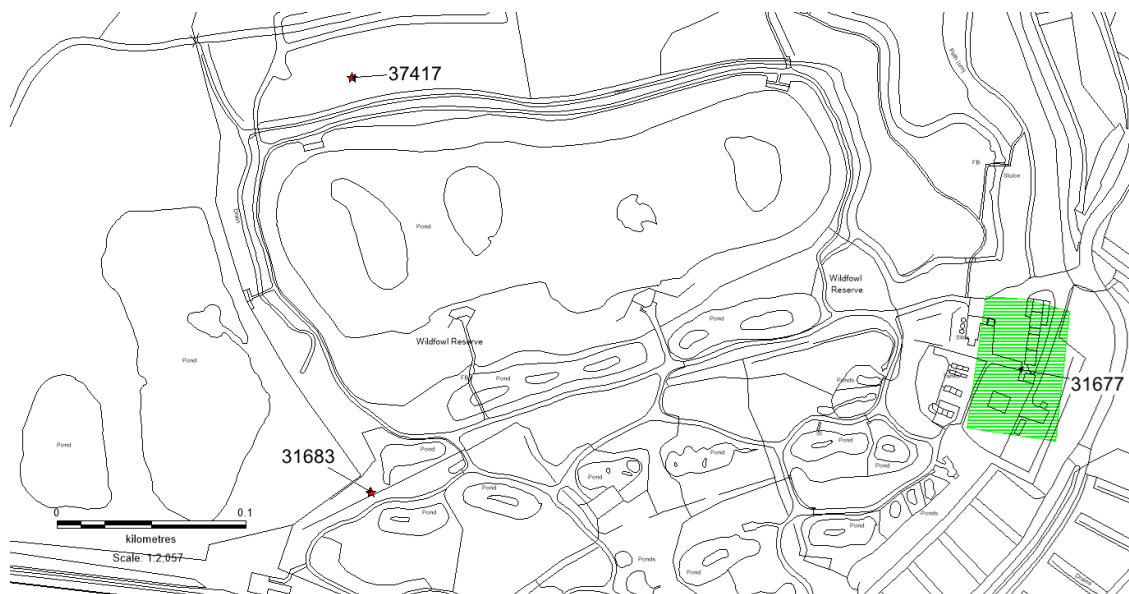

We advise that these historic environment features (labelled on the map above and marked with green polygons and or red stars) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further advice can then be provided.
