

PRN6043 FFOS Y FFIN CROPMARK SN55305350 Cropmark of unknown significance. RPS September 2001. This has been dismissed as an archaeological feature.

PRN1330048 BERTHELE POST MEDIEVAL SN5533853503 "Spout" recorded on 2nd Edition Ordnance Survey Map. A. Powell 2023.
