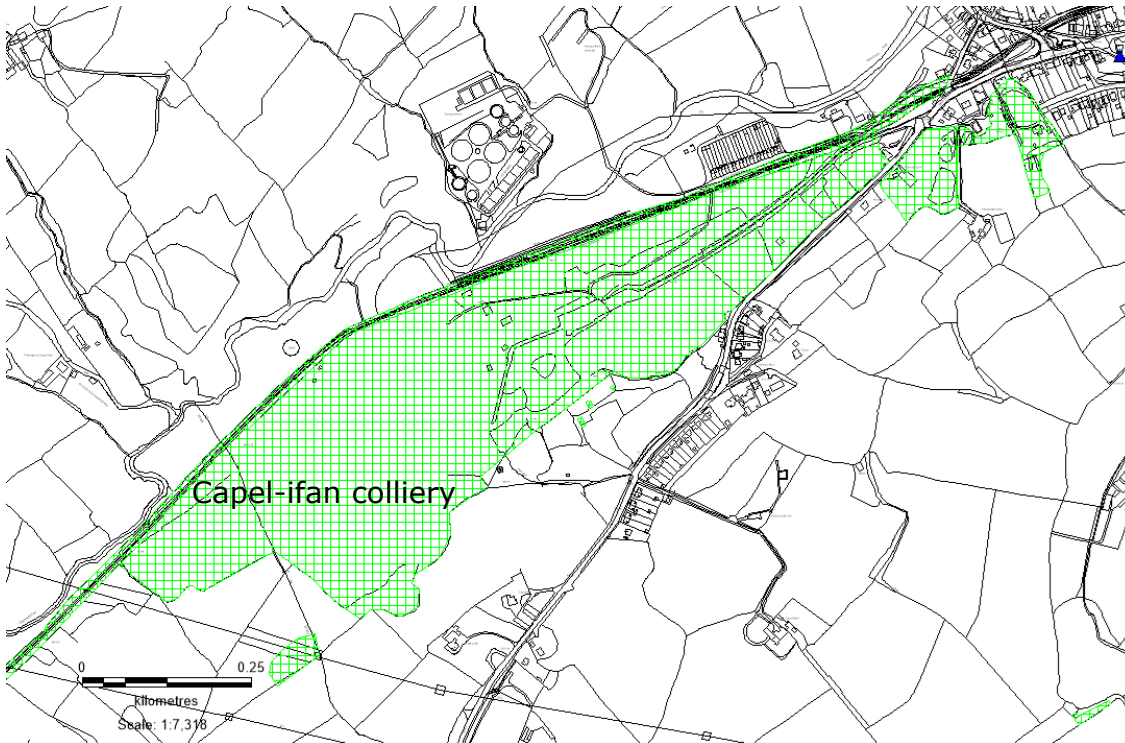

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge.
