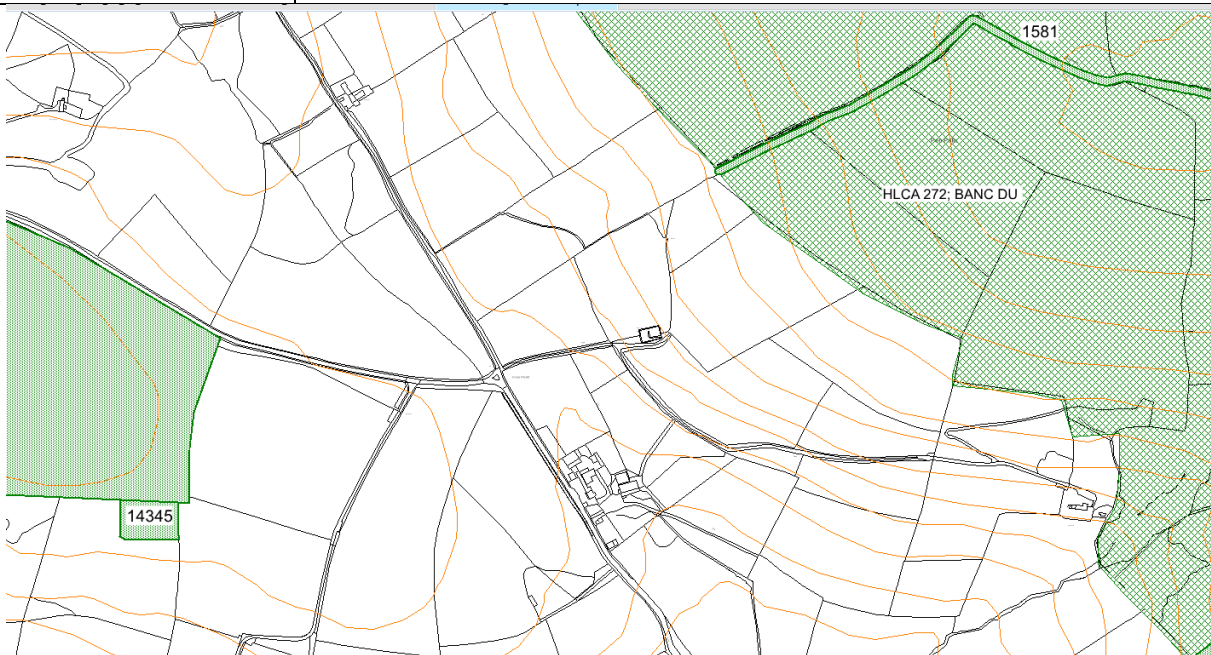

Decision (If the proposal is considered to be inappropriate at this location please provide an explanation)	<p>Thank you for forwarding this Glastir Woodland Creation proposal to us.</p> <p>Dyfed Archaeological Trust have reviewed the new planting proposals for Lodor Fach against the Historic Environment Records database and other readily available record sources and have assessed that the application, as submitted, has the potential to have an impact upon the following Historic Environment Features (HEFs):</p> <p>PRN 1581 Medieval Boundary Bank SN05063156 Pen Palis is a pronounced east-west bank, the 'palis' (or pale) which, though it was used as a boundary to separate the common from the land to the south, pre-dates mid 13th century Fitzmartin's charter, by which time it was already being known as the 'Via Flandrensica' or Flemings' Way. It is named as such in this and succeeding documents. It has also been regarded as a prehistoric track and is recorded on the 1st edition Ordnance Survey as a Roman road though there is no evidence for this. A Pyper based on HLCA description 'Banc Du' HLCA 272.</p> <p>PRN 14345 Prehistoric Enclosure SN04353110 Aerial photographs clearly show evidence of a deserted settlement lying on the southeast-facing slope of Mynydd Morvil (14344). To the south, in the NE corner of one field, is a cropmark of a roughly c.40m square enclosure (PRN 14345).</p>

	<p>There appears to be evidence of an outer ditch and bank at least on the south and west sides. To the north of this cropmark is evidence of the former settlement (PRN 14344), visible as an earthwork, with probable enclosure walls and a building foundation picked out in earthen stony banks that measure approximately 0.25m. FM & RR June 2009.</p> <p>In addition the Historic Landscape Character Area (HLCA 272) of Banc Du remained as unenclosed moorland until the late 18th century when large regular enclosures were established and is noted for its treeless character.</p> <p>Dyfed Archaeological Trust therefore advise that in order to comply with UKFS <i>Forests and the historic environment</i> guidance, the following advice should be adhered to in the Glastir Woodland Creation plan:</p> <p>The areas in green indicate the areas of Historic Landscape and archaeological sensitivity; these areas should remain unplanted.</p>
