Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following feature:

PRN25893LLANILAR POST MEDIEVAL METAL MINESN6120674662A minor metal mine working near Llanilar, "Old Level (Lead)" is recorded on 2ndEdition Ordnance Survey Map. The area is now afforested and the condition of the sitenot known.
