Dear Josh, thanks for sending this consultation.

I'm not sure about the extent of the works, but would like to make the following comments:

As well as the Grade II Listed Building (Pont Talsarn) and scheduled monuments (Castell Trefilan and Pen Clawdd-Mawr) you have noted in the file you should also be aware of the Registered Parkland of Llanllyr (PGW (Dy) 28 (Cer)) which lies on the south west side of the river, any works which might affect the Registered Park must be discussed with Cadw - Lisa Fiddes is the relevant Inspector for Parks and Gardens Lisa.Fiddes@gov.wales.

There are also a number of historic environment features recorded in the area. If the works are going to involve any ground breaking activities, or creating new infrastructure such as roads or compounds then we need to know more detail about the proposals and work out suitable mitigation.
