







The current condition of these features is unknown; however, they may survive as ruins, earthworks or below ground archaeology. In order to comply with UKFS Forests and the historic environment guidance, DAT advise that these historic environment features (shown in green on the attached map) must be protected from damage during felling operations and that no restocking should take place within these defined areas. In addition, any ancillary operations tracks, stacking and loading areas etc must not intrude into these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
