### FLA 141 22-23 Hean Castle Estate

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment features recorded within the consultation area and shown in green on the map below:

PRN	Summary	Type	NGR
98750	An estate lake lying some 150m north of Hean Castle, recorded on the Ordnance Survey 1st edition map ( OS 1889, Pembs Sheet 35.15, 25"). The lake still appears on the recent mapping.	Post Medieval Lake	SN13850615
32806	A large group of former coal workings in Rhode Wood, south of Saundersfoot. Thought to be a well preserved group of relict features representative of early anthracite mining in Pembrokeshire. It has been suggested that they date from the early 18th century to approximately the 1860s. Visited in 2014, between 50-70 shafts were recorded within the woodland, as well as a number of deep trench open (drift) workings, with associated spoil tips and mounds. 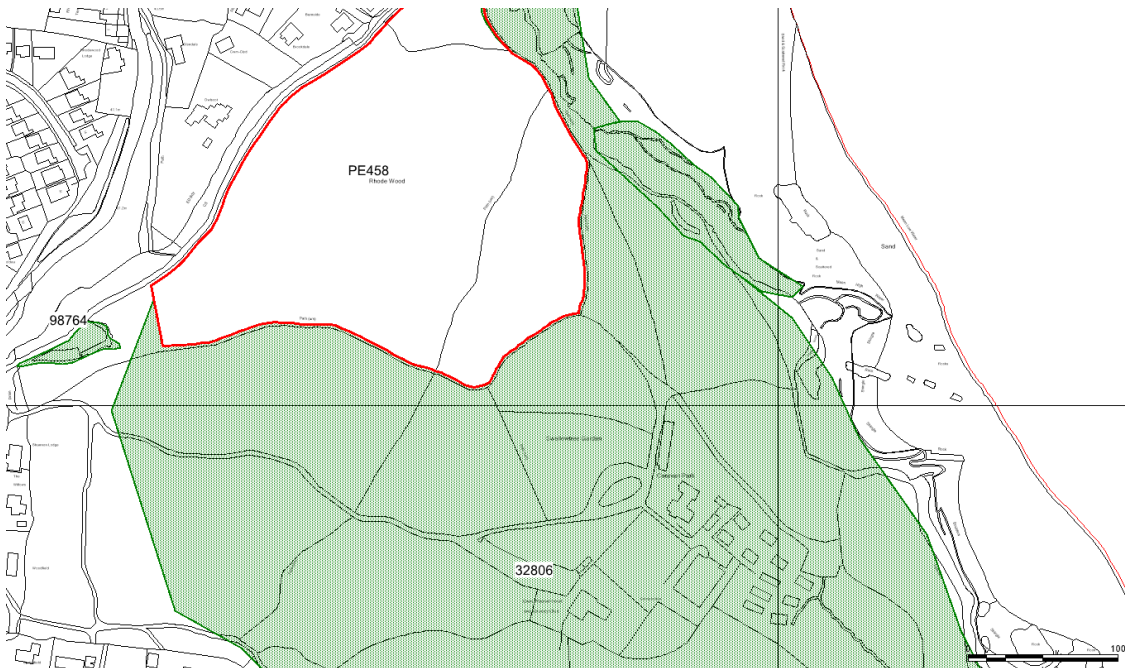

The current condition of these features is unknown; however, they may survive as ruins, earthworks or below ground archaeology. In order to comply with UKFS Forests and the historic environment guidance, DAT advise that these historic environment features (shown in green on the attached map) must be protected from damage during felling operations and that no restocking should take place within these defined areas. In addition, any ancillary operations tracks, stacking and loading areas etc must not intrude into these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
