

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment features:

PRN 100175 HIRWAUN-OLEU POST MEDIEVAL FARMSTEAD SN53931285
A farmstead recorded on the 1880 1st edition and 1906 2nd edition Ordnance Survey maps. Nothing of this farmstead is recorded on modern mapping.

PRN 104073 HIRWAUN-OLEU POST MEDIEVAL BUILDING SN53941275
Two buildings associated with Hirwaun-oleu Farmstead (PRN 100175) recorded on the historic Ordnance Survey maps but not shown on mastermap.

However we are not sure if this area has been subject to largescale reinstatement following mining activities. In order to comply with UKFS Forests and the historic environment guidance, DAT advise that these historic environment features (shown in green on the attached map) must be protected from damage during felling operations and that no restocking should take place within these defined areas. In addition, any ancillary operations tracks, stacking and loading areas etc must not intrude into these areas.
