
Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment features:

PRN 127878 POST MEDIEVAL SLUICE SN34863639

A sluice is recorded on the 1st and 2nd edition Ordnance Survey maps (1889 and 1907).

PRN 35588 POST MEDIEVAL MILL RACE SN3490735960

Mill race taken off the Nant Bargod near Twll-y-graig servicing the dwelling at Cil-graig. The race is shown on OS 1:2500 1st and 2nd Ed maps of 1889 and 1906.

In addition, any ancillary operations tracks, stacking and loading areas etc must not intrude into these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
