Hi Jane,
Thanks for the prod – and apologies for the delay!

I've tried to locate the exact location based on the map provided and I believe it is centred on SN7072093800, but if this is incorrect please let me know.

I've checked our records and we have no specific Historic Environment Records located on the south side of the track/road. However on the 1st and 2nd edition Ordnance Survey maps a line runs through the location of the turning circle, which may indicate the route of a leat or a field boundary (see map extract below). As it is running steeply down slope I suspect it is the latter. The historic map also indicates there are further spoil tips which may extend close to, or into the location of the turning circle.

Ideally the turnaround would be located further from the area of archaeological sensitivity. However if the works go ahead in this location, given the proximity to the mining remains and that unrecorded features may extend into the turning area, I'd recommend a suitably qualified archaeologist (registered with the Chartered Institute for Archaeologists - CiFA) is present during the undertaking of any ground works in the development area, so that an archaeological watching brief can be conducted. The archaeological watching brief must be undertaken to the standards laid down by the Chartered Institute for Archaeologists.

A brief for this piece of work can be supplied from Dyfed Archaeological Trust Heritage Management (DAT HM) and the contractor must provide a detailed specification or Written Scheme of Investigation to DAT HM for approval before the work commences. On completion a report will need to be produced and submitted to DAT HM.

Under the terms of the MoU, further casework provided by DAT HM (such as the provision of a brief, review and approval of the WSI and subsequent monitoring) is not subject to Cadw grant aid and must be resourced by NRW.

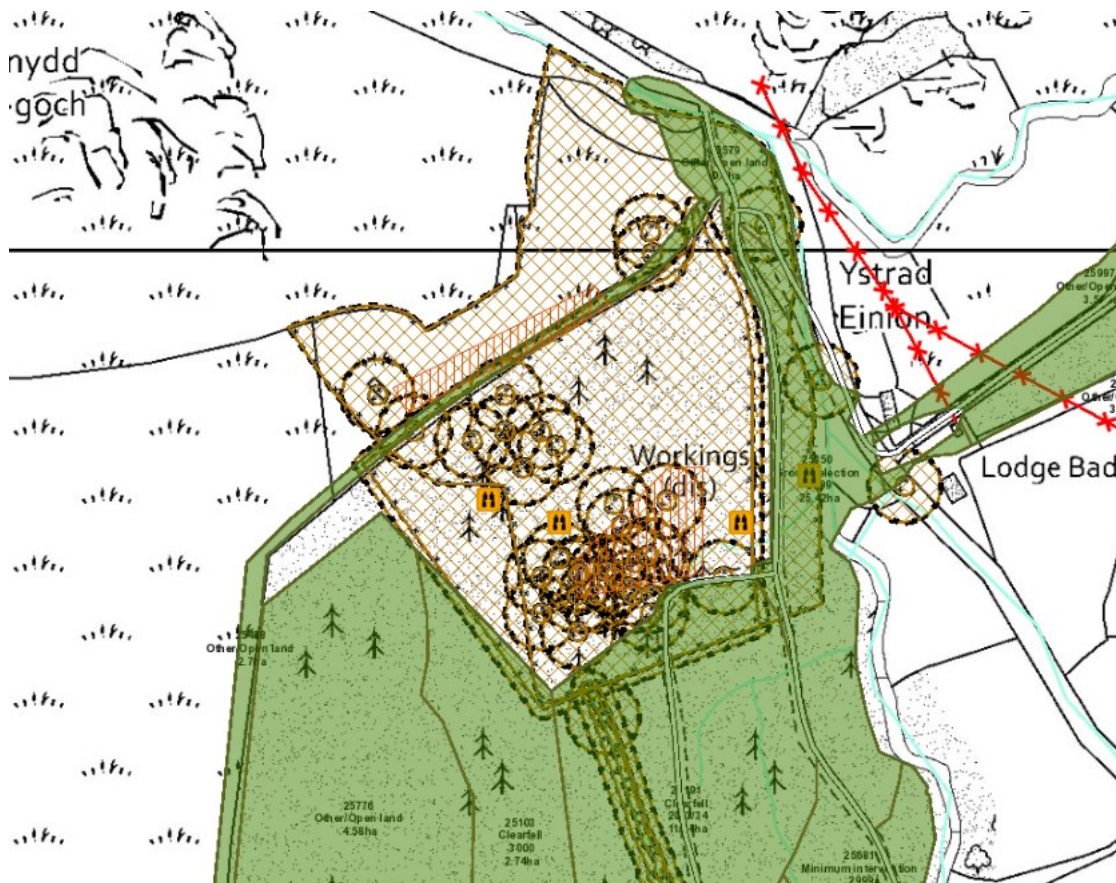

The above SM and many of the associated heritage features lie outside of the Welsh Government Woodland Estate, however the heritage impact zone encroaches into the forest. Please see the attached plan and you will note that the proposed location for the new forest road turnaround falls within the impact zone. Before my colleague from Integrated Engineering produces detailed drawings, I wondered if you could have a look and agree to the turnaround in principle? For the avoidance of doubt, the proposed turnaround falls within a plantation of Sitka spruce. Let me know if you require further information.
