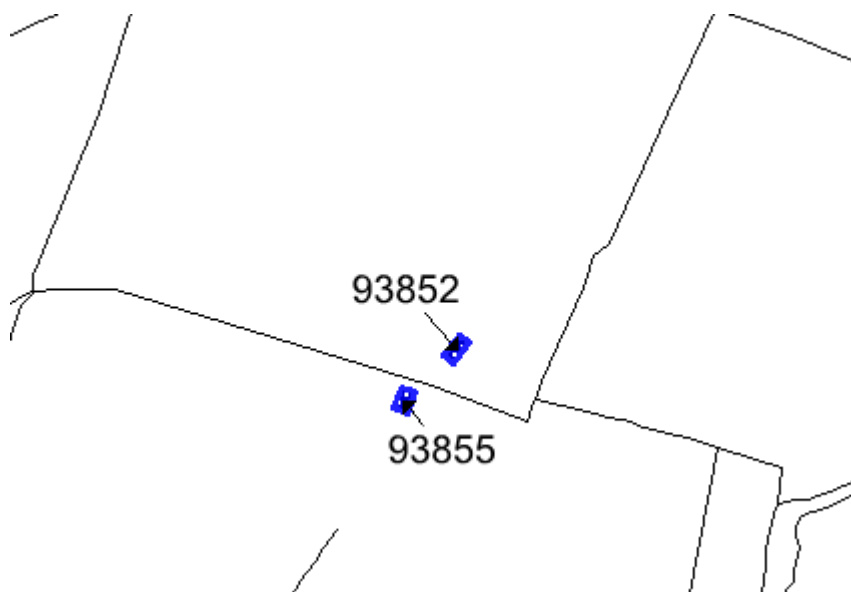

NRW Screening Request FLA 353 22-23 Coed Marnie

Thank you for your felling licence consultation. I've had a look at these proposals in reference to the Historic Environment Record and note the following historic environment features, all derived from historic map sources:

PRN 93852 UNKNOWN Post-Medieval cottage? SN2584142941
Structure recorded on 1st Edition Ordnance Survey and 2nd Edition Ordnance Survey maps.

PRN 93855 UNKNOWN Post-Medieval cottage? SN25834292
The tithe map records a small building in the south of a field enclosure, presumably identifying a cottage site. No further clues are provided on the apportionment. The building is marked in outline by the time of the Ordnance Survey 1st edition map (1888), presumably having been abandoned by that time.

The current condition of these features is unknown; however they may survive as ruins, earthworks or below ground archaeology. To comply with UKFS Forests and the historic environment guidance, we advise that these historic environment features (shown in blue and marked with arrows on the maps above) are protected from damage during forest operations, and that access tracks/loading areas should not cross these features.
