



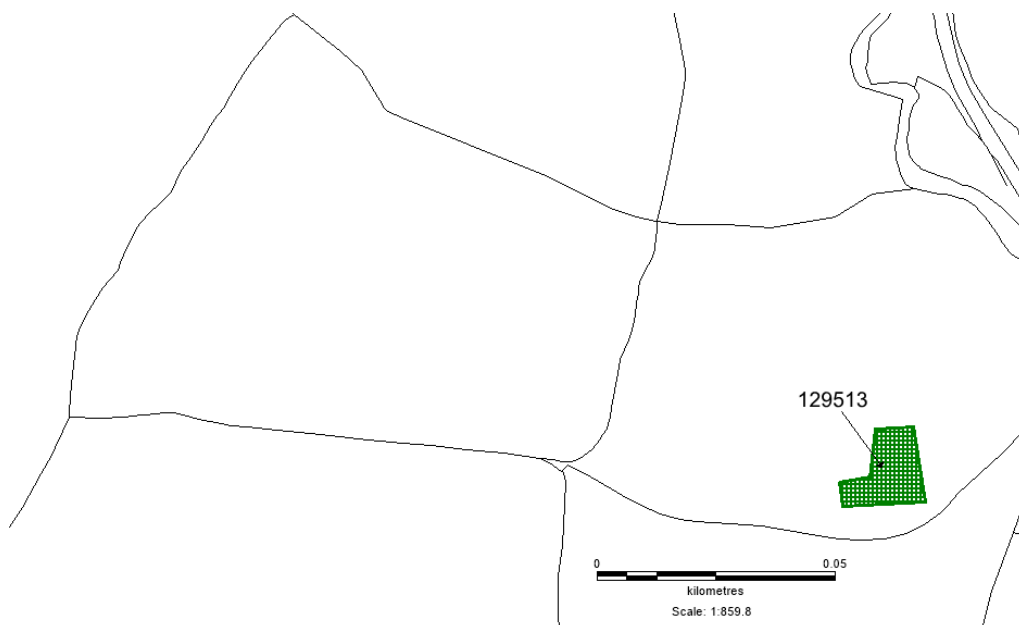

Thank you for your felling licence consultation. I've had a look at the proposal in reference to the Historic Environment Record and note the following historic environment feature, derived from historic map sources:

The current condition of this feature is unknown; however, it may survive as ruin, earthwork or below ground archaeology. We advise that this historic environment feature (shown in green on the map above) is protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

The consultation area lies within the Registered Historic Landscape character area <https://dyfedarchaeology.org.uk/HLC/EstuaryArea/area174.htm>. The historic map evidence shows well defined blocks of deciduous woodland. Therefore, the restocking in mixed broadleaf woodland species would be more appropriate.
