Thank you for your felling licence consultation. I've had a look at the proposal in reference to the Historic Environment Record and note the following historic environment feature, derived from historic map sources:


PRN128225 YSTRAD WOOD POST MEDIEVAL WATER TANK SN3937318818 Water Tank marked on 2nd edition OS historic mapping.


PRN121920 POST MEDIEVAL WATER TANK SN39451895 A tank is recorded within Ystrad Wood on the 1st and 2nd edition Ordnance Survey maps (1890 & 1906).

PRN 121921 POST MEDIEVAL STONE QUARRY SN39531887 A quarry is recorded on the 1st edition Ordnance Survey map, 1890.

PRN 128226 POST MEDIEVAL WELL SN3947218990 Well marked on 1st edition OS historic mapping.

PRN 104046 POST MEDIEVAL COTTAGE SN39491899
Three buildings, possibly a cottage and two outbuildings, recorded on the historic Ordnance Survey maps but not shown on modern mapping.



The current condition of these features is unknown; however, they may survive as ruins, earthworks or below ground archaeology. We advise that these historic environment features (marked on the map above) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

The consultation area lies within the Registered Historic Landscape Character Area https://dyfedarchaeology.org.uk/HLC/HLCTowy/area/area179.htm. The historic map evidence shows the consultation area was a mixed deciduous and conifer woodland. Therefore, we recommend replanting be sympathetic to the historic character.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
