

Thank you for your felling licence consultation. I've had a look at the proposal in reference to the Historic Environment Record and note the following historic environment feature, derived from historic map sources:

PRN99723 MODERN FORD SN80123139 A ford is shown in this location on the second edition Ordnance Survey map.

PRN99724 MODERN BRIDGE SN80173139 A bridge is shown in this location on the second edition Ordnance Survey map.

The current condition of these features is unknown; however, they may survive as ruins, earthworks or below ground archaeology. The consultation area lies within the Registered Historic Landscape Character Area of Llanndeusant – Capel Gwynfe

https://dyfedarchaeology.org.uk/HLC/Myddfai/area/area233.htm, in the Black Mountain and Mynydd Myddfai Landscape of Outstanding Historic Interest. The historic map evidence shows few trees in the consultation area, but the surrounding woodland is made up of broadleaf species. It is recommended that any restocking be sympathetic to the historic character.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
