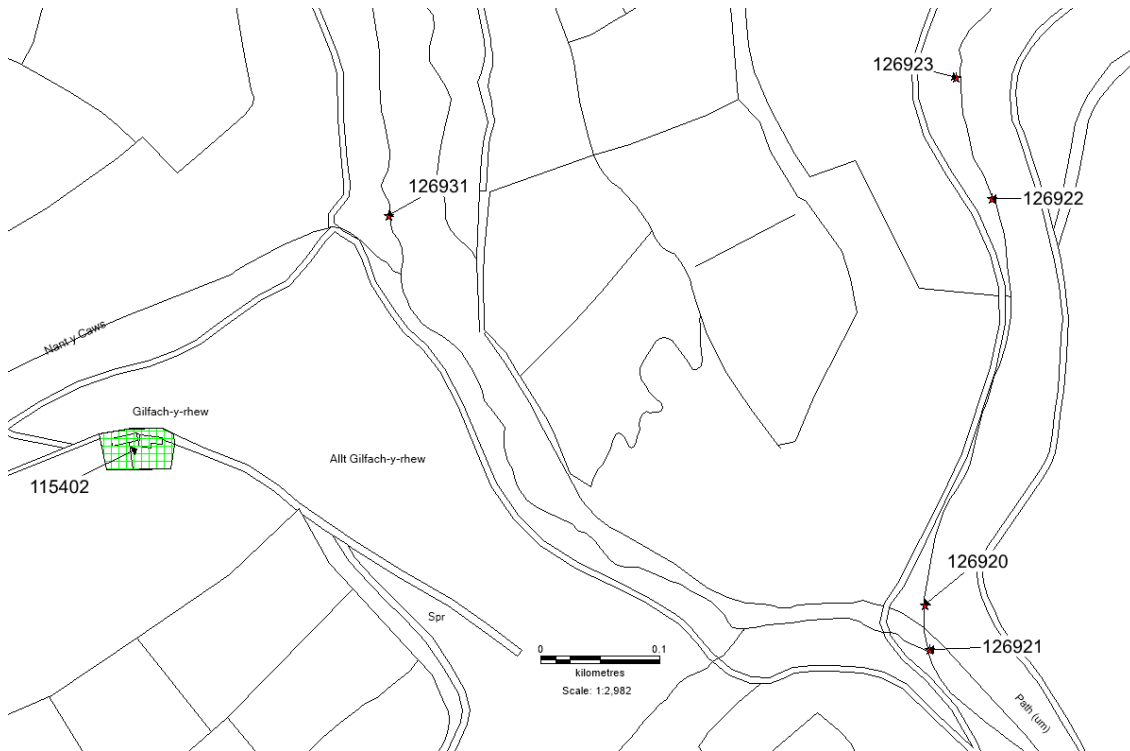

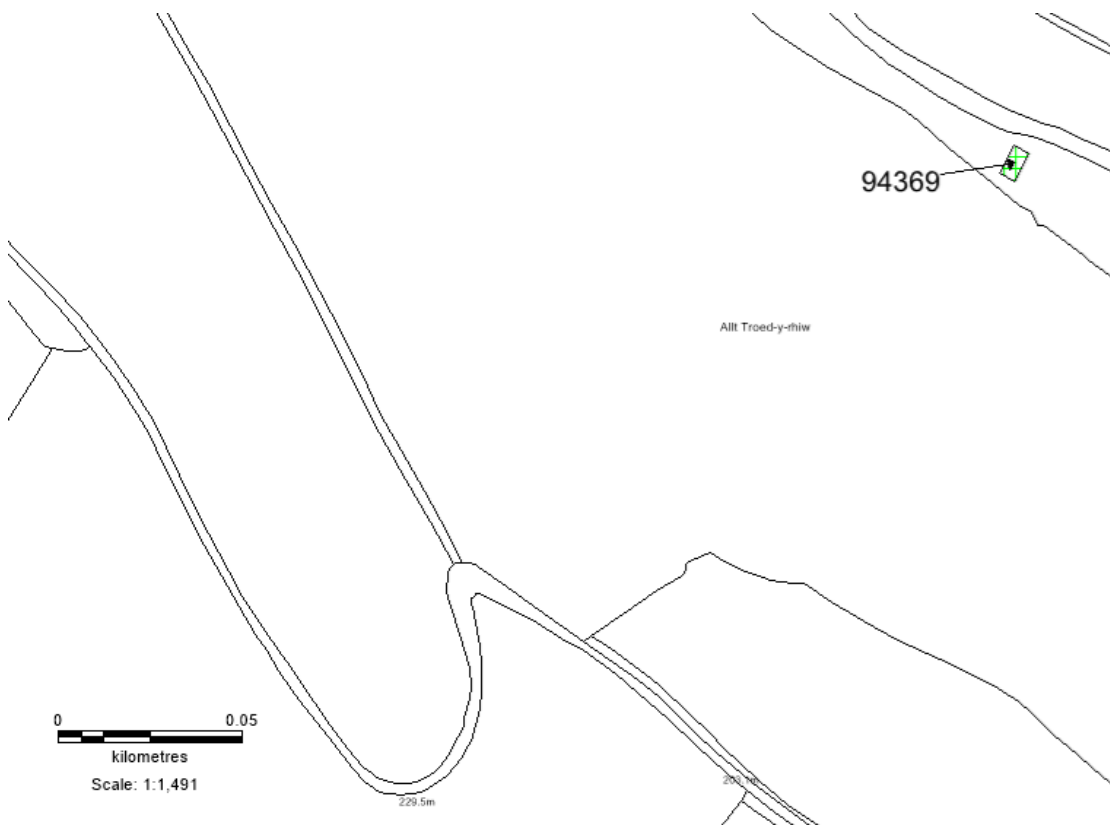

The current condition of these features is unknown; however, they may survive as ruins, earthworks or below ground archaeology. We advise that these historic environment features (labelled on the maps above and marked with a red star or green polygon) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

The historic maps also record predominantly broadleaf species within the application area. Therefore, we recommend any restocking be sympathetic to the historic landscape.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
