PRN 56934 NANTEOS POST MEDIEVAL BUILDING SN61947866
A long building with five small pens against one of the long walls recorded on the Ordnance Survey 1st edition map (1888). Lies within pleasure grounds to west of Nanteos mansion. Present condition unknown.

PRN129520 NANTEOS POST MEDIEVAL BUILDING SN6204078674
Buildings recorded on 1st and 2nd Edition Ordnance survey Maps. A. Powell 2023.

PRN58112 Dovecote at Nanteos SN6203478665
Grade II listed dove and pigeon roost of early 19th century date.
