NRW Screening Request FLA 27 23-24 Allt Dolau Cothi near Pumsaint.

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note that this application lies within Historic Parks and Gardens of Dolaucothi PGW (Dy) 7(CAM) and includes part of the scheduled monument Pumsaint Roman Fort (CM226) therefore Cadw must be consulted. I am copying this response to Louise Mees Inspector of Ancient Monuments and Archaeology (South West Wales) and Lisa Fiddes Inspector of Historic Parks and Gardens.

In addition, I have also noted the following features recorded on the Historic Environment Record:

PRN49967 POST MEDIEVAL LEAT

A leat or water channel marked on an estate map of Dolaucothi, thought to date to around 1770. The western end of this feature is visible as faint earthwork running through the wood. The line of the channel is then lost as it passes through an improved field just east of the woodland. The channel seems to have supplied water to Cefn Coed Mawr farm (NT no.80439), and is one of a number of channels which were taken off springs in a field named Cae Garw. (See also PRNs 49970 and 49971).

PRN49971 POST MEDIEVAL WATER CHANNEL SN66214146 An estate map of Dolaucothi (?1770) shows a number of channels being fed by a stream in this area. These channels conveyed water to Dolaucothy Farm, and also to the farm at Cefn Coed Mawr. On the ground, this area is difficult to interpret. There are earthwork remains of watercourses, but it is not clear how many of these have been caused by the shifting course of the stream, and how many may have artificial origins. There are a number of picnic tables set by the stream, and a short flight of steps has been put in place to lead down to the level ground at the stream's edge. There are also two footbridges, allowing visitors to walk a short circular route crossing the water.

PRN49973 POST MEDIEVAL TRACKWAY

SN66214167

A trackway seen on an estate map of around 1770. The track still survives but has been re-surfaced for much of its length and part of it is open as a public walk through the woods.

PRN52189 POST MEDIEVAL WATER CHANNEL

SN66254157

The approximate line of a water channel marked on an estate map of c.1770 providing water to Cefn Coed Mawr. The channel is described as 'made by Richard Davies about 30 years last' (i.e. c.1740).




