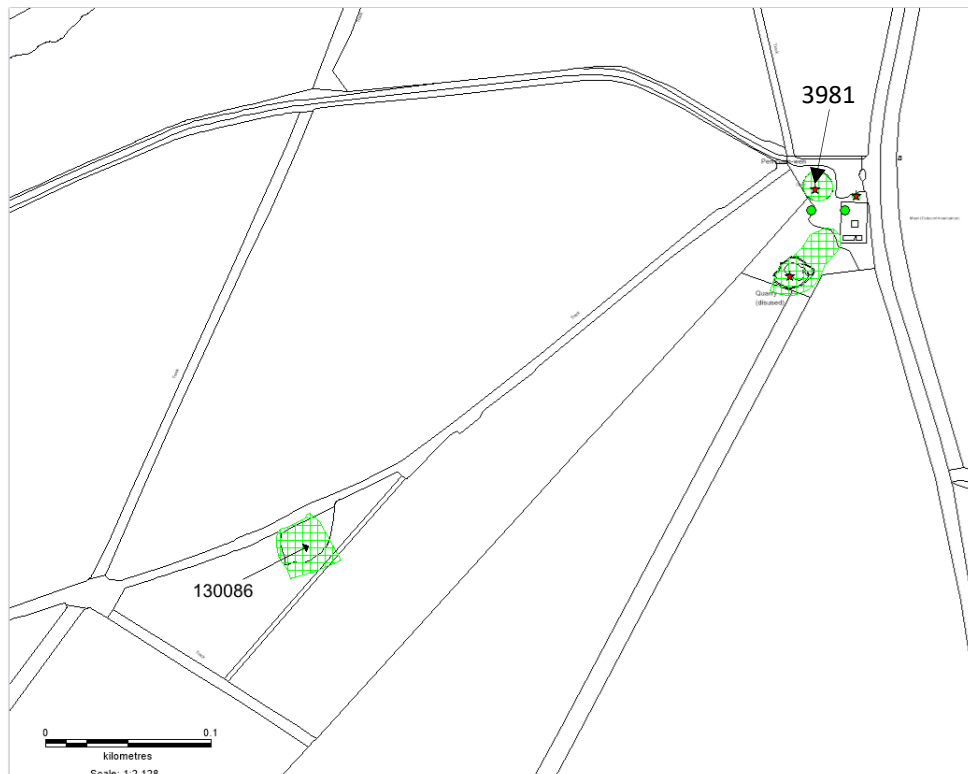

**NRW Screening Request
FLA297 23-24 Tricorn Turret Wood**

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following features:

PRN130086 PEN GARN-WEN POST MEDIEVAL QUARRY SN3699749178
Quarry recorded on 1st and 2nd Edition Ordnance Survey Maps. A. Powell 2024.

PRN3981 CARN WEN BRONZE AGE ROUND BARROW SN3730249393
When visited by the OS in 1975 they noted that the cairn here had been largely reduced to a grass covered spread of stone and earth almost to ground level. A trig pillar set on a 6m diameter x 0.5m high mound appeared to be positioned at the centre of the barrow. The barrow currently lies in an area of waste ground next to a radio mast and was too heavily overgrown with nettles etc. to be able to be properly assessed, but it seems likely that nothing much has changed since the previous OS report. The application is near several historic features which must be protected from damage during the forestry operation. We recommend that the area of the application abutting the round barrow PRN3981 be planted with broadleaf species to act as a permanent canopy to help shade out shrubby vegetation and prevent further damage from forestry operations.

The current condition of these features is unknown; however, they may survive as ruins, earthworks or below ground archaeology. We advise that these historic environment features (labelled on the map above and marked with green polygons and red stars) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
