

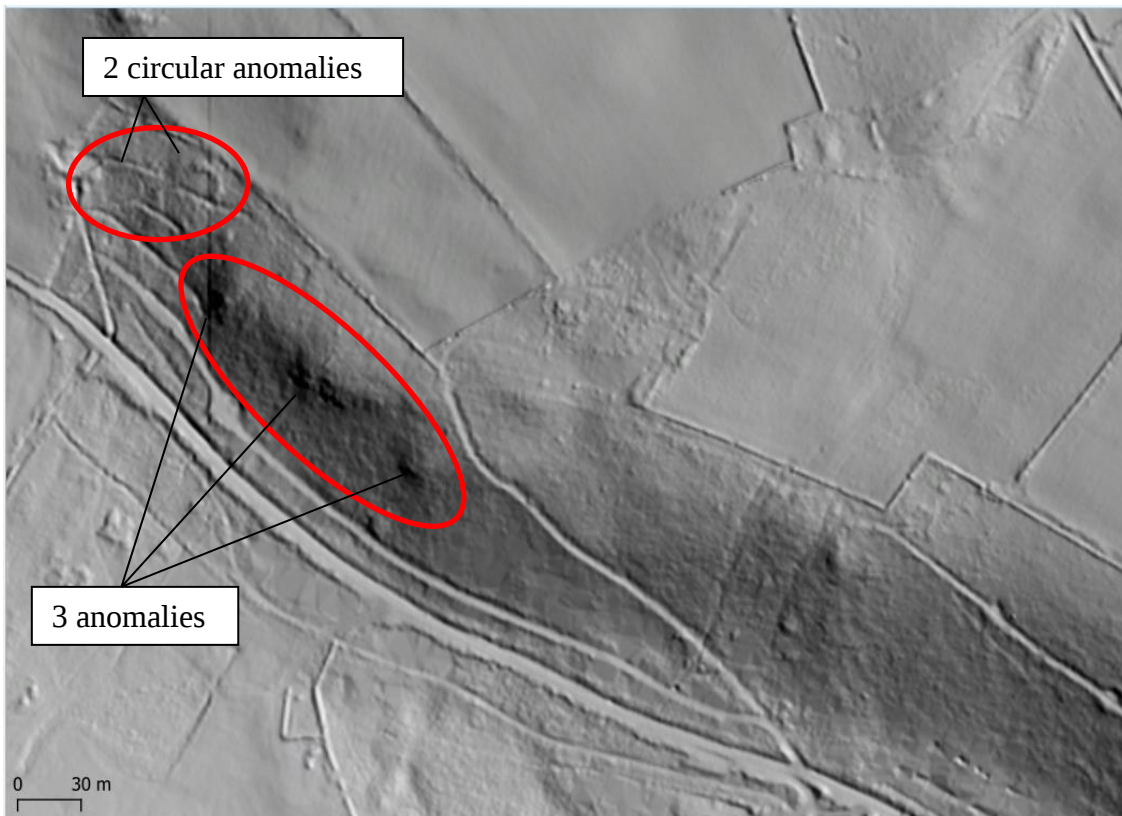

**NRW Screening Request
FLA351 23-24 Allt Mawr**

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and there are no known historic environment features recorded within the consultation area.

Although, we have spotted anomalies during Lidar screening. Care should be taken in these areas (*marked on the map below*) during forestry operations and Heneb would appreciate receiving any information on the nature of these unknown features.
