We advise that these historic environment features (labelled on the map above and marked with a green polygon) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

The consultation area also lies with the Historic Landscape Area of Milford Haven Waterway HLW (D) 3 in the Historic Landscape Character Area of Milford Haven.
