NRW Screening Request FLA404 2024 Ffynnon Ddu

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following features.

PRN18993 FFYNNON-DDA POST MEDIEVAL WELL SN1225639786
Ffynnon-Ddu is recorded, lying some 50 metres to the east of the cottage of the same name. The significance of the well is uncertain. There are no known historic associations at present.
